And the reason why that access track is in our order limits is that we need a right of access over that track to instal planting, or to plug in holes to existing planting that are not on the existing critical main. So all we'll be doing is accessing along that track with new plants, so no heavy goods, vehicles, etc, just ordinary traffic that can go down that track immediately, today, and to reach our planting areas. So from our perspective, there's no interaction with the critical main.

together with any government offices at the time, and that decision when they've got the funding only at that point, will the project proceed. So and in light of that, hence, you have the security provision in the demand consent order, that given the risk of post acquisition, we call it exercise those powers until we demonstrate to the government that there are sufficient funds for couples acquisition, which we could demonstrate today. Well, that's the key point we could demonstrate that security today. But we we were not seeking to obviously the actual we're not going to exercise those powers until funding until that funding decision. So I think all we can state is that there's history of funding of the of Drax. It's a PLC company's got significant reserves behind it. And infrastructure project of this, we see no reason why it wouldn't get the necessary support from other investors.
