1. INTRODUCTION

1.1. OVERVIEW

- 1.1.1. An Application (the 'Application') for a Development Consent Order ('DCO') for Drax Bioenergy with Carbon Capture and Storage (the 'Proposed Development') was made by Drax Power Limited (the 'Applicant') to the Secretary of State ('SoS') for Business, Energy and Industrial Strategy ('BEIS') on 20 June 2022. The Proposed Development is described in Chapter 2 (Site and Project Description) of the Environmental Statement ('ES') (APP-038).
- 1.1.2. On 13 December 2022, the ExA issued a letter under Rule 6 of The Infrastructure Planning (Examination Procedure) Rules 2010. The Examining Authority ("ExA") has requested that the Applicant provides a Schedule of Changes to the Book of Reference, if any changes have been made since the latest submission of the Book of Reference (REP2-016).
