0. INTRODUCTION

0.1. OVERVIEW

0.1.1. This Application Document Tracker has been prepared on behalf of Drax Limited (the 'Applicant') to support an application (the 'Application') for a Development Consent Order ('DCO') that has been submitted to the Secretary of State ('SoS') for Business, Energy and Industrial Strategy ('BEIS') under Section 37 of The Planning Act 2008 (as amended) (the 'PA 2008'). The Application relates to Drax Bioenergy with Carbon Capture and Storage (the 'Project'), which constitutes the 'Proposed Scheme'.
