### Participation at the Preliminary Meeting and Hearings

Spirit intend to participate in Issue Specific Hearing 1 (**ISH1**) on 24<sup>th</sup> October. Spirit wish to participate at item 6 where the ExA invites observations from interested parties relating to the draft Development Consent Order (**dDCO**).

Spirit will attend both the Preliminary Meeting and ISH1 virtually and will be represented by James Gibson, Partner, Eversheds Sutherland LLP.

We confirm that we have completed the event participation form on behalf of Spirit.

Spirit do not wish to participate in the Open Floor Hearing on 23rd October 2024 (if it proceeds).

## Comments on Initial Assessment of Principal Issues
