



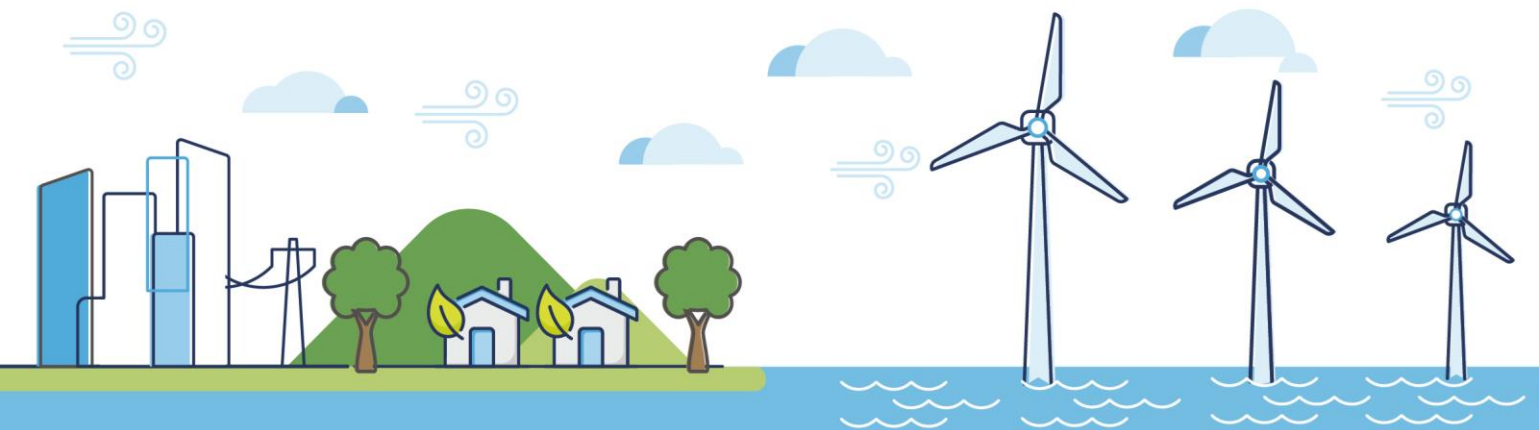

1 Introduction

1. As requested by the Examining Authority (ExA) in its Rule 6 letter dated 23 September 2024 (PD-007), this document presents the Applicant's declaration on the use of Artificial Intelligence (AI).
2. The Planning Inspectorate issued guidance on 6 September 2024 regarding the use of AI as part of any examination¹. As this guidance was published after the Application was accepted for Examination, the ExA requested that all parties provide a declaration on the use of any AI in information submitted to date in respect of the Application.

2 Declaration

3. The Applicant confirms that AI was used for one application document, as follows:
 - Volume 5 - Chapter 11 Marine Mammals (APP-048)
4. AI (specifically Microsoft 365's Copilot tool) was used by the chapter author, for whom English is not their first language, to revise and reword text drafted by the author for clarity. AI was not used to create any content. Copilot is a generative artificial intelligence chatbot tool developed by Microsoft.
5. As this document was subsequently reviewed, revised and finalised by the Applicant's wider team prior to submission, the Applicant is unable to definitively label where AI was used within the document.
6. The Applicant confirms that AI was not used to create or alter any images or plans within the document.
7. The Applicant cannot confirm the precise date on which AI was used other than that it was before 30 May 2024.
8. The Applicant confirms that AI was not used in the preparation of any other submissions to date.
9. The Applicant declares that it is responsible for the factual accuracy of the document and that its use of AI was responsible and lawful.
10. The Applicant confirms that no personal information was disclosed, shared, or used within this document. The use of any data in this document complies with copyright legislation.
