#### Launch of Statutory Consultation

BayWa r.e. (BayWa) is launching a statutory consultation on the Oaklands Farm Solar project.

In advance of our submission of an application to build this Project, we are consulting the local community and stakeholders to help us shape our final plans. This is a formal process, beginning on 21st April 2022, and running until 6th June 2022.

This leaflet explains where to find out further information, view the detailed plans, and how to contact the Project team to provide feedback.

This project would produce around 160MW of clean renewable energy. That's enough renewable energy to power around 40,000 homes, or nearly all houses in South Derbyshire."



#### The Proposals

The proposals comprise a solar farm, expected to generate over 160 MW of electricity, and a 37 MW energy storage unit. The Project will be located on two main parcels of land and cover approximately 540 acres. It will connect to the UK electricity network at Drakelow substation to the north by a 2km underground and overhead cable.



#### The Planning Process

As the proposed development is for electricity generation of more than 50MW, it will be classed as a Nationally Significant Infrastructure Project (NSIP) under the Planning Act 2008 and we must therefore apply for a Development Consent Order (DCO). Following consultation, we are aiming to submit an application to the Planning Inspectorate later in 2022. The final decision will be taken by the Secretary of State for Business, Energy & Industrial Strategy (BEIS).

### How to find out more and have your say:

Our formal (statutory) consultation on the proposals commences on 21st April 2022 and runs until 6th June 2022. We will then review and consider the feedback received before finalising our proposals and submitting our application to the Planning Inspectorate later this year.

Electronic copies of the Preliminary Environmental Information Report (PEIR), which comprises detailed information and plans of the Project will be available free of charge' for inspection during the statutory consultation period on the project website and at the locations listed in the table below.
