#### Oaklands Farm Solar Park

Notice of Acceptance of an application for a Development Consent Order ("DCO") by the Planning Inspectorate (on behalf of the Secretary of State) under Section 56 of the Planning Act 2008.

Regulations 8 and 9 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009.

Regulation 16 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017.

1. Notice is hereby given that the Secretary of State has accepted an application (the "Application") by Oaklands Farm Solar Limited (Company No.12915335) of 22 Chancery Lane, London, WC2A 1LS (the "Applicant") for a Development Consent Order ("DCO") under the Planning Act 2008. The Application (Reference No. EN010122) was submitted by the Applicant to the Secretary of State via the Planning Inspectorate on 08 February 2024 and was accepted for examination on 05 March 2024.

### **Summary of the Proposed Development**

- 2. The Application is for development consent to construct, operate, maintain and decommission a solar photovoltaic (PV) electricity generating facility with a capacity of over 50 megawatts (MW) and export connection to the National Grid.
- 3. Oaklands Farm Solar Park (the "Proposed Development") will be situated in the administrative boundary of South Derbyshire District Council and Derbyshire County Council. The Scheme comprises a number of land parcels that accommodate ground mounted PV generating stations (incorporating solar arrays); grid connection infrastructure and battery energy storage; cable route corridors; accesses and environmental mitigation and enhancement measures. The site is situated at Oaklands Farm, west of Rosliston. An underground cable will run from an on-site substation to a grid connection at the Drakelow substation. - 4. Development consent is required to the extent that development is or forms part of a Nationally Significant Infrastructure Project (NSIP) pursuant to sections 14(1)(a) and 15(1) and 15(2) of the Planning Act 2008, as an onshore generating station in England with a capacity greater than 50 MW. It is for this reason that the Proposed Development falls within the remit of the Secretary of State's decision-making powers.
- 5. The DCO, if granted, would authorise the compulsory acquisition of land, interests in land and rights over land, and the powers to use land permanently and temporarily. The DCO would also authorise alterations to the layout of streets, the construction of accesses to the Proposed Development, the temporary stopping up or management of the public rights of way, street works, removal of hedgerows and the application and disapplication of legislation.

# **Environmental Impact Assessment Development**

6. Due to its nature and size, the Proposed Development is classified as an Environmental Impact Assessment (EIA) development for the purposes of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017. This means that the Proposed Development constitutes development for which an EIA is required. The Application is therefore accompanied by an Environmental Statement.
