DEADLINE 1 - WRITTEN REPRESENTATION.OAKLANDS FARM SOLAR PARK, DERBYSHIRE

Following our Relevant Representation (RR) [AS-019] dated 3 May 2024, we have had two meetings (09/05/2024 and 18/07/2024) with the applicant and their consultants to address the issues raised.

Point 6 of our RR (*Changes to water quality that does not impact WFD need to be considered*) has been resolved. Our initial concerns were due to a misunderstanding. However, we are confident that Chapter 8 (Water Resources and Flood Risk) does not underestimate water quality impacts and sufficient mitigation is proposed.

The other issues (Points 1-5, and 7) that we raised in our RR are still outstanding. However, the applicant has committed to resolving these issues.

We are unable to provide a more detailed update at this moment in time as we are awaiting updates to the following:

- Flood Risk Assessment
- Drainage Assessment
- Water Framework Directive Assessment
- Construction Environmental Management Plan
- Draft Development Consent Order
