## Cumulative Impact NSIP Oaklands

- Currently within the short distance there is:
  - 18MW Steam Turbine Alternator Unit, incinerating household refuse, online now building to full capacity at Drakelow nearly opposite the Park Farm main NSIP access, 200 lorries/day which should be noted in the highways impact. DCC deal with Waste applications.
  - 2 field solar projects passed 2022/23 at planning committee Scropton and Hilton/Hatton.
  - The Willshee's incinerator at Stanton is at application stage in at DCC, believed to now being determined as the incinerator pause has been reversed by the government. Application Number CW9/0623/15 Valid 28/07/23 60m chimney, vast building, chimney can be seen from Walton, Drakelow and at Park Farm, massive lorry impact on the A444.
  - Haunton solar farm (346 acres) has been passed and now being built, just next door on the border in Staffordshire by Lullington.
  - A biomass plant at Haunton owned by a farmer who lives in Seales Ward at SDDC generating electricity for 12,000 homes, the maize and grass supplied from farmed land locally is used at this biomass plant. Whilst the biomass plant is just over the border his farm straddles the border much of his tenanted farmland is in SD and Lullington.
  - BESS Under consultation received preapplication advice Land west of Cauldwell Road, Drakelow (opposite the Dracon entrance) on Park Farmland
  - EON land Brownfield 200 acres by the gas turbine incinerator above, opposite Park Farm, has been in pre application talks with SDDC for large scale solar, it was in the press this year.
  - This BESS at Drakelow is currently deferred at SDDC committee Proposed Battery Energy Storage System with associated access, landscaping and ancillary works at land South of Walton Road, Drakelow.   - Fairfield's BESS adjacent to NSIP track and site The installation and operation of a 1.025 GW Energy Storage System (ESS), including energy storage units, substation, site access, cable connection, landscaping and ancillary infrastructure at Fairfields Farm, Rosliston Road, Walton-on-Trent, The application may be viewed on our website at https://planning.southderbyshire.gov.uk/dmapps.aspx/?ref=DMPA/2024/0789.
  - BESS Royal Farm Drakelow The installation of a Battery Energy Storage Facility with associated infrastructure, a grid connection route corridor, a DNO substation and connecting structure, a new internal site access, and associated works at Land to the north of the Royle Farm Business Park, Drakelow, Swadlincote The application may be viewed on our website at https://planning.southderbyshire.gov.uk/dmapps.aspx/?ref=DMPA/2024/0499.
  - BESS screening test at the back of Rosliston/Drakelow DMOT/2022/0629 Land at Barn Farm, DE159TX, I thought this was given.
  - Coton Park/ Castle Gresley Bess 20MW not yet built, application 2021/1697
  - Coton Park Solar 2014/15 3.5MW it is built.
  - Breach Farm Cauldwell next to Royal Farm has a large Agric shed and indoor BESS 40MW dmpa/2020/0542 & 2018/0233
  - I believed there are a number of other BESS/Solar around the District I am unaware of as they are not in my ward/locality
  - Oddly the biggest impact has been the construction of 2200 houses on the Drakelow brownfield site, which was the power station with a vast loss of

trees, massive traffic from residents and construction and a big change to a very rural area, This is a big impact and is opposite this site, we are the fastest growing District in the UK and building and exceeding targets which the Planning Inspector needs to realise. We also build Derby City's un met need houses as well! Local infrastructure has not caught up, such as GPs and highway networks, I think they build 200 houses/year plus at Drakelow currently, as a District we are currently building 1200/year.
