We write on behalf of our client, National Grid Electricity Transmission plc (NGET), in relation to the Oaklands Farm Solar Park DCO.

We note that Item 6 of the agenda for Compulsory Acquisition Hearing 1 (CAH1) lists NGET as one of the statutory undertakers to make oral representations at the hearing. However, it is not felt necessary for NGET to make an oral representation at CAH1 because at this point in time, NGET and the applicant are nearing agreement of the protective provisions and will continue to work together to agree them as soon as possible. As there is no further update which can be provided at this point in time, it is considered that attendance at CAH1 to reiterate this update would be disproportionate.

However, NGET reserves the right to request attendance at any further open floor hearings or compulsory acquisition hearings should this become necessary.
