The dDCO and Explanatory Memorandum have been amended to reflect further changes to the dDCO arising from the Applicant's submissions at Deadline 6. As required by the ExA's Rule 8 letter the Deadline 6 includes the Applicant's clean version of the dDCO in Microsoft Word and an email notification confirming successful validation of the dDCO.

The Applicant no longer requires two plots of land owned by E.ON and has therefore submitted an amended Land Plan, Statement of Reasons and Book of Reference.

Amendments have then been made to various parts of the ES, including the management plans, primarily to reflect the Applicant's submissions at Deadline 6 and ongoing discussions with different statutory bodies.
