The Applicant provided its latest comments to NGET on 10 December 2024 and awaits a response.</p> <p>Upon the agreement of the Protective Provisions, the Applicant understands NGET will be able to withdraw its objection and will have no further representations to make, subject to there being no changes to the Proposed Development that would affect NGET's apparatus.</p>
2.	National Grid Electricity Distribution (East Midlands) plc ( <b>NGED</b> )	Yes	<p>The Protective Provisions have been agreed between the Applicant and NGED on 8 March 2024 and are reflected in Part 3 of Schedule 10 of the dDCO as submitted [APP-016] and remain unchanged in subsequent iterations of the dDCO.</p> <p>The Applicant and NGED have agreed the terms of an Asset Protection Agreement, which completed on 12 December 2024.</p> <p>The Applicant notes NGED withdrew its objection to the Proposed Development on 17 December 2024 and that NGED will have no further representations to make, subject to there being no changed to the Proposed Development that would affect NGED's apparatus.</p>
3.	South Staffordshire Water plc	No	<p>The Protective Provisions have been agreed between the Applicant and South Staffordshire Water plc on 25 April 2024 and are reflected in Part 5 of Schedule 10 of the dDCO as submitted [APP-016] and remain unchanged in subsequent iterations of the dDCO.</p>
4.	Cadent Gas Limited ( <b>Cadent</b> )	Yes	<p>The Protective Provisions have been agreed between the Applicant and Cadent on 30 October 2024 and are reflected in Part 4 of Schedule 10 of the dDCO as submitted at Deadline 5 [REP5-003].</p> <p>The Applicant notes Cadent withdrew its objection to the Proposed Development on 30 October 2024 and that Cadent will have no further</p>

			representations to make, subject to there being no changes to the Proposed Development that would affect Cadent's apparatus.
5.	BT Openreach	No	The Applicant has not received any engagement from BT Openreach in relation to Protective Provisions. However, BT Openreach is protected under Part 6 of Schedule 10 of the dDCO submitted at Deadline 3.
6.	Severn Trent Water	No	The Applicant has not received any engagement from Severn Trent Water in relation to Protective Provisions. However, Severn Trent Water is protected under Part 1 of Schedule 10 of the dDCO submitted at Deadline 3.
7.	Vodafone Limited	No	The Applicant has not received any engagement from Vodafone Limited in relation to Protective Provisions. However, Vodafone is protected under Part 6 of Schedule 10 of the dDCO submitted at Deadline 3.
