Ecotricity (Heck Fen Solar) Limited ("Ecotricity") has launched a targeted consultation for Heckington Fen Solar Project (the "Project") after making some localised changes to our proposals.

The principal formal consultation period for our Project was between 30 June 2022 and 1 September 2022. The design of the Project has continued to evolve in response to consultation.

Since the formal consultation, it has become apparent that you hold an interest in land within the Order Limits for the Project which have been amended.
