### Heckington Fen Solar Park Development Consent Order (application reference: EN010123)

### **Ecotricity (Heck Fen Solar) Limited**

### Change Notification (our document reference – PreExA.CL.CN.v1)

### Introduction

Ecotricity (Heck Fen Solar) Limited (company number 13225224) of Lion House, Rowcroft, Stroud, England, GL5 3BY (the "Applicant") submitted its application for a Development Consent Order ("DCO") for the construction, operation, maintenance and decommissioning of solar photovoltaic (PV) generating panels with a total capacity exceeding 50 megawatts (MW) together with associated energy storage and grid connection infrastructure at the Bicker Fen National Grid substation ("the Proposed Development") on 15 February 2023 (the "Application"). The Application was accepted for Examination on 13 March 2023 and the period for relevant representations closed on 9 June 2023.

The Applicant is proposing to submit a Change Application to the Planning Inspectorate (on behalf of the Secretary of State); prior to doing so the Applicant is notifying the Planning Inspectorate of the change (this letter) and will undertake targeted consultation.

Please therefore treat this letter and its enclosures as the Applicant's formal Change Notification in accordance with the Planning Inspectorate's Advice Note 16<sup>1</sup>.

### Executive Summary

The accepted Application includes land and works at National Grid's Bicker Fen Substation ("Bicker Fen Substation") to provide for a new generation bay for the Applicant together with works to facilitate the connection for the Applicant's project.

The proposed change relates to land at Bicker Fen Substation. Following submission of the Application, and as a result of ongoing discussions with National Grid Electricity Transmission (NGET), it has become clear that additional works at Bicker Fen Substation are required to

enable the grid connection. These works lie outside of the current Order Limits at the Bicker Fen Substation.

These works are necessary as a consequence of the Proposed Development and include:

- 1. a new section of NGET infrastructure at the substation comprising a busbar extension including a section breaker, a bus coupler and a feeder circuit on land to the south of Bicker Fen Substation, which is owned by NGET; and
- 2. a new cable sealing end ("CSE") compound on land to the west of Bicker Fen Substation which is owned by NGET.

Accordingly, a larger area is needed to facilitate the Applicant's connection into the Bicker Fen Substation. The full extent of the land area covered by the change is shown in yellow and green shading on Figure 1 appended to this letter.

The Applicant and NGET have prepared a Joint Position Statement (document reference PreExA.JPS.CN.v1), submitted with this Change Notification, to demonstrate the Applicant's and NGET's agreement on the proposals.

### Reason for the change

The latest discussions with NGET confirm that additional works needed at the NGET substation are triggered by the Applicant's Proposed Development; these works include a new 'section' of NGET infrastructure to be built to ensure compliance with the infeed loss risk at Bicker Fen Substation. A complete substation 'section' comprises:

- 1. a busbar extension and a 'bus section circuit breaker'2;
- 2. a 'bus coupler'<sup>3</sup>; and
- 3. at least one 'feeder circuit'<sup>4</sup> to evacuate power.

These three pieces of infrastructure are the minimum requirement to create a new substation 'section'.

The Applicant's Proposed Development is the "tipping point" of generation, necessitating a new section. The reason for this change now is due to further technical information being known and for completeness to ensure that the DCO contains the relevant provisions and permissions to allow the full project to be constructed. It also gives a complete picture of the related environmental impacts associated with the NGET connection works. This position is supported by the emerging National Policy Statements for Electricity Networks (EN-5)<sup>5</sup> which

encourages holistic planning – particularly at paragraph 2.7.1 and 2.7.2, which includes the following text:

"EN-1 explains in Section 4.10 that the Planning Act 2008 aims to create a holistic planning regime, such that the cumulative effects of the same project can be considered together.

Accordingly, the government envisages that, wherever reasonably possible, applications for new generating stations and their related infrastructure should be contained in a single application to the Secretary of State...".

Further, the principle of including wider associated development is supported in guidance on associated development applications for major infrastructure projects<sup>6</sup> where at paragraph 5(iv) guidance states that associated development should be proportionate to the nature and scale of the principal development, which is the case here.

### New / Altered Works

There are two main elements to the additional works the subject of this Change Notification (and the subsequent Change Application), as follows:

- a new section of NGET infrastructure at the substation comprising a busbar extension including a section breaker, a bus coupler and a feeder circuit on land to the south of Bicker Fen Substation, which is owned by NGET ("AW1"); and
- 2. a new cable sealing end ("CSE") compound on land to the west of Bicker Fen Substation which is owned by NGET ("**AW2**").

(together, the "Additional Works").

A CSE is a connection point to transition between underground cable and above ground apparatus such as electrical bus-bars or overhead line. At Bicker Fen Substation there is a 400kV transmission tower on the western boundary of the substation site which carries overhead line circuits to West Burton. As part of facilitating the Applicant's connection, one of the West Burton circuits will be moved to terminate at a new bay that will be constructed as part of the Bicker Fen Substation extension. To achieve this, the overhead line circuit will be connected onto a new CSE to be located in the area adjacent to the tower and an underground cable run to the new bay. For this reason, the Order Limits need to be extended around the transmission tower to allow for this circuit transfer.

The Additional Works must be delivered by NGET in order for NGET to be able to connect the Applicant whilst maintaining compliance with the infeed loss risk at Bicker Fen Substation. The Additional Works are therefore infrastructure works and assets which will be built and owned by NGET, but are triggered by the Applicant's connection.

In view of this, NGET require control over the Additional Works. In the alternative, if these works are not included in the DCO, NGET would need to obtain planning permission for the works comprising AW1 (under the Town and Country Planning Act 1990). That alternative is not the Applicant's preferred approach as it creates an additional consenting step to obtain all necessary consents to bring forward the Applicant's Proposed Development. It may, however,

be necessary in the event that NGET needed to undertake the extension works prior to commencement of the Applicant's DCO. For this reason, the Applicant proposes to include standalone works within the DCO for the benefit of NGET to undertake these Bicker Fen Substation Additional Works. Accordingly, the Applicant envisages splitting Work No. 6 into Work No. 6A (for the Applicant's generation bay), Work No. 6B (for NGET's extension works (AW1)), and Work No. 6C (for the CSE compound (AW2)). Allied with the above, a new Article will be included in the DCO to make clear that, in the event that NGET did undertake Work 6B or Work 6C under a separate consenting regime, the respective works and requirements in the DCO would not be engaged.

In addition, NGET require optionality over the type of insulation required for the switchgear and so the relevant parts of Work No.6A and 6B in the revised DCO will be updated to include the option for Air Insulated Switchgear (AIS) or Gas Insulated Switchgear (GIS).

The Applicant will confirm its approach to the changes post-consultation and show the full extent of the changes, including with updates to the DCO Application documents, alongside the formal Change Application.

### Additional Land

The change will require approximately 0.9ha of additional land at the Bicker Fen Substation. The land is under National Grid's ownership. At this stage it is the Applicant's intention to include rights of compulsory acquisition over the additional land. The Applicant is in discussions with National Grid and expects to be in a position to provide a consent letter with the Change Application confirming that the additional land can be included in the application for compulsory acquisition.

The NGET extension works are still in the preliminary design stage, however the extent to be shown in the Change Application (if accepted) will adopt a parameters approach and present a worst-case scenario from an Environmental Impact Assessment (EIA) perspective.

### EIA Implications

As explained above, the area subject to this Change Notification (and the subsequent Change Application) includes additional land that was not included as part of the Application. The land was included with the Preliminary Environmental Information Report published in June 2022 but was not the subject of full assessment in the environmental statement submitted with the Application.

The proposed change will result in the removal of a section of established tree plantation in the location to the south of the Bicker Fen Substation. The plantation trees were planted for compliance with a condition for the grant of planning permission for the Bicker Fen Substation which was approved in 2005 (under Boston Borough Council reference B/05/0046).

Removal of the tree planting will incur additional environmental impacts (i.e. landscape/ecology) but preliminary assessment is indicating that these impacts are not likely to be significant. A full assessment is being undertaken and preliminary details are included within the draft Targeted Consultation Information Leaflet (see below). Updates to the ES will be submitted with the Change Application.

The Applicant's preliminary assessment is that replacement tree planting may not be possible because of the land taken by the Additional Works as they do not leave sufficient land available for planting. However that preliminary assessment also considers that the removal of the planting will not give rise to any significant visual or landscape impacts. The ecological impact

of the removal of the trees does not change the overall significance in EIA terms and the overall biodiversity net gain (which is currently in excess of 100%) for the Proposed Development only decreases by c.1% with removal of the section of plantation trees.

The PEIR and ES Chapter 6 established that the area to the west, south west, and south of the National Grid Bicker Fen Substation is virtually free from any constraints in visual terms. The identified visual receptors are either too distant or are already screened, limiting the potential for any significant effects brought about by the proposed change. In landscape character terms, the area is already influenced by the existing large scale high voltage electricity pylons and Bicker Fen Wind Farm, the Triton Knoll Substation at Doubletwelves Drove / Bicker Drove, and the Viking Link converter stations.

The supplementary EIA, to be submitted with the Change Application, will consider in detail the full assessment of the change; at this stage, the Applicant is still reviewing whether any additional landscaping can be accommodated on NGET's land as mitigation or enhancement.

The Applicant has enclosed with this Change Notification, at Appendix 2, extracts from the draft of the consultation information leaflet that will form the basis of the primary consultation document. It is in draft at this stage as it requires further detail to be added on some of the EIA conclusions. However, we considered that it would be helpful for the Examining Authority to see the proposed structure for the consultation document. This document, once supplemented with the final details of the EIA assessments, will form the Targeted Consultation Information Leaflet to be sent to relevant consultees.

### Consultation and Timescale for the Change Application

We understand that the Preliminary Hearing is due to take place in mid-late September 2023. With that in mind, and recognising the emphasis in paragraph 7.3 of Advice Note 16 to undertake consultation prior to Examination commencing, the Applicant proposes to undertake targeted consultation with those relevant and affected bodies that were the subject of consultation under Section 56 of the Planning Act 2008. The Applicant does not consider that there will be any new interested parties or consultees in addition to those consulted at Section 56.

In view of the localised nature of the changes, the Applicant considers that it will be proportionate to adopt targeted consultation limited to those relevant "EIA consultation bodies"<sup>7</sup> and relevant local stakeholders including Bicker Parish Council. A full list of proposed consultees is enclosed with this cover letter at Appendix 1. Notwithstanding this, the Applicant acknowledges the suggestion at Figure 2b paragraph 6A of Advice Note 16 that the publicity should reflect the relevant publicity requirements of The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 ("EIA Regulations"). Accordingly, in keeping with the requirements of the EIA Regulations, the Applicant will publish notices:

- for at least 2 successive weeks in one or more local newspaper circulating in the vicinity of the proposed development;
- in a national newspaper; and
- in the London Gazette.

The Applicant will allow consultees a minimum of 30 days to provide responses following the date on which the notice is last published.

The Applicant will also place site notices at, or as close as reasonably practicable to, the area of additional land at the Bicker Fen Substation.

As explained above, the consultation will include a Targeted Consultation Information Leaflet. The Targeted Consultation Information Leaflet will summarise the changes and explain the impact in environmental terms. Where parties are not consulted, a justification for this will be included alongside a standalone consultation report with the Change Application.

The consultation summary document will be available on the project website or if requested on email, or a USB stick or hard copy. A copy will also be available for viewing at the following locations:

Consultees will be invited to provide comments to the Applicant by telephone, email or freepost using the details noted below. The Applicant will have due regard to all relevant responses, and this will be set out in a consultation report/statement to be submitted with the Change Application. We propose the targeted consultation to begin in **mid-July** and run until the end of **August 2023**.

In summary, the Applicant is undertaking targeted consultation in advance of the Preliminary Hearing. This will give the Applicant the ability to have regard to responses before submitting the Change Application. The Applicant will compile a consultation report, which sets out how it has undertaken its consultation and how regard has been had to the responses received. In the event that the Examining Authority considers that there needs to be further opportunity for comment following submission of the formal Change Application, the Applicant would request that this is built into the Examination timetable with, for example, a deadline reserved for further comments on the Applicant's change request.

We trust that the above and enclosed are a helpful explanation of the proposed change to the Application but please do let us know if there is any clarification or further detail you require in advance of submission of the Change Application, which the Applicant expects to submit in early September 2023.

### Appendix 2 – Targeted Consultation Change Notification Information Leaflet - DRAFT

The below shows extracts of the proposed Consultation Information Leaflet to illustrate the structure and matters that will be covered as part of the consultation. Please note that after page 4, between the sections labelled 'Rochdale Envelope' and 'How are we consulting?', there will be summaries of the EIA assessments in relation to the following topics: Landscape and Visual; Residential Visual Amenity Assessment; Ecology and Ornithology; Hydrology, Hydrogeology, Flood Risk and Drainage; Cultural Heritage; Socio-Economics; Noise and Vibration; Climate Change; Transport and Access; Air Quality; Land Use and Agriculture; Glint and Glare; Miscellaneous Issues.

### We are consulting on localised changes to our proposals at Bicker Fen Substation that have been made since our Application was submitted in February 2023.

Ecotricity (Heck Fen Solar) Limited (the Applicant) submitted its application for a Development Consent Order for the construction, operation, maintenance and decommissioning of solar photovoltaic generating panels with a total capacity exceeding 50 megawatts together with associated energy storage and grid connection to, and infrastructure at, the Bicker Fen National Grid Substation (the Proposed Development) on 15 February 2023 (the Application). The Application was accepted for Examination on 13 March 2023 and the period for relevant representations closed on 9 June 2023.

The Applicant is proposing to submit a Change Application to the Planning Inspectorate (on behalf of the Secretary of State); however prior to doing so the Applicant will submit a Change Notification and complete Targeted Consultation.

The accepted Application includes land and wor at National Grid's Bicker Fen Substation (Bicker Fen Substation) to provide for a new generation bay for the Applicant together with works to scalitate the connection for the Applicant's project.

The proposed change relates to land a wrcker Fen Substation, which is under the write vip on Vational Grid Electricity Transmission (NGET). Following submission of the Application and as a result of ongoing discussions with NGET, that become clear that additional works at Bicker Fen Substation are required to enable the grid connection. These works lie outside of the current Order Limits at the Bicker Fen Substation.

The works are necessary as a consequence of the Proposed Development and include:

• a new section of NGET infrastructure at the substation comprising a busbar extension including a section breaker, a bus coupler and a feeder circuit on land to the south of Bicker Fen Substation (AW1) and;

• a new cable sealing end compound (CSE) on land to the west of Bicker Fen Substation (AW2);

together known as, the "Additional Works".


The land is owned by NGET.



#### **REASON FOR THE CHANGE**

The Additional Works must be delivered by NGET in order for NGET to be able to connect the Heckington Fen project whilst maintaining compliance with the infeed loss risk at Bicker Fen Substation. The Additional Works are therefore infrastructure works and assets which will be built and owned by NGET, but are triggered by the new connection.

The Applicant's Proposed Development is the "tipping point" of generation, necessitating a new section. The reason for this change now is due to further technical information being known and for completeness to ensure that the DCO contains the relevant provisions and permissions to allow the full project to be constructed; it also gives a complete picture of the related environmental impacts associated with the NGET connection works. This position is supported by the emerging National Policy Statements for Electricity Networks (EN-5) which encourages holistic planning – particularly at paragraph 2.7.1 and 2.7.2, which includes the following text:

"EN-1 explains in Section 4.10 that the Planning Act 2008 aims to create a holistic planning regime, such that the cumulative effects of the same project can be considered together.

Accordingly, the government envisages that, wherever reasonably possible, applications for new generating stations and their related infrastructure should be contained in a single application to the Secretary of State...".

Furthermore, the principle of including wider associated development is upported in guidance on associated development applications for major infrastructure projects where a paragraph (v) guidance states that associated development should be proportionate to the nature and scale of the principal development.

### ADDITIONAL WORKS - DESCRIPTION

The extent of the trees which need to be cleared to enable the new expansion at Bicker Fen can be seen on the plan below (yellow area). NGET have advised that if there cleared would only be required if an Air Insulated Switchgear (AIS) solution is used. This design solution would be contribution of the switchgear equipment already in operation at Bicker Fen National Grid substation. The alternative location option is the installation of a Gas Insulated Switchgear system (GIS). This alternative solution would be noused within a building and would occupy a smaller footprint than the AIS design option.


The cable sealing end (CSE mpound o to and the west of the existing Bicker Substat (green area) is a connection point to t between underground cable and above grou nd apparatus such as electrical bus-bars or overhead line. At Bicker Fen Substation there is a 400kV transmission tower on the western boundary of the substation site which carries overhead line circuits to West Burton. As part of facilitating the Applicant's connection, one of the West Burton circuits will be moved to terminate at a new bay that will be constructed as part of the Bicker Fen Substation extension. To achieve this, the overhead line circuit will be connected onto a new CSE to be located in the area adjacent to the tower and an underground cable run to the new bay. For this reason, the Order Limits need to be extended around the transmission tower to allow for this circuit transfer.

### DEVELOPMENT CONSENT ORDER

The Additional Works must be delivered by NGET in order or no. To be a set to connect the Applicant whilst maintaining compliance with the infeed loss risk at Bicker Fen Substation and Assets which will be built and owned by the complication of the Applicant's connection.

In view of this, NGET require control over ie Addi nal Woi In the alternative, if these works are not included in the DCO, NGET would need to obtain plannin em (under the Town and Country Planning Act 1990). That sion alternative is not the Applicant's ach as it creates an additional consenting step to obtain all necessary ar pplican consents to bring forward the d Development. It may, however, be necessary in the event that rop NGET needed to undertake t rks prior to commencement of the Applicant's DCO. For this reason, the xtension v orks within the DCO for the benefit of NGET to undertake these Bicker Applicant proposes to include s lalon Fen Substation Additional Works. A ngly, the Applicant envisages splitting Work No. 6 into Work No. 6A (for the Applicant's generation bay), Work No. 6B (for NGET's extension works (AW1)), and Work No. 6C (for the CSE compound (AW2)). Allied with the above, a new Article will be included in the DCO to make clear that, in the event that NGET did undertake Work 6B or Work 6C under a separate consenting regime, the respective works and requirements in the DCO would not be engaged.

In addition, NGET require optionality over the type of insulation required for the switchgear and so the relevant parts of Work No.6A and 6B in the revised DCO will be updated to include the option for Air Insulated Switchgear (AIS) or Gas Insulated Switchgear (GIS).

#### **ROCHDALE ENVELOPE**

Where flexibility is required, as is the case with the Additional Works the use of the 'Rochdale Envelope' approach can be applied to ensure a robust assessment of the likely significant environmental effects. This involves assessing the maximum (and where relevant, minimum) parameters, size (footprint, width, and height), technology, and locations. The outcome of the Development Consent Order would then permit development of the type and scale assessed within that envelope area.

We will have regard to all comments received during the consultation, your fee back is important to us. We are seeking your views on the changes outlined in this document and are only consulting on these changes. Ecotricity will consider the consultation responses made and will have regard to them as it inalises to request to make changes to the Application. It will compile a consultation report, which sets out how it has unservice its consultation and how regard has been had to the responses received. This will be submitted with the request to make changes to the Application. The examining authority will then decide whether to accept the request.


