# **1 INTRODUCTION**

## **Purpose of this Document**

1.1.1 This document provides a guide to Ecotricity (Heck Fen Solar) Limited's (the 'Applicant') application for a Development Consent Order (DCO Application) for Heckington Fen Solar Park made to the Secretary of State for Energy Security and Net Zero (the 'Secretary of State') pursuant to the Planning Act 2008 (PA 2008).

1.1.2 The Applicant is seeking a DCO for the construction, operation (including maintenance), and decommissioning of a solar photovoltaic (PV) park and supporting infrastructure (the 'Proposed Development'). The DCO Application is required because the Proposed Development is classified as a Nationally Significant Infrastructure project (NSIP) under the PA 2008.

1.1.3 This Guide aims to help the Examining Authority (ExA) and interested parties understand the structure of the DCO Application through signposting to the documents that make up the Application.

1.1.4 Regulation 5 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (as amended) (APFP Regulations) sets out the documents that DCO applications must include. It also provides at Regulation 5(2)(q) for the submission of "any other documents considered necessary to support the application" as well as at Regulation 5(2)(o) for "any other plans, drawings and sections necessary to describe the proposals."

1.1.5 Regulation 6 of the APFP Regulations sets out the specific documentation required in support of DCO applications for particular types of development, including generating stations and grid connections.

1.1.6 The Proposed Development constitutes an Environmental Impact Assessment (EIA) development and therefore the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the EIA Regulations), and requirements contained therein, apply.

1.1.7 This Guide provides an overview of the documents that have been submitted in order to satisfy the APFP Regulations, the EIA Regulations and section 37 of the PA 2008.

## **The Applicant**

1.1.8 Ecotricity (Heck Fen Solar) Limited (company number: 13225224) is the Applicant for the DCO. The Applicant has been formed to create and develop the Heckington Fen Solar Park and is a company registered in England and Wales. Ecotricity (Heck Fen Solar) Limited is part of the group owned by Green Britain Group Limited (the "**Ecotricity Group**").

1.1.9 Founded by Dale Vince in 1995, the Ecotricity Group was the world's first green energy supplier and now supplies customers across the UK from a growing portfolio of wind and sun parks, with all its electricity supply coming from 100% renewable energy. The Ecotricity Group is a high technology business, developing cutting edge green technology and energy for a low carbon future and generating a large number of knowledge intensive and highly skilled jobs within Gloucestershire and the UK.

1.1.10 Further details about the Applicant can be found in the Funding Statement (document reference: 4.2).

## **2 DOCUMENT REFERENCING**

2.1.1 Each document that forms part of this Application has been assigned a reference number that will allow it to be located within the Application document library. When an Application document refers to another document, then the document reference information is provided. This comprises of a specific document number (for example, '3.3') which is shown on the front cover of the corresponding document and included in the list at Table 3.2 below.

## **3 MASTER DOCUMENTS LIST**

3.1.1 The documents submitted as part of the Application have been grouped into the below document parts noted within Table 3.1 to accord with the Planning Inspectorate's (PINS) Advice Note Six: Preparation and submission of application documents (version 11) published in August 2022.

Part 4 – Compulsory Acquisition Information	Provides evidence for why legal powers of compulsory acquisition are sought, as well as information on how the Proposed Development is to be funded and details of the land interests that are required for the Proposed Development.
Part 5 – Reports and Statements	Contains the consultation report and its supporting appendices relating to the pre-application consultation undertaken on the Proposed Development and how consultation feedback has been taken into account. It contains a report to support the ExA's/SoS's assessment under the UK Habitat Regulations. It contains a statement identifying potential statutory nuisances associated with the Proposed Development and how these have been mitigated. It also contains a statement clarifying responsibility for the construction of the grid connection, which forms part of the Proposed Development, and a more general technical guide relating to the Proposed Development.
Part 6 – Environmental Statement	Provides environmental information and an assessment of the likely significant effects of the Proposed Development, as well as a description of proposed mitigation measures.
Part 7 – Other Documents	Contains additional documents pertaining to the Proposed Development, required by Regulation 6 of the APFP Regulations and considered by the Applicant to be required to support the application in the form of outline plans to secure mitigation in accordance with Regulation 5(2)(q) of the APFP Regulations.

3.1.2 The master document table, provided at Table 3.2, provides a breakdown of the documents, indicating either the latest version (if applicable) or when a new document was submitted. 'Milestone' sub-headings are provided to distinguish between different stages of the DCO application process and to make it clear at which stage a document was submitted – for example, the first milestone sub-heading lists out the documents submitted with the Application; the second milestone sub-heading is for documents submitted during the Pre-Examination stage; and the third milestone sub-heading will be for documents submitted during the Examination stage (etc.). This is therefore a live document and will be updated when updates or revisions to existing documents are made and new documents are submitted to the Planning Inspectorate as part of the Examination process. The table identifies the reference number, title, submission date, and version of the document.

**Certified Documents**

3.1.3 In response to a request within the Rule 6 letter (PD-009) for a live list of the documents and document reference numbers that are to be certified under Schedule 11 of the DCO, the Applicant has included Table 3.1(a). # **1 INTRODUCTION**

## **Purpose of this Document**

1.1.1 This document provides a guide to Ecotricity (Heck Fen Solar) Limited's (the 'Applicant') application for a Development Consent Order (DCO Application) for Heckington Fen Solar Park made to the Secretary of State for Energy Security and Net Zero (the 'Secretary of State') pursuant to the Planning Act 2008 (PA 2008).

1.1.2 The Applicant is seeking a DCO for the construction, operation (including maintenance), and decommissioning of a solar photovoltaic (PV) park and supporting infrastructure (the 'Proposed Development'). The DCO Application is required because the Proposed Development is classified as a Nationally Significant Infrastructure project (NSIP) under the PA 2008.

1.1.3 This Guide aims to help the Examining Authority (ExA) and interested parties understand the structure of the DCO Application through signposting to the documents that make up the Application.

1.1.4 Regulation 5 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (as amended) (APFP Regulations) sets out the documents that DCO applications must include. It also provides at Regulation 5(2)(q) for the submission of "any other documents considered necessary to support the application" as well as at Regulation 5(2)(o) for "any other plans, drawings and sections necessary to describe the proposals."

1.1.5 Regulation 6 of the APFP Regulations sets out the specific documentation required in support of DCO applications for particular types of development, including generating stations and grid connections.

1.1.6 The Proposed Development constitutes an Environmental Impact Assessment (EIA) development and therefore the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the EIA Regulations), and requirements contained therein, apply.

1.1.7 This Guide provides an overview of the documents that have been submitted in order to satisfy the APFP Regulations, the EIA Regulations and section 37 of the PA 2008.

## **The Applicant**

1.1.8 Ecotricity (Heck Fen Solar) Limited (company number: 13225224) is the Applicant for the DCO. The Applicant has been formed to create and develop the Heckington Fen Solar Park and is a company registered in England and Wales. Ecotricity (Heck Fen Solar) Limited is part of the group owned by Green Britain Group Limited (the "**Ecotricity Group**").

1.1.9 Founded by Dale Vince in 1995, the Ecotricity Group was the world's first green energy supplier and now supplies customers across the UK from a growing portfolio of wind and sun parks, with all its electricity supply coming from 100% renewable energy. The Ecotricity Group is a high technology business, developing cutting edge green technology and energy for a low carbon future and generating a large number of knowledge intensive and highly skilled jobs within Gloucestershire and the UK.

1.1.10 Further details about the Applicant can be found in the Funding Statement (document reference: 4.2).

## **2 DOCUMENT REFERENCING**

2.1.1 Each document that forms part of this Application has been assigned a reference number that will allow it to be located within the Application document library. When an Application document refers to another document, then the document reference information is provided. Part 4 – Compulsory Acquisition Information	Provides evidence for why legal powers of compulsory acquisition are sought, as well as information on how the Proposed Development is to be funded and details of the land interests that are required for the Proposed Development.
Part 5 – Reports and Statements	Contains the consultation report and its supporting appendices relating to the pre-application consultation undertaken on the Proposed Development and how consultation feedback has been taken into account. It contains a report to support the ExA's/SoS's assessment under the UK Habitat Regulations. It contains a statement identifying potential statutory nuisances associated with the Proposed Development and how these have been mitigated. It also contains a statement clarifying responsibility for the construction of the grid connection, which forms part of the Proposed Development, and a more general technical guide relating to the Proposed Development.
Part 6 – Environmental Statement	Provides environmental information and an assessment of the likely significant effects of the Proposed Development, as well as a description of proposed mitigation measures.
Part 7 – Other Documents	Contains additional documents pertaining to the Proposed Development, required by Regulation 6 of the APFP Regulations and considered by the Applicant to be required to support the application in the form of outline plans to secure mitigation in accordance with Regulation 5(2)(q) of the APFP Regulations.



3.1.2 The master document table, provided at Table 3.2, provides a breakdown of the documents, indicating either the latest version (if applicable) or when a new document was submitted. 'Milestone' sub-headings are provided to distinguish between different stages of the DCO application process and to make it clear at which stage a document was submitted – for example, the first milestone sub-heading lists out the documents submitted with the Application; the second milestone sub-heading is for documents submitted during the Pre-Examination stage; and the third milestone sub-heading will be for documents submitted during the Examination stage (etc.). This is therefore a live document and will be updated when updates or revisions to existing documents are made and new documents are submitted to the Planning Inspectorate as part of the Examination process. The table identifies the reference number, title, submission date, and version of the document.

**Certified Documents**

3.1.3 In response to a request within the Rule 6 letter (PD-009) for a live list of the documents and document reference numbers that are to be certified under Schedule 11 of the DCO, the Applicant has included Table 3.1(a).
