This letter is provided in response to the Examining Authority's ("ExA") **Rule 17 letter** [PD-008] dated 26 November 2024.

Request to Interested Parties

The Applicants have responded to this matter in a separate letter dated 28 November 2024 [AS-091].

Request to the Applicants

The Applicants are asked to review the status of application documents to which the Examining Authority and Interested Parties have sought updates, with reference to the list supplied. The Applicants have reproduced this table in **Appendix A** to this letter, with commentary on the status of the documents.

Following provision of further document updates on 29 November 2024, the information requested is now substantially available to the ExA and Interested Parties. The only exceptions are listed below:

- a. The draft Development Consent Order and supporting documents will be provided by 6th December 2024. These documents are intentionally provided last so that changes arising from amendments to other documents can be incorporated. This suite of documents will include:
 - o 3.1 draft Development Consent Order
 - o 3.2 Explanatory Memorandum
 - o 10.39 Schedule of Changes to dDCO







- b. **1.4 Guide to the Application** is also updated at this final submission (by 6th December 2024) to incorporate all of the revisions provided in the pre-examination period to date
- Row 21 Coastal Erosion Rate Technical Note this is expected in mid-December due to incorporation of data recently received from East Riding of Yorkshire Council
- d. **8.23 In Principle Monitoring Plan** this document will be updated if agreement is reached with the MMO on time limits to sign off post-consent submissions. The discussions are underway, but an update is not expected soon.
- e. Row 51 Phase 2 Archaeological Trial Trenching as stated in our letter [PDA-011], this new work will be provided in early 2025 once reporting is complete
- f. Row 53 Agri environment scheme **7.21 Land Use** will be updated with available information on 6th December 2024
- g. **7.18 Terrestrial Ecology and Ornithology** this will be updated again on 6th December 2024
- h. Row 70 photomontages as stated in our letter [PD-006], this new work will be provided in early 2025, as they need to include trees after leaf fall

The Applicants consider that once items (a) and (b) have been provided all preexamination document revisions sought, and requests for information, would have been dealt with. These will be reflected in the new edition of the Guide to the Application and of the draft DCO.

The Applicants are currently consulting on potential changes to the Application, in line with the ExA's advice. The Applicants expect Change Applications to be made in January, subject to consideration of feedback received.
