Dogger Bank South Offshore Wind Farms Project Change Request Applications

The Applicants have notified the Examining Authority (ExA) of two potential changes to the Dogger Bank South proposals. This letter is the Applicants' application to make these changes.

Project Change Request 1 was notified to the ExA on 8 October 2024 in **10.2 Change Notification Letter** [PDA-012]. Project Change Request 2 was notified to the ExA on 4 November 2024 in **10.22 Intention to Submit a Change Request** [AS-015]. The ExA responded to both on 7 November 2024 in their **Rule 17 Letter** [PD-007] endorsing the approach to consultation and the change process.

In making this change application, the Applicants have been mindful of Planning Inspectorate Advice *Nationally Significant Infrastructure Projects: Changes to an application after it has been accepted for examination* (August 2024) (the Advice). Having followed the first three steps, this letter and accompanying documents represent Step 4 of the process, the requirements of which are addressed below.

Changes sought

Project Change Request 1 relates to the Offshore and Intertidal works areas. The proposed changes do not affect the Order Limits and are limited to reducing the scope of activities within the works. The Applicants have assessed the environmental impacts of the proposed changes and reported on these. It is concluded that it would not result in any new or different likely significant effects from those previously reported. This is provided in **10.49 Project Change Request 1 – Offshore and Intertidal Works** provided as part of this application. This

Project Change Request 2 relates to the Onshore Substation Zone. The proposed changes would reduce the footprint of the permanent infrastructure within the Onshore Substation Zone, which would reduce the extent of the Order Limits in this area and reduce the scope of compulsory acquisition powers sought in some remaining parcels. The Applicants have considered the environmental impacts of the proposed changes and concluded that it would not result in any new or different likely significant effects from those previously reported. This is provided in **10.53 Project Change Request 2 - Onshore Substation Zone** provided as part of this application. This is an update to the information consulted upon.
