Representative Viewpoint 4 (Left) - Carlby Road near layby and junction with Bridleway BrAW/1/1

## **Existing View:**

This viewpoint is representative of walkers and motorists at the layby and junction with Bridleway BrAW/1/1 approximately 313m to the north of the eastern parcel of the Solar PV Site. The existing view extends along the highway towards Braceborough Little Woods and Grange Farm Cottages to the east, Banthorpe Woods to the south-east, Bridleway BrAW/1/1 to the south, woodlands near Park Farm and Essendine to the south-west of the viewpoint.

## **Operational Phase Effects:**

The proposed eastern parcel of the Solar PV Site would be set back from Carlby Road by approximately 313m beyond new hedgerows and treebelts providing a connection and habitat linkage between two existing blocks of woodland. The proposed hedgerows would approximately follow the alignment of an historic hedgerow lost through arable intensification. The upper elevations of the solar arrays would be visible in the medium distance following construction although the foreground of the Carlby Road would be retained within the context of arable farmland. The Solar PV Site would be screened over time by the proposed hedgerow and treebelt planting to north of the eastern parcel and to the south of the Carlby Road. A new permissive footpath would be provided to the south of the Carlby Road. The scale of effect would be medium (adverse) at year 1 reducing to small (adverse) by year 15 once the existing and proposed hedgerows have matured to provide additional visual screening.


