Anglian Water	Yes	<p>The Protective Provisions have been agreed between the Applicant and Anglian Water on 12 June 2023 and are reflected in the dDCO (Rev 2) submitted at Deadline 2.</p> <p>As the PPs are now agreed, Anglian Water will be able to withdraw its objections and will have no further representations to make, subject to there being no changes to the Proposed Development which would affect Anglian Water's apparatus.</p>
2.	BT Limited	No	<p>The Applicant has not received any responses from BT Limited in relation to protective provisions. However, BT is protected under Part 2 of Schedule 15 of the dDCO (Rev 2).</p>
3.	Cadent Gas Limited	Yes	<p>The Protective Provisions and Side Agreement have been agreed between the Applicant and Cadent Gas on 6 June 2023 and are reflected in the dDCO (Rev 2) submitted at Deadline 2.</p> <p>Once the Side Agreement has been completed, which is expected imminently, Cadent Gas will be able to withdraw its objections and will have no further representations to make, subject to there being no changes to the Proposed Development which would affect Cadent Gas' apparatus.</p>

Environment Agency	Yes	<p>The Applicant is in active discussions with the Environment Agency and anticipates the Protective Provisions will be agreed before the end of the Examination.</p> <p>The Applicant sent comments on the Protective Provisions to the Environment Agency on 15 February 2023. The Applicant is awaiting a response from the Environment Agency.</p> <p>The Applicant's latest position is reflected in the dDCO (Rev 2), however this has not yet been agreed with the Environment Agency.</p>

5.	Gigaclear Limited	No	On 1 November 2022, Gigaclear Limited confirmed that they are content with the protections provided in the protective provisions contained in Part 2 of Schedule 15 of the dDCO (Rev 2).

Network Rail	Yes	<p>The Applicant is in active discussions with Network Rail and anticipates the Protective Provisions will be agreed before the end of the Examination.</p> <p>The Applicant sent comments on the Protective Provisions to Network Rail on 6 June 2023. The Applicant is awaiting a response from Network Rail.</p> <p>Network Rail's standard form protective provisions are reflected in the dDCO (Rev 2), with discussions on-going with Network Rail.</p>
7.	National Grid Electricity Transmission (NGET)	Yes	<p>The Protective Provisions have been agreed between the Applicant and NGET on 7 June 2023 and are reflected in the dDCO (Rev 2) submitted at Deadline 2.</p> <p>As the PPs are now agreed, NGET will be able to withdraw its objections and will have no further representations to make, subject to there being no changes to the Proposed Development which would affect NGET's apparatus.</p>

National Grid Electricity Distribution (East Midlands) (NGED)	Yes	<p>The Protective Provisions have been agreed between the Applicant and NGED on 14 April 2023 and are reflected in the dDCO (Rev 2) submitted at Deadline 2.</p> <p>The Applicant is in active discussions with NGED in relation to the Asset Protection Agreement and anticipates agreement before the end of Examination. Upon completion of the Asset Protection Agreement, NGED will be able to withdraw its objections and will have no further representations to make, subject to there being no changes to the Proposed Development which would affect NGED's apparatus</p>
