Purpose of ISH2

This Hearing is being held to address matters and questions identified by the ExA including through its reading of application documents, Local Impact Reports, representations from Interested Parties, responses to written questions and site inspections to date.

It considers that the matters raised would benefit from consideration of oral representations in order to ensure adequate examination of these issues.

The agenda provided above is indicative and may be subject to change on the day. Documents within the Examination Library should be taken as read and need not be repeated in oral submissions, although signposting to key documents and representations may assist.

Attendance

Anyone wishing to attend the Hearing in person, who has not already advised the Case Team of this, should do so as soon as possible.

The event will be livestreamed and a link for watching the livestream will be posted on the <u>project webpage</u> of the National Infrastructure Planning website closer to the Hearing date. IPs and members of the public who wish to observe the Hearing can therefore view and listen to the Hearing using the livestream, or view and listen to the recording, after it has concluded.

Procedure at ISH

Guidance under the Planning Act 2008 and the Infrastructure Planning (Examination Procedure) Rules 2010 provides that it is for the ExA to probe, test and assess the evidence through direct questions of persons making oral representations at Hearings. Questioning at the Hearing will be led by the ExA. The ExA will ask specific questions related to the matters identified in the agenda. Matters raised in written submissions should be taken as read and do not need to be repeated but may be referred to where required.

Cross questioning of a person giving evidence by another person will only be permitted if the ExA decides it is necessary to ensure representations are adequately tested or that an IP has had a fair chance to puts its case.
