1. Introduction

1.1. Purpose of this Document

- 1.1.1. This document provides a guide to Mallard Pass Solar Farm Limited's (the 'Applicant') application for a Development Consent Order (DCO) for Mallard Pass Solar Farm made to the Secretary of State for Business, Energy and Industrial Strategy (the 'Secretary of State') pursuant to the Planning Act 2008 (PA 2008). Please note that the application will now be determined by the Secretary of State for Energy Security and Net Zero. This new governmental Department (Department for Energy Security and Net Zero) replaced the Department for Business, Energy and Industrial Strategy on 7th February 2023.
- 1.1.2. The Applicant is seeking a DCO for the construction, operation (including maintenance), and decommissioning of a solar photovoltaic (PV) farm and supporting infrastructure (the 'Proposed Development'). The Application is required because the Proposed Development is classified as a Nationally Significant Infrastructure project (NSIP) under the Planning Act 2008 (PA 2008).
- 1.1.3. This Guide aims to help the Examining Authority (ExA) and interested parties understand the draft DCO Application through signposting to the documents that make up the Application.
- 1.1.4. Regulation 5 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (as amended) (APFP Regulations) sets out the documents that all draft DCO applications must include. It also provides at Regulation 5(2)(q) for the submission of "any other documents considered necessary to support the application" as well as at Regulation 5(2)(o) for "any other plans, drawings and sections necessary to describe the proposals."
- 1.1.5. Regulation 6 of the APFP Regulations sets out the specific documentation required in support of draft DCO applications for particular types of development, including generating stations and grid connections.

The Applicant

1.2.1. The Applicant is Mallard Pass Solar Farm Ltd, a subsidiary of Windel Energy Ltd.

1.2.2. Windel Energy Ltd, founded in 2018, is a privately held company that specialises in the development and asset management of renewable energy projects and low carbon, including solar, battery energy storage systems, onshore wind and green hydrogen technologies with projects ranging from 10MW to 320MW output across England and Wales. Windel Energy works closely with landowners, giving them the opportunity to diversify their income stream by leasing their land for solar development.

1.2.3. Canadian Solar Inc is the development partner of Windel Energy. It was founded in 2001 in Canada and is one of the world's largest solar power companies. It is a leading manufacturer of PV Modules and provider of solar energy solutions and has a geographically diversified pipeline of utility-scale solar power projects in various stages of development. Over the past 19 years, Canadian Solar Inc has successfully delivered over 49 GW of premium-quality, PV Modules to customers in over 150 countries.

2. The Proposed Development

Proposed Development Description

2.1.1. Mallard Pass Solar Farm is a proposed solar farm that will generate energy for exporting to the National Grid (the 'Proposed Development').

2.1.2. The Proposed Development comprises the construction, operation and maintenance, and decommissioning of a solar PV array electricity generating facility with a total capacity exceeding 50MW in approximately 852ha of land within Lincolnshire and Rutland. A full description of the Proposed Development can be found within Chapter 5 of the Environmental Statement **[REP2-012]** and Design and Access Statement **[REP5-058]**.

2.1.3. The main objective for the Proposed Development is to generate low-carbon renewable energy, that can be used to contribute to addressing the urgent need to decarbonise the UK's energy supply. Further details on this can be found within the Statement of Need **[APP-202]**.

The Order Limits

2.2.1. The Order limits are shown on the Location, Order Limits and Grid Coordinates Plans **[AP-013]**, Land Plans **[REP7-004]** and Works Plan **[REP7-005]** which accompany this Application.

2.2.2. The Proposed Development comprises of approximately 852ha of land that is located within the administrative areas of South Kesteven District Council (SKDC) and Rutland County Council (RCC).

3. The Purpose and Structure of this Document

- 3.1.1 The purpose of this Application Guide is to list the documents (the Application Documents) that make up the Application submitted to the SoS. In addition, it sets out how the Application Documents submitted comply with relevant legislative and policy requirements and guidance.
- 3.1.2 The Application Guide will be updated by the Applicant, as required, during the examination of the Application by the SoS and documents that have been superseded will be clearly identified as such.
- 3.1.3 The Application Documents are listed in Section 2 (Table 2.1) of this document.

4. Application Documents

- 4.1.1 The Application Documents have been grouped into appropriate categories and each has been given its own document reference in Table 2.1 on the following pages.
- 4.1.2 In addition to listing the Application Documents submitted, Table 2.1 also identifies where these have been provided to comply with relevant legislative requirements, or specific policy and relevant guidance. The legislative requirements for DCO applications are principally contained in 2008 Act, the Infrastructure Planning (Applications: Prescribed Forms and Procedures) Regulations 2009 (APFP Regulations) and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (The Infrastructure EIA Regulations 2017). Specific policies are set out in relevant energy National Policy Statements (NPS).
- 4.1.3 The Application submitted for the Proposed Development is considered to comply with the statutory requirements of the 2008 Act, the APFP Regulations and the Infrastructure EIA Regulations 2017, and also with the applicable SoS and Planning Inspectorate (PINS) guidance, including PINS Advice Note 6 'Preparation and submission of application documents' (version 10).
