## 0. INTRODUCTION

### 0.1. OVERVIEW

0.1.1. This Application Document Tracker has been prepared on behalf of the Applicant to support an application for a Development Consent Order (DCO) for the Cory Decarbonisation Project ('the Proposed Scheme') that has been submitted to the Secretary of State (SoS) for Energy Security and Net Zero (DESNZ) under section 37 of the Planning Act 2008 (PA 2008).
