Uh, I'm speaking on behalf of the Ridgeway users, um, and Djokovic, uh, an investigative journalist and documentary Filmmaker who's been working with, uh, with our group.

Um, we've also submitted, um, written representations. Um, mainly, uh, from a Richmond user called Scott Burrell, who's a member of the Romany community and a historian as well. And that focused on, uh, was it, uh, telling the story from their point of view? But I would also like to add some points from, uh, from the Ridgeway users as a, as a whole. Um, so just saying that, um, the Ridgeway, um, nature reserve is a really valued, um, local site, um, and nationally, uh, valuable site for biodiversity.

Um, in fact, it's only probably one of 4 to 5 sites now in the whole of the country. Um, where the show cannot be, is is found. Um, I mean, you know, being a local resident. Um, Thamesmead has a reputation for, for many things. Um, mostly bad. Um, but, you know, few people know it for this, uh, important, uh, nature reserve and this important area for, for for national, uh, biodiversity.

Um, with this in mind, the Ridgway users actually, uh, had been working with a number of stakeholders, including Bumblebee Conservation Trust, uh, and experts from the University of East London, to try and preserve and supplement this habitat for pollinators. Um, this was funded through a mayor of London grant, uh, last year, where we actually created a Thamesmead pollinator corridor, um, to try to encourage, uh, these pollinators.

Uh, my main point about this proposal is that, uh, uh, it risks devastating this nature reserve, this, this area of, of natural biodiversity and the species that we're trying to protect, um, and which gives Thamesmead its uniqueness. Um, risk being gone forever. Um, and that's my, my main point around, you know, the effect on biodiversity. My second point is around, um, was it, um, the current structure of the testing regime? Um, in relation to the quarry field site? Um, especially around forever Chemicals.

Uh, earlier this year, we've with Jay Djokovic. Um, we conducted a, uh, sampling of, uh, water. Uh, from the ditches that are joined quarry site. Um, which, uh, in our official, in our correspondence with, uh, Corey suggested where there, uh, some of the water outflows from their site went to, um, we found the presence of forever chemicals. Name is known as PFAS. Uh, to be detectable at concentrations around 59.1 nanograms per liter, and with several breaching the individual ten nanograms per liter.

Um suggested by the Royal Society of Chemistry. Um, this is the single highest concentration in a in a water sample found in the London area. Um, and we know that, you know, we didn't actually test the soil. And so it was actually meant to have higher levels. Um, we suggest that, uh, um, this is an important, uh, finding from, uh, um, both a planning, um, was it, uh, consideration which hasn't been taken into account? Um, and we suggest that, um, you know, going forward, um, as it's, uh, Corey may want to test for PFAS, um, as part of their, their application.

Nothing. Mr. James Hewitt, I've no affiliation. Um. Government policy. Respect that. However, the policy, I understand, um, requires that at least 90% of the CO2, the post combustion CO2 is captured.

That's implicit. In fact, governments have been taken to judicial review on a couple of occasions and found that their plans, um, ought to be requiring this, and they're not actually very practical. Um, when it comes to the carbon capture rate of an an energy from waste facility. The material that is going into the furnaces is a variable quality that makes it extremely difficult to make the capture rate to optimize the capture rate.

When they say 90%. Mr. Djokovic earlier today mentioned Petro Nova in the states. Um, the only other one that's a post combustion, um, is the the boundary down in Saskatchewan and that's even poorer, um, capture rates. Um, with this, I believe it'll be even less in order to raise the level of capture up to a higher amount, you're going to have to be spending a lot more money with the amines and the recovery of them.

Um, and that will require a great deal more energy. The amount of energy being produced by Riverside one is about 70MW. If they're lucky. Um, if the, um, the carbon capture recovery facility requires 50, you're not going to get very much to dispatch to the general public or whoever it is that is buying them. The people who would be buying that electricity are no longer going to be able to do so, because the energy will be used in reclaiming the solvent.

They will then have to obtain the electricity from somewhere else. It'll be from a gas fired power station, or one which is even dirtier, um, from a wood burning power station. Um, those CO2 emissions ought to be included, in my opinion, in the calculations of the benefits of the scheme.

Another matter. Um, the period of depreciation of the Riverside one in their annual accounts is about 25 years. The way in which the carbon benefits to the scheme, um, have been assumed or estimated is between 50 and 55 years, which is twice as long.

So the benefits would seem to be twice what they might be.

The I will mention is probably as well in my written representations. Um, the amount of plastic in the, um, the feedstock for the incinerators, um, may well reduce because the emissions trading scheme coming into effect in January 2028, I believe it is, um, will tend to make it more costly for people to be, um, using plastic and sending it to the incinerator. They may pass the price back to the local authorities.

Who have no, um, capacity to manage the waste, to just. They were obliged to get rid of the waste the people have. Um.

Otherwise, they're getting, um, the money which they've given will have to be clawed back.

So in summary, I believe that, um, there isn't a hole in the ground where they can actually put the CO2. The, um, the infrastructure is not yet there. Whether it's in the Viking field. The endurance field were in high net where there already is a proposal. In fact, the government has agreed to subsidize. I think it's Protoss, which is at a smaller carbon capture facility, which is only just been thought about on a new energy from waste facility, and that the scale of that is about half as much as the riverside one.
