1.1 Introduction

- 1.1.1 As described throughout each of the ES Chapters [**Application Document Reference 6.2**] there are no instances where the environmental effects associated with the Proposed Project may be of such a magnitude as to warrant additional mitigation measures. These are measures which would be deemed necessary to minimise environmental impacts during the operation, construction and/or maintenance phases of the Proposed Project if they were required.
- 1.1.2 This Schedule of Environmental Commitments (**Table 1**) presents the industry standard mitigation required above the measures already specified in the Consented Development's Construction Environmental Management Plan (Appendix 2A [**Application Document Reference 6.4.3 – Existing CEMP for Consented Development**]) and any additional mitigation measures or enhancement measures identified in this ES.
