In respect of the Adequacy of Consultation, Spelthorne Borough Council have been aware of the project since last year. The consultation report (Doc 5.1) indicates that a letter and USB were sent to the Borough Council on 3 May 2022 however the Strategic Planning Team, who have been engaged in this project since last year, have not had sight nor hold a record of having received this. It may be that this was held by a different department in the Borough Council however initial requests to establish if this is the case have not as yet turned up that this information has been received. It is therefore not possible to explicitly state that the applicant has not complied with the relevant acts in regard to the consultation process aside from not having had sight of the letter and accompanying USB from 3 May.
