EN010129 – SLOUGH MULTIFUEL EXTENSION PROJECT

APPLICANT'S DEADLINE 2 SUBMISSION

I write on behalf of the Applicant, SSE Slough Multifuel Limited, to provide its Deadline 2 submission in respect of the Examination of the Slough Multifuel Extension Project Development Consent Order (DCO) application.

The Deadline 2 submission comprises the following documents:

1. Document Ref. 2.1, Rev. 3.0 – Application Guide – The Applicant has provided an updated Application Guide to take account of the updated and new documents being submitted at Deadline 2. Updated and new documents are highlighted yellow within the document.
2. Document Refs. 7.3.1, 7.4.1, 7.9.1, 7.10.1, 7.14 and 7.14.19.1 – Historic TCPA Permissions – The Applicant has provided additional documents and plans relating to the Consented Development as requested by the Examining Authority ('ExA').
3. Document 8.1 – Statement of Common Ground ('SoCG') with Slough Borough Council ('SBC') – A signed SoCG that has been agreed between the Applicant and SBC.
4. Document Ref. 8.2 – SoCG with the Environment Agency ('EA') – A signed SoCG that has been agreed between the Applicant and the EA.
5. Document Ref. 8.3 – SoCG with Natural England ('NE') – A signed SoCG that has been agreed between the Applicant and NE.
6. Document Ref. 9.2 – Applicant's Responses to the ExA's First Written Questions (EXA1).
7. Document Ref. 9.3 – Section 106 Supplemental Deed of Variation.

In response to a number of the ExQ1s (see Document Ref. 9.2) regarding the drafting of the draft DCO ('dDCO'), the Applicant has explained that it can provide alternative drafting in the event that it would assist the ExA (noting that these responses also explain why in these particular cases the Applicant considered the existing drafting is more appropriate than any alternative). The Applicant requests that the ExA provide confirmation as to whether alternative drafting in respect of the following points would be of assistance. If so, the Applicant can incorporate the alternative drafting, for comparison purposes, within its revised dDCO which will be submitted at Deadline 3. The ExA is directed to the Applicant's responses to ExQ1 1.2.2, 1.2.4 and 1.2.6 in which possible alternative drafting is explained.

The Applicant has prepared draft SoCG with Royal Mail Group Limited and SEGRO and is in dialogue with these parties. The Applicant intends to submit the SoCG with these parties at Deadline 3.
