APPLICANT'S DEADLINE 3 SUBMISSION

I write on behalf of the Applicant, SSE Slough Multifuel Limited, to provide its Deadline 3 submission in respect of the Examination of the Slough Multifuel Extension Project Development Consent Order (DCO) application.

The Applicant has also attached the validation report and validation success email for the updated draft DCO.

In its cover email at Deadline 2 [REP2-001], the Applicant explained that it could provide alternative DCO drafting at Deadline 3 in the event that it would assist the ExA to be provided with alternative drafting for comparison purposes. The Applicant directed the ExA to its responses to ExQ1 1.2.2, 1.2.4 and 1.2.6 in which possible alternative drafting is explained (although the Applicant's responses also explain why the Applicant considers the existing drafting to be more appropriate than any alternative). As the ExA has not indicated that alternative drafting would be of assistance, it has not been provided at Deadline 3. However, should the ExA consider this to be useful then the Applicant can provide such drafting at Deadline 4.

I would be grateful if you could confirm receipt of this email and the attachments.
