"1. Taking into account new information received during our meeting on 28 March 2023 and set out in your email of 29 March 2023 together with information on current traffic conditions in Slough from Royal Mail's local Operational Managers, Royal Mail has decided to withdraw its Deadline 2 representation.

2. In view of Requirements 3(b) and 4 of the draft DCO requiring the proposed works to be constructed in accordance with the approved Construction Environmental Management Plan (CEMP) dated April 2020 and the appended Construction Traffic Management Plan (CTMP), Royal Mail is content to rely on the provisions of the CEMP as approved by Slough Borough Council and also on the Section 106 Agreement dated 4 May 2017 in relation to the routing for operational traffic and the cap on HGV movements.

3. Royal Mail wishes remain as an IP to the Examination."

Royal Mail has also confirmed that it does not consider a SoCG is necessary. The Applicant agrees with Royal Mail's position on the SoCG.
