# Marine and Water Environment: Outer Dowsing Offshore Windfarm.

The Danish law regarding marine strategy (Ministerial order LBK no. 1161 of 25/11/2019) implements essential parts of EU's Marine Strategy Framework Directive (MSFD) with the purpose to ensure healthy marine environments in marine areas of the member states. The MSFD requires EU member states to achieve and maintain good environmental status (GES) by the year 2020, which is determined over a number of descriptors (e.g. biodiversity, food webs, seafloor integrity, alterations of hydrography, contaminants, energy and noise).

The Danish law regarding marine strategy covers all Danish waters including seabed and underground of territorial waters and exclusive economic zones. In relation to the MSFD, the Danish Environmental Protection Agency has no remarks to the transboundary scoping consultation of the Proposed Outer Dowsing Offshore Wind. As long as activities and potential cumulative effects related to Outer Dowsing Offshore Wind do not compromise achieving and maintaining GES under the MSFD, the Danish Environmental Protection Agency has no further remarks.
