ollowing the notice, the Applicant undertook consultation in accordance with the Planning Act 2008 and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 in June and July 2023 ("Statutory Consultation").

In considering responses to the Statutory Consultation, through ongoing design development, and through the Offshore Transmission Network Review process, there have been a number of changes and refinements to the Project. To ensure that all parties with an interest in the works and/or land are consulted on these changes to the Project, the Applicant is now undertaking further statutory consultation to ensure that any persons with an interest in such changes are duly consulted with (the "Further Statutory Consultation")

The proposed DCO would, among other things, license and authorise

- Up to 100 offshore wind turbines and their foundations with a maximum tip height of 403m above lowest astronomical tide and a maximum rotor diameter of 340m;
- Up to two large or up to four small offshore transformer substations and their foundations within the array area; Up to one offshore accommodation platform and its foundations;
- Up to two offshore HVAC reactive compensation platforms and their foundations within the offshore cable route
- A network of subsea cables connecting the wind turbines, offshore transformer substations and offshore accommodation platform;
- Up to four offshore subsea export cable circuits to bring electricity from the offshore transformer substations to landfall, located at Wolla Bank, south of Anderby Creek;
- Works at landfall to connect the offshore export cable circuits to the onshore cable circuits, crossing underneath the beach and including transition joint bays
- Up to four underground cable circuits approximately 80 km in length, with joint bays, link boxes and/or earth pits, commencing at the landfall and running in a south westerly direction to an onshore substation in the vicinity of Surfleet Marsh/Weston Marsh:
- A new onshore substation in the vicinity of Surfleet Marsh/Weston Marsh;



Israeli coalition ready to invade

Netanyahu forms war government Troops expected to cross into Gaza next week BA suspends flights over rocket fear

Israel united around a new government last night as it prepared for an invasion of Gaza, expected as early as next week.

Binyamin Netanyahu, whose efforts to form a stable cabinet have almost torn the country apart in the past two years, will be joined by Benny Gantz, a former general turned opposition leader, and Yoav Gallant, the defence minister, at the head of the government.

The new coalition is a resumption of Israel's historical secular norm: politicians and former generals with a range of views prepared to adopt a common stance against military foes. Last year Gantz and other centre-left leaders refused to join a coalition with Netanyahu, who was forced to join with hardright and ultra-religious parties.

As Gantz changed course, the army declared the area around Gaza a no-go zone for non-military personnel. The Israeli military said hundreds of thousands of troops had assembled around the enclave, "ready to execute the mission we have been given".

Last night Netanyahu gave a tele-

vised address in which he said Israel was on the attack. "Every member of Hamas is a dead man," he added.

Tanks have been heading into the area for days, with soldiers expecting an order to go into Gaza as soon as the new cabinet has reviewed updated plans.

The strip is already buckling under the stress of continuous bombardment and a lack of power, water and other essentials amid Israeli retaliation for an assault launched by Hamas terrorists on Saturday

The development came as:

• Palestinian rocket attacks and Israeli airstrikes continued for a fifth day, with casualties rising on both sides: 1,200 Israelis are confirmed to have died and 1,100 have died in Gaza, including more than 300 children.

● The King condemned the "acts of terrorism" inflicted on Israel.

 Seventeen British citizens were said to be dead or missing, with Jake Marlowe, 26, who worked at the Supernova music festival, confirmed dead.

 James Cleverly, the foreign secretary. made an unannounced visit to Israel but had to take cover as sirens sounded during a meeting with his counterpart. British Airways suspended flights to and from Israel after one of its planes heading to Tel Aviv turned back to Heathrow following a report that Hamas had fired rockets towards Ben Gurion airport.

• Air raid warnings forced millions of residents to take shelter in northern Israel, after suspected aerial attacks from Lebanon raised fears of the conflict spilling over on to a second front. However, the alerts were later attributed to a "malfunction".

Last night Hamas continued to hold up to 150 people hostage after seizing them at the weekend. Qatar has been called in by western allies to try to negotiate the release of women and children, regional diplomats told The Γimes. The proscribed terrorist group is believed to want to hand some hostages back in return for the release of Palestinian women prisoners in Israeli jails.

However, there is unlikely to be time for detailed negotiations, nor is any attempt likely to be made to free dozens of hostages by force before a full-scale ground assault.

Israeli airstrikes have already destroyed about 1,000 buildings across the small enclave, from Gaza City and Beit Hanoun in the north to Khan Younis in the south. The towns were Continued on page 2

Rapists will go free as judges are told that prisons are full

Convicted rapists and burglars will be free to walk the streets from next week because the country's prisons are full. Lord Justice Edis, the senior presid-

ing judge for England and Wales, has ordered crown court judges to delay sentencing hearings for criminals who are on bail. It means convicted offenders, including some who have committed serious crimes, will be temporarily

The Times also understands that some prisoners will be released early under plans drawn up by justice ministers, which could start as soon as next week

In an online meeting between Edis and senior judges, it emerged that suspects who are accused of the most serious crimes and remanded in custody are to be held in magistrates' court cells.

One senior crown court judge told

The Times that from Monday, judges have been "ordered/strongly encouraged" not to send to prison a defendant

who appears before them on bail, so as not to add to the prison population.

The judge said: "We have been told that this is a 'short-term measure', but nobody knows what that means."

The judge added the "biggest con

The judge added the "biggest concern" was defendants charged with historical rape or rape of a child and other sexual assault, as even if convicted they were now likely to remain on bail. "What am I going to do if a jury finds someone guilty [of rape]," the judge said, adding: "Do I release that person who is now convicted back into the community, where the victim might see them? What will the victim think?

Figures from the Ministry of Justice showed that as of last Friday, the prison population in England and Wales was 88,016, just several hundred below the estate's capacity of about 88,670.

Ministry officials published a report this year predicting that the prison

population was likely to rise to 94,400 by spring 2025. The report noted that there was "considerable uncertainty around how the courts will recover Continued on page 2

THE EUROPEAN COMMISSION'S move to allow the consortia block exemption regulation to expire resolves a long-running dispute between carriers and their shipper and forwarder customers.

But it remains to be seen whether the result will be as positive for shippers as they had hoped for or whether the law of unintended consequences will apply.

Commission Regulation (EC) No 906/2009, commonly known as the consortia block exemption regulation, and its predecessors have provided a legal certainty that has allowed liner shipping companies to increase their service offerings and maximise their efficiency by sharing vessels.

The regulation sets a market share ceiling of 30%. Arrangements that fall within that threshold are automatically exempted from the bloc's competition regulation if they do not collude on prices, restrict capacity except to match demand, or allocate markets and customers between each other.

The current version dates to 2009, when the commission said it recognised the benefits of consortia in liner shipping as a means to bring rationalisation and economies of scale that helped to improve both productivity and the quality of available container line shipping services.

At its peak it covered around 60 consortia serving the EU trades. That number now stands at 43 but does not include the major east-west alliances that fell out of the scope due to their size and were covered by specific competition exemptions.
