1 Executive Summary

- This Consultation Report accompanies an application for a Development Consent Order (DCO) pursuant to section 37 of the Planning Act 2008 (hereafter referred to as the 2008 Act), which states that an application for a DCO must be accompanied by a Consultation Report, (as defined in section 37(7) of the 2008 Act.
- 2. GTR4 Limited (trading as Outer Dowsing Offshore Wind) (the 'Applicant') is proposing to develop Outer Dowsing Offshore Wind Farm (hereafter 'the Project').
- 3. If granted, the DCO would permit the Applicant to construct, operate and maintain, and decommission the Project i.e. an offshore generating station and associated and ancillary offshore and onshore development.
- 4. This Consultation Report has been prepared in accordance with section 37(3)(c) of the 2008 Act and follows relevant legislation and guidance including Department for Communities and Local Government (DCLG, 2015): Guidance on the pre-application process, the Infrastructure Planning (Application: Prescribed Forms and Procedure) Regulations 2009 as amended (the APFP Regulations) and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the EIA Regulations)
- 5. The Consultation Report demonstrates how the Applicant has complied with all relevant legislation and guidance and provides further details regarding non-statutory consultation undertaken for the Project.
- 6. The Applicant has sought to engage actively and openly throughout the pre-application consultation process by way of ongoing consultation with the community, Prescribed consultees, non-prescribed consultees, and statutory consultees.
- 7. This Consultation Report describes the consultation process that the Applicant has followed and demonstrates how the Applicant has had due regard to consultation feedback from prescribed consultees (being all applicable consultees listed in Schedule 1 of the APFP Regulations or by the Planning Inspectorate under Regulation 11(1)(c) of the EIA Regulations), statutory consultees (under sections 42(aa), (b) and (d) of the 2008 Act (including landowners and persons with an interest in land) stakeholders and members of the public at all stages of the design evolution.
- 8. This Consultation Report describes the consultation process that the Project has followed both in terms of the non-statutory 'informal' consultation and the statutory 'formal' consultation and publicity stages as required under sections 42, 47 and 48 of the 2008 Act.
- 9. In accordance with sections 42, 47 and 48 of the 2008 Act, the Applicant undertook pre application consultation on the Project ahead of submission of the DCO to the Secretary of State (SoS) with the following consultees:
 - Prescribed consultees (in accordance with section 42(1)(a) of the 2008 Act)
 - The Marine Management Organisation (MMO) (in accordance with section 42(1)(aa) of the 2008 Act)
 - Host and neighbouring local authorities (in accordance with section 42(1)(b) and section 43 of the 2008 Act).
 - Those persons that fall within the categories in section 44 of the 2008 Act (in accordance with section 42(1)(d) of the 2008 Act).



- Community and other organisations in the "vicinity" of the Project who may be affected both directly and indirectly by the Project (in accordance with the Statement of Community Consultation (SoCC) published under section 47 of the 2008 Act).
- Wider communities and organisations (in accordance with sections 47 and 48 of the 2008 Act).
- 10. The Applicant commenced regular meetings with the Lincolnshire County Council and kept in regular contact with the three host Local Planning Authorities (LPAs): East Lindsey District Council (ELDC), South Holland District Council (SHDC) and Boston Borough Council (BBC) through the South and East Lincolnshire Councils Partnership (S&ELCP) which represents these LPAs.
- 11. In accordance with section 47 of the 2008 Act, the Applicant consulted the relevant local authorities, the Planning Inspectorate and the MMO on the content of the SoCC as detailed in Sections 7 and 8 of this Consultation Report. In response to the comments received, the Applicant made changes to the SoCC as set out in Section 8.1 and Appendix 5.1.5. The SoCC was published on 21 October 2022 in accordance with section 47 of the 2008 Act.
- 12. Following feedback from the Phase 1 Consultation, the Project introduced an alternative cable route option and the SoCC was updated and the relevant authorities consulted. The Updated SoCC was published on 18 January 2022 in accordance with section 47 of the 2008 Act.
- 13. Full details of the community consultation undertaken in accordance with section 47 of the 2008 Act and the requirements as set out in the SoCC are detailed in Sections 8 and 9 of this Consultation Report.
- 14. Consultation occurred in five phases to enable the communication of and consultation on the project refinements made following feedback from previous phases of consultation as well as external project developments.
- 15. Table 1.1 below outlines the phases of consultation and where they are discussed in this Consultation Report.

- 16. 89As required under section 48 of the 2008 Act and Regulation 4 of the APFP Regulations, the proposed application for the Project was published in local and national newspapers, Fishing News (a commercial fishing publication), Lloyd's List, and the London Gazette as detailed in Section 9.1 of this Consultation Report.
- 17. An overview of the pre-application consultation process undertaken by the Applicant is shown in Figure 6 of this Consultation Report.
- 18. Extensive non-statutory consultation has taken place with technical consultees through the Evidence Plan Process (EPP) (see Appendix 6.1 Evidence Plan (document 6.1.6.1)) to inform the Environmental Impact Assessment (EIA) process and to identify key impacts, constraints, and design changes.
- 19. As detailed in Section 7, 8 and 10 of this Consultation Report, the Applicant held a series of stakeholder meetings with elected members and interest groups, including:
 - Establishing four Community Liaison Groups (CLGs) with locally elected members and appointed community representatives; and
 - Engaging with elected members and parish councils through a series of bespoke meetings and presentations.
- 20. A summary of the key comments raised through consultation which have influenced the design of the Project and resulted in change to the onshore Project parameters from scoping through to PEIR and the final DCO application is presented in Plate 1.1 and Table 1.1 below.
- 21. Refinements to the offshore Project parameters were not a central focus of the public consultation carried out under section 47 but addressed by a number of statutory consultees both through bilateral engagement, the EPP and consultation carried out under section 42. A full list of consultation responses and how the Applicant has had regard for these is detailed in Appendix 5.1.4. Key refinements included:
 - The reduction of the northern and western boundaries to reduce impacts to shopping and navigation users
 - Further engineering has been undertaken to minimise impacts to sandbanks within the IDRBNR Special Areas of Conservation (SAC) including commitments to the use of removeable cable protection if any is required over sandbank features
 - Commitments to micrositing infrastructure where practicable to avoid areas of Annex I reef
- 22. The Applicant's response to feedback is summarised and provided in full in the following sections and annexes of this Consultation Report:
 - Section 9: includes a summary of key topics raised during the project's five consultation phases.
 - Appendix 5.1.4: Consultation Responses for all comments received to the section 42 and 47 consultation and commentary on how the Applicant has had regard to the response.



- 23. The Project plans have evolved iteratively in response to feedback received throughout the pre-application consultation with the community, prescribed consultees, statutory consultees and other stakeholders. This Consultation Report details the multiple stages of this process and the Project's reactiveness in response to this.
- 24. In October 2021, the Applicant appointed a Community Liaison Officer (CLO), Andrew Acum, whose role was to act as an independent link between the Project and the local community.
- 25. The CLO's role involved, but was not limited to:
 - Receipt and management of stakeholder enquiries via email and telephone.
 - Establish and management of relationships with key local stakeholders through ad hoc meetings upon request, along with meetings through established working groups (as set out in Section 8).
 - Site visits and information gathering along the onshore ECC.
 - Distribution of project materials to stakeholders, upon request.
 - Proactive engagement with key stakeholders, through phone calls and emails.
 - Local capacity to respond quickly to stakeholder concerns, including follow up with face-to-face interaction where required.
 - Distribution and placement of local information event posters and advertising.
 - Attendance at all virtual and in person public information events.
 - Design and production of materials for Public Information Day (PID) events and logistical support during events.
 - Secretariat function for the Community Liaison Groups (CLG); and
 - Design and maintenance of website and social media channels.





2 Introduction

2.1 The Applicant

26. The Applicant is GTR4 Limited, a joint venture between Corio Generation (a Green Investment Group (GIG) portfolio company), TotalEnergies (a global multi-energy company) and Gulf Energy (one of Thailand's largest private power producers) together trading as Outer Dowsing Offshore Wind (ODOW).

2.2 Consultation Report Purpose

- 27. This Consultation Report describes the consultation undertaken for the Project and demonstrates compliance with the consultation requirements set out in the 2008 Act, other relevant legislation and statutory guidance.
- 28. This document details stakeholder responses which have come out of the consultation and how these responses have been taken into account, including where this has influenced design and decision-making processes.
- 29. The Applicant has sought to engage actively and openly throughout the pre-application consultation process with the community, statutory and non-statutory consultees, and persons with an interest in land. This Consultation Report has been structured as follows to reflect the phases and timeline of the consultation to best communicate how the design of the Project and the development of the application has progressed in line with the feedback received from our stakeholders:

- 30. Summaries of key themes and responses the Project has received throughout the pre-application phase, and how these have been addressed is included in the relevant subsections of this document. Mitigation measures agreed with statutory consultees will be detailed in the Schedule of Mitigation (document reference 8.13) which is submitted as part of the DCO application.



3 Project Background

3.1 The Project

- 31. The Project is a proposed offshore windfarm located approximately 54km off the coast of Lincolnshire, England. The Project comprises an offshore generating station that can generate up to 1.5 gigawatts (GW) of energy and covers an area of seabed of approximately 436km². The Project will require both offshore and onshore infrastructure to transmit the power generated by the turbines to an onshore substation and subsequently into the National Grid Transmission System. Full details on the Project design can be found in ES Volume 1 Chapter 3 Project Description (document reference 6.1.3).
- 32. The Project includes an offshore generating station that will have a proposed capacity in excess of 100 megawatts (MW). Therefore, under section 15 of the 2008 Act it is classified as a Nationally Significant Infrastructure Project (NSIP). As such, the Project must apply for a DCO to build and operate the Project. The DCO process was created to streamline the consenting of large infrastructure projects and to ensure transparency and public participation.

3.2 Early Project Definition, Site Selection and Refinement

- 33. The Project's application boundaries (known as Order Limits) are presented in the Location Plan -Onshore (document reference 2.3) and the Location Plan- Offshore (document reference 2.4)
- 34. The offshore Order Limits include: the offshore wind farm Array Area ; the offshore export cable corridor (offshore ECC); the export cable landfall on the Lincolnshire coast to mean high water springs (MHWS) (Landfall)), up to two Offshore Reactive Compensation Platforms (ORCPs) and may include if required Artificial Nesting Structures (ANSs) and biogenic reef compensation areas, the onshore export cable corridor (onshore ECC), onshore substation (OnSS), the 400kV cable corridor and associated development and ancillary works.
- 35. The location for the Project's array area was selected through the consideration of various environmental, engineering and technical constraints.
- 36. The Project's onshore proposals were developed following publication of the preliminary results of the Offshore Transmission Network Review (OTNR) Holistic Network Design (HND) document "The Pathway to 2030 Holistic Network Design" in July 2022 which identified two potential grid connection options for the Project. Further information on the OTNR process is provided in ES Volume 1, Chapter 4: Site Selection and Consideration of Alternatives (document reference 6.1.4).
- 37. The Project's grid connection was confirmed in August 2023 (Annex 5.1.10H), however all consultation prior to this announcement (including the Phase 2 Consultation) encompassed both of the proposed connection options. The adopted route and substation location were consulted on as part of the Autumn Consultation (Section 9.6).
- 38. Further details on defining both the onshore and offshore Order Limits including the array area, offshore ECC, Landfall, onshore ECC and Onshore Substation Location are detailed in ES Volume 1, Chapter 4: Site Selection and Consideration of Alternatives (ES document 6.1.4). The consultation that has been undertaken by the Project that has informed the iterative design process of the Project is summarised in this Consultation Report.



4 Consultation- Legislation, Policy and Guidance

- 39. This Consultation Report has been produced as part of the suite of documents prepared for the Project's DCO application in accordance with Section 37(3)(c) of the 2008 Act.
- 40. Details on the 2008 Act, National Policy Statements and EIA Regulations as well as other guidance that has informed the Project's consultation is outlined in ES Chapter 2: Need, Policy & Legislative Context (document reference 6.1.2).

4.1 General Data Protection Regulation (GDPR)

- 41. The Applicant uses a secure GDPR compliant stakeholder engagement and management system to support in the planning, engaging, and measuring of communication with stakeholders, to safeguard personal information.
- 42. Privacy notices were included in consultation communications and personal data has been redacted and/or anonymised in line with the outlined approach in this report and the appendices.
- 43. Establishing constructive and trusted relationships with all stakeholders is central to the Project's consultation principles and approach.

4.2 Statutory Consultation Requirements under the 2008 Act

- 44. A detailed checklist setting out how the Project has complied with the statutory consultation requirements and guidance under the 2008 Act as well as other relevant legislation and guidance is included in Appendix 5.1.1.
- 45. As the Project is defined as an NSIP, the Project must undertake pre-application consultation in accordance with the requirements of the 2008 Act. As the development is EIA development (as discussed further in section 4.4) the Project must also ensure that it complies with the consultation requirements under the EIA Regulations.
- 46. The relevant sections of the Planning Act 2008 in relation to pre-application consultation are:
 - Section 42 Duty to consult;
 - Section 43 Local authorities for the purpose of section 42(1)(b);
 - Section 44 Categories for purposes of section 42(1)(d);
 - Section 45 Timetable for consultation under section 42;
 - Section 46 Duty to notify the Secretary of State of proposed application;
 - Section 47 Duty to consult local community;
 - Section 48 Duty to publicise;
 - Section 49 Duty to take account of responses to consultation and publicity; and
 - Section 50 Guidance about pre-application procedure.



4.3 National Policy Statements

- 47. The relevant National Policy Statements (NPS) which form the primary national policy documents for Secretary of State decision-making in relation to NSIPs are listed below. These documents encourage applicants to carry out pre-application consultation with a range of stakeholders.
 - EN-1 Overarching NPS for Energy, November 2023
 - EN-3 Renewable Energy Infrastructure, November 2023; and
 - EN-5 Electricity Networks Infrastructure, which covers the electrical infrastructure in conjunction with EN-1, November 2023
- 48. Details of the Applicant's compliance with the relevant NPS is set out in Chapter 2, Need, Policy and Legislative Context (document reference 6.1.2) and the Planning Statement (document reference 9.1).

4.4 EIA Regulations

4.4.1 Environmental Statement (ES)

- 49. The Project notified the Secretary of State under Regulation 8(1)(b) that it proposes to provide an Environmental Statement (ES) in respect of the proposed Development. Therefore, in accordance with Regulation 6(2)(a) of the EIA Regulations, the proposed Development is EIA development.
- 50. An ES presenting the findings of the EIA has been submitted alongside the DCO application. A Scoping Report (Annex 5.1.2A) was submitted to the Planning Inspectorate on 01 August 2022.
- 51. The Planning Inspectorate reviewed and consulted on the EIA Scoping Report and published a Scoping Opinion on 09 September 2022 which is included as Annex 5.1.2B.
- 52. The Project has taken due consideration of the comments from the Planning Inspectorate given within the Scoping Opinion and also notes the comments provided by the statutory consultees in Appendix 2 of the Scoping Opinion. Both the Scoping Opinion and the comments from the consultees provided throughout the consultation phases have been considered in undertaking the EIA and in preparing the ES. The comments received and how these have been addressed are outlined in the relevant chapters of the ES.

4.5 Habitats Regulation Assessment (HRA)

- 53. The Project has been required to undertake a Habitats Regulation Assessment (HRA) in accordance with section 63(1) of the Conservation of Habitats and Species Regulations 2017. Further details on the HRA process are set out in the Report to Inform Appropriate Assessment (document reference 7.1) HRA Screening Report (document reference 7.2) and the Need, Policy and Legislative Context chapter of the ES (document referent 6.1.2).
- 54. The HRA process was a key topic covered in the Expert Topic Groups (ETGs) and EPP process including identification and prioritisation of HRA matters and discussions on how these should be addressed in the Applicant's application.
- 55. Full details of consultation on HRA and Compensation is set out in the Evidence Plan Report (Appendix 5.1.15) and Section 9.10 below.



4.6 Transboundary Consultation

- 56. Transboundary effects arise when impacts from the development within one European Economic Area (EEA) state affects the environment of another EEA state(s). The need to consider such transboundary effects has been embodied by the United Nations Economic Commission for Europe Convention on EIA in a Transboundary Context (commonly referred to as the 'Espoo Convention'). The Convention requires that assessments be extended across borders between Parties of the Convention when a planned activity may cause significant adverse transboundary effects.
- 57. The Espoo Convention has been implemented in the UK for the purposes of NSIPs by the EIA Regulations. Regulation 32 of the EIA Regulations sets out the obligations on the Secretary of State to notify and consult EEA State(s) that may be affected by a development that is likely to have significant transboundary effects. Table 4.1 below sets out the approximate distances of the Project from the Exclusive Economic Zone (EEZ) boundaries of the other EEA states that share a maritime border with the UK.

- 58. A transboundary screening process was carried out and was submitted as Annex A (Transboundary Screening Matrix) to the Scoping Report (Annex 5.1.2A). This report concluded that only particular offshore technical aspects could result in transboundary effects, namely marine mammals; offshore and intertidal ornithology; commercial fisheries; shipping and navigation; and aviation, radar, military and communication. Each of these technical assessment chapters includes details of such potential transboundary effects.
- 59. The Planning Inspectorate undertook a transboundary consultation with the relevant EEA states. Copies of the responses received during this consultation are included as Appendix 5.1.19. In addition to this preapplication consultation, statutory transboundary consultation will be undertaken by the Planning Inspectorate in accordance with Regulation 32 of the EIA Regulations, if and when it accepts the Applicant's application for a DCO.

4.7 Planning Inspectorate Advice Notes

- 60. The Planning Inspectorate has published a series of advice notes in relation to NSIPs. The advice notes are non-statutory but provide advice and information on a range of issues arising throughout the duration of the application process.
- 61. The Project's approach to consultation has been informed by a number of the Planning Inspectorate's advice notes, with particular reference to:
 - Advice Note 3: EIA consultation and notification (August 2017);



- Advice Note 7: Environmental Impact Assessment: Preliminary Environmental Information, Screening and Scoping (June 2020);
- Advice Note 10: Habitat Regulations Assessment (HRA) relevant to Nationally Significant Infrastructure Projects (August 2020);
- Advice Note 11: Working with public bodies in the infrastructure planning process (November 2017); and
- Advice Note 14: Compiling the Consultation Report (February 2021).



5 Pre-Application Guidance issued by the Secretary of State (section

- 50)
- 62. Section 50 of the 2008 Act provides that the Applicant must have regard to any guidance issued by the Secretary of State (SoS) on how to comply with the pre-application procedure set out in the 2008 Act. The Department for Communities and Local Government (DCLG) issued guidance on the pre-application process under the Planning Act 2008 in 2015 which sets out expectations for pre-application consultation. Where this cannot be complied with the applicant is expected to provide an explanation.
- 63. An outline of how the Applicant has complied with the guidance is provided in Appendix 5.1.1.



6 Early Adopters Programme (EAP)

- 64. The Project volunteered to take part in the Early Adopters Programme (EAP) launched by the Planning Inspectorate to trial potential components of a future enhanced pre-application service.
- 65. As part of the Project's participation in the EAP, the Project has trialled the use of Pre-application Principal Areas of Disagreement Summary Statements (PADSS) as set out in section 6.1 below.

6.1 **Principal Areas of Disagreement Summary Statements (PADSS)**

- 66. The Project has worked proactively to frontload stakeholder engagement and facilitate constructive discussions with the Planning Inspectorate, statutory and non-statutory stakeholders through throughout the pre-application process and before participation in the EAP commenced.
- 67. Due to the considerable overlap between topics covered in the ETGs, issues trackers being developed through the ETGs, and eventual SoCGs specific stakeholders were invited to participate in the PADSS trial. These stakeholders were selected to reduce overlap with the issues trackers being developed with a couple of stakeholders being invited to participate in both.
- 68. If the application is accepted for examination, subject to the discretion of the Examining Authority, the Project will continue to engage with stakeholders to update the PADSS throughout the pre-examination and examination stages of the process where issues remain.
- 69. Table 6.1 sets out the stakeholders who have submitted a PADSS to the Applicant for inclusion in the DCO application. PADSS that have been received through this process are included in Appendix 5.1.16.

72. The Project's consultation with the local county council, host and neighbouring local authorities on the SoCC is outlined in Section 8 of this document.



- 73. The Project subsequently commenced monthly meetings with Lincolnshire County Council (LCC) and hosted both introductory and follow up meetings with the host local authorities (Category B) via the South & East Lincolnshire Councils Partnership (S&ELCP). The S&ELCP is comprised of Boston Borough Council (BBC), East Lindsey District Council and South Holland District Council. Following the initial introductory meetings, a main Point of Contact (POC) was appointed to act on behalf of all three district councils.
- 74. The case officers assigned for each of the councils as well as appointed POC were also invited to sit on the relevant ETGs established as part of the EPP process as described in Section 9.8.
- 75. Ongoing meetings were established to provide updates to the councils regarding the development of the Project's proposals, provide a forum for questions and invite discussion on various aspects of the project's proposals.

8 Statement of Community Consultation (SoCC)

8.1 Consultation on the draft SoCC

- 80. In accordance with section 47 of the 2008 Act the Applicant developed a Statement of Community Consultation (SoCC) in consultation with the relevant local authorities, LCC, MMO & PINS which was published in October 2022. The relevant local authorities were identified as outlined in section 7 of this report above as those falling under section 43 (1) of the 2008 Act.
- 81. Consultees were given 28 days to provide comments on the draft SoCCs, therefore complying with the statutory consultation period set by section 47 of the 2008 Act.
- 82. Following receipt of comments from consultees, a second draft of the SoCC was prepared by the Applicant, and consultees were given a further 28 days to provide comments on the draft SoCC, therefore complying with the statutory consultation period set by section 47 of the 2008 Act.
- 83. The SoCC explained how the Applicant intended to consult with local communities on the Project as required under the Planning Act 2008.
- 84. The SoCC was subsequently updated following the introduction of an additional phase of consultation (Phase 1A) which introduced an alternative onshore cable route option into the Applicant's proposals following feedback from the community and local stakeholders received during the Phase 1 Consultation events. Further details on the Phase 1 Consultation events are outlined in section 9.3 of this report.
- 85. A draft of the updated SoCC was consulted on with the same consultees consulted on the first SoCC. Consultees were given 28 days to provide comments on the draft SoCC, therefore complying with the statutory consultation period set by section 47 of the 2008 Act.
- 86. Table 8.1 below reflects the responses received during the SoCC consultation and the Applicant's corresponding response and/or update.
- 87. Copies of the draft and final versions of the original and updated SoCC are included in Appendix 5.1.5 together with copies of the formal notices that were used to advertise the ODOW SoCC as outlined in Table 8.3 below.




Plate 8.1 Stakeholder consulted on the Draft SoCC

- The offshore environment including consultation with the Marine Management Organisation (MMO) and commercial fisheries organisations;
- Short-term and temporary impacts during construction, such as traffic movements, local amenities and the environment; and
- Long-term operational considerations, such as on the local environment, landscape and visual amenity.
- **100.** These topics underpinned each phase of consultation where feedback was sought on a variety of themes including each of the onshore elements of the Project and how the Project could help deliver positive environmental change in the local area. Additionally, the Applicant presented the reasoning for the selection of Wolla Bank at landfall. Full details of each consultation are outlined in Section 9 below.

9 **Pre-Application Consultation Phases**

9.1 Summary of Statutory Compliance

9.1.1 Section 42

- 102. Under Section 42(1) of the 2008 Act the Applicant must consult the following parties on the proposed application:
- (a) such persons as may be prescribed
- (aa) the MMO, in any case where the proposed development would affect or be likely to affect any of the areas specified in subsection (2).
- (b) each local authority that is within section 43
- (c) the Greater London Authority if the land is in Greater London, and
- (d) each person who is within one or more of the categories set out in section 44
- 103. The Project falls within multiple of the categories set out in subsection (2) of section 42 and therefore the Applicant has included the MMO as a consultee.
- 104. In relation to section 42(1)(a) the Applicant consulted all prescribed consultees defined as statutory consultees under Schedule 1 of the APFP Regulations and by the Planning Inspectorate under Regulation 11(1)(c) of the EIA Regulations. The Applicant has carried out multiple phases of consultation under section 42 of the 2008 Act and therefore how consultees have been identified in respect of each phase is outlined in the respective sections below.
- 105. In addition to the prescribed consultees identified, the Applicant has consulted a further number of non-prescribed consultees on the basis of their interest in the proposed application.
- 106. In respect of section 42(1)(b), the local authorities falling within section 43 are defined and outlined in section 7 above. Section 42(1)(c) is not relevant to the Project as the proposed application will not affect any land within Greater London.
- 107. Identification of parties falling within the categories set out in section 44 and therefore included as section 42 consultees under section 42(1)(d) is outlined in relation to each phase below.
- 108. Appendix 5.1.3 lists all of the section 42 consultees that have been consulted in respect of the proposed application.

9.1.2 Section 44

- 109. The Applicant is required under section 42(1)(d) of the 2008 Act to consult with the relevant persons defined in section 44 of the 2008 Act ('the section 44 consultees').
- 110. Section 44 consultees were broadly defined as:

a person that is an owner, lessee, tenant or occupier of the land; is interested in the land or has power to sell and convey the land, or to release the land; or is entitled to make a relevant claim if the order sought by the proposed application were to be made and fully implemented.

111. A relevant claim under section 44 means:

(a) A claim under section 10 of the Compulsory Purchase Act 1965 (compensation where satisfaction not made for the taking or injurious affection, of land subject to compulsory purchase)

(b) A claim under Part 1 of the Land Compensation Act 1973 (compensation for depreciation of land value by physical factors caused by use of public works)

(c) A claim under s152(3) of the 2008 Act (any person whose land is injuriously affected by the carrying out of the works)

112. Below sets out the categories of section 44 consultees as identified under the 2008 Act.

113. The Applicant sought to identify section 44 consultees by diligent inquiry before the statutory consultation which is fully detailed within the Land Referencing Methodology (Annex 5.1.14V). Further details of the land consultation are outlined in the phases of consultation below.

9.1.3 Section 46

- 114. Under Section 46 the Applicant must supply the Secretary of State with the same information that the Applicant would submit if the Secretary of State was a consultee under the section 42 consultation. This information must be submitted prior to or at the start of commencement of the consultation.
- 115. Table 9.4 below sets out the dates on which the Applicant provided the consultation information to the Secretary of State, the date that it was acknowledged and for completeness the date that the consultation commenced.
- 116. The Applicant carried out three phases of consultation under section 42. Prior to each phase commencing the Applicant notified the Secretary of State under section 46 of the 2008 Act and provided them with the consultation materials that were being provided to consultees for that phase. Copies of the notices are included in Appendix 5.1.6.

9.1.4 Section 47

- 117. Section 47 of the 2008 Act sets out the Applicant's duties in respect of consultation with the local community. Under section 47(1) the applicant is required to prepare a statement setting out how they propose to consult the local community on the proposed application. Section 8 above sets out the process the Applicant has undertaken in respect of the preparation and consultation on the proposed Statement of Community Consultation (SoCC).
- 118. Under Section 47(2) the applicant must consult each local authority that is within section 43(1) about what should be included in the statement. The Applicant consulted on the content of the SoCC with those LPAs shown in Figure 4.

9.1.5 Section 48

- 119. Section 48 of the 2008 Act requires the Applicant to publicise the proposed application in the prescribed manner. The prescribed manner is set out in Regulation 4 of the APFP Regulations. Under Regulation 4(2) this requires the Applicant to publish a notice in the following newspapers:
- (a) For at least two successive weeks in one or more local newspapers
- (b) Once in a national newspaper
- (c) Once in the London Gazette and if land in Scotland is affected, the Edinburgh Gazette and;
- (d) Where the proposed application relates to offshore development:
- (i) Once in Lloyd's List and
- (ii) Once in an appropriate fishing trade journal

120. In respect of Regulation 4(2)(a) the Applicant has publicised the application in a variety of local newspapers, as agreed during the SoCC consultation with local stakeholders, as set out in Table 9.5 below. Copies of the notices as they appeared in the newspapers are included within Appendix 5.1.6.

The Louth Leader is published under several names throughout Lincolnshire including Skegness Standard, Mablethorpe Leader, Horncastle News, Spilsby Standard and Market Rasen Mail. Copies of the notice appeared in all of the publications that are distributed in the relevant areas of Lincolnshire that could potentially be affected by the proposed development.



121. The Applicant published a notice under section 48 in conjunction with the Phase 2 consultation under section 42. The notice provided the information required under regulation 4(3) of the APFP Regulations in relation to the proposed application. Following feedback from the Phase 2 Consultation the Applicant made a number of changes to the Project and proceeded to re-consult under section 42 of the 2008 Act (being the Autumn Consultation). As a result of the changes to the Project the Applicant considered it would be appropriate to publish a further notice under section 48 in order to notify any persons with an interest in the Project of the changes to the proposed application. This notice was published in conjunction with the Autumn Consultation. Due to the targeted nature of the Targeted Winter Consultation no public notice was published in the newspapers and stakeholders were contacted directly by the Applicant.

124. In respect of Regulation 4(2)(d) the Applicant has publicised notice of the application in Lloyd's List on 7 June 2023 and 12 October 2023 and Fishing News on 8 June 2023. Copies of these are included within Appendix 5.1.6.



9.1.6 Section 49

125. Section 49 of the 2008 Act requires the Applicant to have regard to any relevant responses when deciding whether the final application should be in the same terms as the proposed application. The Applicant has reviewed all responses received under the consultations carried out under section 42 and 47. Further details of how these have been taken into account are set out in Appendix 5.1.4. No comments were received under the section 48 consultation.




Plate 9.1 Pre-Application Community Consultation Timeline




Plate 9.2 Pre Application Land Interest Consultation Timeline





9.3 Phase 1 Consultation (Project Launch)

129. The purpose of the Phase 1 Consultation was to launch the Project and the initial proposals with the local community with a view to receiving feedback at an early stage in the Project's design process. This phase of consultation was carried out under section 47 of the 2008 Act.




Plate 9.3 Phase 1 Consultation Timeline



9.3.1 Identification of Consultees

9.3.1.1 Consultation Zones (Compliance with the SoCC)

130. A core consultation zone was identified for the Phase 1 Consultation as shown in Figure 8. This core consultation zone comprised a minimum distance of 500 metres either side of the onshore search zone, extending to 1,000 metres around the onshore substation search zones. For clarity a map was included in the SoCC (Annex 5.1.5C) and in the Phase 1 Leaflet that was issued to all residents and businesses within this core consultation zone (Annex 5.1.8C). This approach was intended to ensure that all individuals and stakeholders identified within the vicinity of any proposed underground or overground infrastructure were consulted.

131. An "outer zone" was also identified as included in the SoCC (Annex 5.1.5C) consisting of people who may be interested in the wider potential impacts of the proposed Project, such as transport, visual impact and socio-economic impacts, including job creation within the local area. This zone included both the host and neighbouring Local Authorities, all of whom were consulted on the draft SoCC. The Applicant engaged with this zone using both local and social media.

9.3.1.2 Identification of Seldom Heard Voices

- 132. In addition to consulting residents and businesses, parties with an interest in the land and local parish, district and county representatives within the consultation zone, the Applicant further identified a list of seldom heard voices which are defined as individuals or groups that an organisation may have difficulty contacting or engaging for a particular purpose.
- 133. These consultees were identified through discussions with local stakeholders and stakeholder mapping, as outlined in Section 8 above, and were contacted at the start of each consultation phase to ensure that the approach best met the needs of its members and to maximise the chance of positive collaborations.

9.3.1.3 Identification of Land Interests and Consultation with Landowners

- 134. To identify relevant land interests the Applicant commissioned a search through the use of His Majesty's Land Registry (HMLR) to identify all registered titles and to obtain the official documents. Searches were undertaken on the 17 May 2022 and 20 June 2022 for an 800m wide corridor running through the Lincolnshire Node search zone through to the Weston Marsh search node.
- 135. Residential properties with less than 1 acre of ground were excluded from the search.
- 136. From this search all registered freeholders and leaseholders (hereafter referred to as 'landowners' within the search zone were issued a Landowner Questionnaire (LOQ) to introduce the Project, offer a face to face meeting and for them to confirm, refute or amend their interest in the land together with a letter introducing the Project. Letters were issued to 847 parties.



137. Between October 2022 and January 2023 following refinement of the search area, land agents met with landowners and/or their agents to review the search areas for cables and substation locations to obtain landowner feedback to assist with route feasibility. 305 of the 314 parties identified within the indicative 300m cable corridor participated in these meetings.

9.3.2 Consultation Events and Key Feedback

- 138. The Applicant received valuable feedback on various elements of the proposed cable route. Taking onboard the information received during the Phase 1 Consultation along with guidance from the environmental and engineering team and site surveys/meetings, the Applicant considered the feedback to be of key significance and, following detailed review, as described in ES Volume 1, Chapter 4: Site Selection and Consideration of Alternatives (document reference 6.1.4), proposed a potential alternative to the central section of the proposed onshore cable corridor to the Weston Marsh option between Wainfleet All Saints and Butterwick.
- 139. This feedback was communicated to the community and local stakeholders by means of a Project newsletter (Annex 5.1.8F), which the Applicant published in early 2023 following the decision to include the alternative cable route option. The newsletter also outlined that the Applicant would be undertaking an additional phase of consultation (Phase 1A details of which are provided in Section 9.4).
- 140. In general the offshore elements of the Project received no objection from the local communities and participants were more interested in the onshore component of the Project.
- 141. Feedback received during the Phase 1 consultation is shown and the Project's regard outlined in Appendix 5.1.4. The themes covered are listed below:
 - Landscape, Seascape and Visual Impacts
 - Impacts on the beach at Anderby Creek
 - Location of the Project's OnSS and National Grid connection
 - Traffic impact on the local roads
 - Screening of the OnSS and choice of planting
 - Potential impacts on the RSPB reserves at Frampton Marsh and Freiston Shore
 - Access to Public Rights of Way
 - Considerations around archaeological and cultural heritage in the area
 - Reinstatement of hedgerows
 - The possibility of siting the cable route under the Wash SSSI

142. The purpose of the Phase 1A Consultation was to consult the local community and residents on the newly proposed alternative route option. This phase of consultation was carried out under section 47 of the 2008 Act.




Plate 9.5 Phase 1A Consultation Timeline



9.4.1 Identification of Consultees

- 143. A core consultation zone (as included in the Updated SoCC (Annex 5.1.5F)) was identified for the Phase 1A Consultation as shown on Figure 10. This core consultation zone comprised a minimum distance of 500 metres either side of the newly introduced alternative route option onshore search zone, extending to encompass those consulted in Phase 1 on the original section of this route. For clarity a map was included in the Updated SoCC (Annex 5.1.5E) and in the Phase 1A Leaflet (Annex 5.1.9C) that was issued to all residents and businesses within this core consultation zone. This approach was to ensure that all individuals who may be directly affected by the proposed alternative route section were consulted.
- 144. An "outer zone" was also identified (as included in the Updated SoCC (Annex 5.1.5E)) consisting of people who may be interested in the wider potential impacts of the proposed Project, such as transport,
- visual impact and creating new jobs. This zone included both the host and neighbouring Local Authorities, all of whom were consulted on the draft Updated SoCC, this zone was reached through local and social media.
- 145. In addition to consulting residents and businesses, parties with an interest in the land and local parish, district and county representatives within the Phase 1A Consultation zone, the Project reviewed their list of seldom heard voices against the updated Phase 1A Consultation zone and continued to engage with the groups identified. No requests were made from any of the identified groups in relation to accommodations required to facilitate participation in the consultation process.

9.4.1.1 Identification of Land Interests

- 146. When the alternative route option was introduced following the initial round of Phase 1 consultation the same process was undertaken for s
- consultation the same process was undertaken for searches for landowner interests as has been undertaken for Phase 1.
- 147. 227 letters and LIQs were issued to all landowners identified as falling within the alternative route option 300m corridor in January 2023.
- 148. Between January 2023 and July 2023 the Applicant and their land agents met with landowners and/or their agents to review the search areas along the revised cable to obtain landowner feedback to assist with route feasibility. Of the 177 parties identified as landowners, 129 participated in these meetings.





9.4.2 Consultation Events and Key Feedback

- 149. The Project received valuable feedback on various elements of the alternative proposed cable route option. This feedback was communicated to the community and local stakeholders by means of a spring Project newsletter following the close of the consultation phase (Annex 5.1.9F). A summary of this feedback and how the Project has taken it into account when developing the proposals is outlined in Appendix 5.1.4.
- 150. In general, the offshore elements of the Project received no objection from the local communities and participants were more interested in the onshore component of the Project. These primarily focused on:
 - Traffic impact on the local roads in particular in relation to emergency vehicles
 - The site selection and alternative cable route proposed
 - Community Benefit Funds
 - Underground cabling or overhead pylons

9.5 Phase 2 Consultation

9.5.1 PEIR and consultation under section 42, 47 and 28 of the 2008 Act

- 151. Phase 2 of the Project's consultation ran from 7 June to 21 July 2023. During Phase 2 the Project sought feedback on the PEIR and associated documents and plans from statutory consultees, local communities and persons with a potential interest in the Project in accordance with the requirements set out under section 42 and section 47 of the 2008 Act.
- 152. The section 48 notice published ran concurrently with the section 42 and section 47 consultation.
- 153. The purpose of the PEIR was to provide sufficient information about the Project to allow consultees to develop an informed view of the likely significant environmental effects of the development, in accordance with Regulation 12(2) of the EIA Regulations.
- 154. At the time the PEIR was consulted on under the Phase 2 Consultation the Project's grid connection had not been confirmed and therefore both possible grid connection options and the cable routes, including both routes to Weston Marsh were considered as part of the PEIR documentation as shown in Plate 9.10.
- 155. An ES has been prepared as part of the DCO Application which describes and summarise the results of the EIA process. The final ES is based on:
 - The Scoping Opinion
 - Responses received from the Project's pre- application consultation process; and
 - Engagement with the statutory consultees and local communities throughout the pre-application period




Plate 9.9 Phase 2 Consultation Timeline * the deadline was extended to 31 July for a small number of stakeholders who requested further time



9.5.2 Identification of section 42 consultees

- 156. 


Plate 9.10 Onshore PEIR boundary consulted on during Phase 2



9.5.2.1 Identification of Land Interests and Consultation with Landowners

- 159. Search data, as outlined in Section 9.3, was refreshed on the 2, 23 and 24 May to ensure any changes in land ownership had been captured.
- 160. Landowner Interest Questionnaires (LIQ) were issued to all landowners identified as section 42 consultees within the PEIR boundary. The LIQ is a more detailed questionnaire than the LOQ originally issued, to confirm details held from HMLR, contact details, details of tenancies, the current land use and confirmation of any other interests including third party interests. Separate LIQ Templates were utilised for Landowners (Annex 5.1.14R) and those with rights in the land (Annex 5.1.14S).
- 161. On 2nd June 2023, 567 letters were issued to affected parties accompanying the initial batch of Section 48 notices. Due to delays with Royal Mail, 38 letters were hand delivered to ensure safe receipt on 14th June 2023.
- 162. Following the issue of Section 48 notices, any parties requiring additional information or further clarity, parties were directed to the Project's consultation materials available on the website or provided further details over the phone or met in person if required.

9.5.2.2 Identification of unregistered land and consultation with other land interests

- 163. Unregistered landowners were identified where possible by utilising public sources of information including site visits. Site notices were erected at various stages throughout the consultation phrases as shown on the Location Plans included in *Appendix 5.1.14*, as identified and during consultation phases and discussions with neighbouring landowners. A copy of the template is included as Annex 5.1.14F.
- 164. During the consultation phases notices were checked once a week and replaced if damaged or missing.
- 165. Between February and June 2023 and agents met caravan park owners and/or managers on site and subsequently posted and emailed letters to static caravan parks within or within close proximity of the Project's Order Limits to inform them of the Project and up and coming public information days. Emails and letters were issued to all caravan parks and managers in the consultation zone to notify them of the Phase 2 Consultation and requested this information was passed on to their tenants.

9.5.3 Identifying section 47 consultees

- 166. A core consultation zone was identified for the Phase 2 Consultation. This core consultation zone comprised a minimum distance of 1,000 metres buffer around the search zones for the proposed cable route options and the onshore substation search zones. A map was included in the Phase 2 Consultation Leaflet (Annex 5.1.10B) as shown in Plate 9.11 that was issued to all residents and businesses within this core consultation zone.
- 167. In addition to consulting residents and businesses, local parish, district and county representatives within the Phase 2 Consultation zone, the Project continued to engage with those identified as seldom heard voices including:

- 168. While Social Media was utilised throughout the Project's Phase 1 and Phase 1A consultation (as stated in the SoCC), following close monitoring and discussions with attendees it became clear that social media was a key channel utilised by the demographic and therefore as a part of an integrated communication strategy around the Phase 2 Consultation, the Project expanded the use of social media as a channel to reach potential consultees, promote the consultation events, and direct members of the community to the appropriate resources. Details of the Project's social media engagement are summarised in the Social Media Report (Appendix 5.1.14).

9.5.4 Consultation Events and Key Feedback

169. A summary of the feedback received during the Phase 2 events and how the project had regard to these is included in Appendix 5.1.4. Key topics addressed during this phase of consultation included:

- Substation location
- Cable routes proposed
- Ecology concerns around priority habitats
- Ornithology in particular around the RSPB reserves at Frampton Marsh and Freiston Shore
- Management of topsoil, subsoil and alluvial silts
- Impacts on the King Charles III England Coastal Path
- Archaeological remains in particular air crash sites and military remains
- Drainage strategy and flood risk
- Assessment methodologies
- Drafting and terminology
- Interaction with other offshore infrastructure
- Impacts on radar and navigation including potential vessel replacement
- 170. The Project received valuable feedback on the PEIR and updated project proposals. Some of this feedback was communicated to the community and local stakeholders by means of the Project update which jointly advised them of both the confirmation of the Grid Connection location and the adopted cable route to Weston Marsh which was selected following the feedback from the consultation phase (Annex 5.1.10H).



- 171. To ensure all those residents and businesses who had previously been directly contacted by means of a leaflet in the post were notified of this key update, a leaflet was issued to the entire consultation zone advising them of the areas that were no longer in scope. Throughout the consultation phase it was made clear by those potentially affected that even if their local area was removed from the scope they wanted to be notified.
- The remainder of the Phase 2 feedback informed further refinements and progression of the project's design which were communicated to stakeholders as part of the Autumn Consultation.

9.6 Autumn Consultation

- 172. Following review of feedback received throughout the previous consultation phases and corresponding amendments proposed for the Project, a further consultation under both section 42 and section 47 was undertaken in the Autumn (the Autumn Consultation) which ran from 20 October to 24 November 2023. A high level summary of the refinements undertaken as a result of feedback received throughout the pre-application consultation phases is included as Plate 1.1.
- 173. A notice published under section 48 of the 2008 Act ran concurrently with the consultation.
- 174. The purpose of the Autumn Consultation was to consult upon the project updates and design refinements following Phase 2 Consultation as a result of both the Section 42 feedback and the update from the National Grid confirming the Weston Marsh grid connection option. A high level summary of the refinements undertaken as a result of feedback received throughout the pre-application consultation phases is included as Plate 1.1.
- 175. Specific to the Autumn Consultation these included:
 - Proposed substation location following confirmation of the Project's grid connection location
 - Updated substation design parameters, landscaping proposals& visualisations
 - Refined cable route including updated temporary access, compounds and highway improvements for traffic
 - Refined landfall arrangements
 - Increase to 100 offshore turbine (from 93)
- 176. A summary of the key refinements that were consulted on are outlined below. An Environmental Update Report (Annex 5.1.11H) was published alongside Panels (Annex 5.11F), Visualisations (Annex 5.1.11I), a 3D Visualisation tool all of which will were made available on the Project's website and at consultation events. A copy of the environmental update report and visualisations were made available in hard copy at the Project's hard copy access locations as part of the consultation.




Plate 9.13 Autumn Consultation Timeline

9.6.2.2 Category 3 Land Interests

- 182. After the commencement of the consultation, the Applicant identified a number of additional parties who at the time were considered as potentially falling into the classification of Category 3 land interests under section 44 of the 2008 Act, namely that:
- *'if the Applicant thinks that, if the order sought by the proposed application were to be made and fully implemented the person would or might be entitled-*
- (a) As a result of implementing the order,
- (b) As a result of the order having been implemented, or
- (c) As a result of use of the land once the order has been implemented

To make a relevant claim'

- 183. A relevant claim in this context refers to a claim under section 10 of the Compulsory Purchase Act 1965, a claim under Part 1 of the Land Compensation Act 1973 or a claim under section 152(3) of the 2008 Act (Compensation in case where no right to claim in nuisance).
- 184. Category 3 letters included a summary of where consultation materials for both the Autumn Consultation and Phase 2 Consultation could be located. Responses received in respect of the Category 3 letters issued are included within Appendix 5.1.4
- 185. Due to the delay in identification of these parties the Autumn consultation was extended to 15 January 2024 to allow for consultees to be given the full time to respond.

9.6.3 Identifying section 47 consultees

186. The Applicant considered that all consultees who had been identified as part of the Phase 2 Consultation should also be invited to participate in the Autumn Consultation, therefore the Consultation Zone remained the same as had been established during Phase 2. Parties who had attended previous phases of consultation and registered for further information were also included. Leaflets were issued to all residents within the Autumn Consultation Zone, a copy of which is included in Annex 5.10.B, emails were also issued to other interested parties, consultees and members of the public who had indicated that they wished to be kept updated with the Project's consultation phases, a copy of which is included in Annex 5.1.10E.



187. The Applicant continued to ensure that the consultation was accessible to all those who wished to participate and included a review of the list of seldom heard voices identified at the earlier stages of the consultation. The Applicant recorded the Autumn Consultation event advert for the Boston and South Holland Talking newspaper. The Applicant encouraged the listeners to attend an event and contact the Applicant if they had queries. The recording was distributed to the 60 visually impaired listeners the week before the consultation events held in October 2023.

9.6.4 Consultation Events and Key Feedback

188. A full summary of all responses received during the Autumn Consultation and how the Project has considered and had regard for these is included within Appendix 5.1.4. Key topics addressed included:

- Feedback on the confirmed location of the substation and cable route
- Impacts on the productivity on Grade 1 agricultural land
- Noise and Vibration impacts
- Traffic impacts on the local roads
- Interaction with other offshore infrastructure
- Impacts on radar and navigation including potential vessel replacement

9.7 Targeted Winter Consultation

9.7.1 Purpose of Targeted Consultation

189. Following feedback received during the Autumn Consultation the Applicant made a small number of changes and then undertook a final round of targeted consultation under section 42 of the 2008 Act for those affected by the changes ahead of the DCO application submission.

190. The proposed changes to the Project included:

- Refinement of landscaping to better align with landownership boundaries to prevent severed land and enable access for maintenance.
- Addition of drainage works adjacent to the landscaping to mitigate landowner concerns of potential impacts of planting on land drainage.
- Amendments to accesses following landowner consultation.
- Re-location and removal of passing places following design optimisation studies.
- Removal and re-location of construction compounds based on engineering refinements and landowner feedback.
- Refinement of landfall works to accommodate optimised engineering design and environmental mitigation.

9.7.2 Identification of Section 42 Consultees

- 191. Due to the minor nature of the refinements the Applicant elected to consult the small proportion who would potentially be affected by the changes. These were:
 - Landowners affected by the proposed changes
 - Prescribed and statutory consultees identified in accordance with section 42 of the 2008 Act and Schedule 1 of the APFP Regulations as outlined in Section 9.1.1. above. A full list of consultees consulted during the Targeted Winter Consultation is included in Appendix 5.1.3.

9.7.3 Feedback from Targeted Consultation

192. 761 letters were issued in December 2023 encompassing both the Targeted Winter Consultation and the Category 3 consultation carried out as part of the Autumn Consultation. A full summary of all responses received during the Targeted Winter Consultation has been included in Appendix 5.1.4. No further comments were received in these responses.



9.8 Identification of additional parties

- 193. Prior to the submission of the application, cross checking of the final Book of Reference to the section 44 parties consulted as part of the section 42 identified additional parties with Category 2 and 3 interests who had not been previously consulted as identified below:
 - Gordon Albert Mills: through further due diligence checking this party was identified as having a Category 2 interest within the Project's Order Limits
 - Helen Juliette Mills: through further due diligence checking this party was identified as having a Category 2 interest within the Project's Order Limits
 - Robert William Dawson: through further due diligence checking this party was identified as having a Category 2 interest within the Project's Order Limits
 - TM Trustees Limited: through further due diligence checking this party was identified as having a Category 2 interest within the Project's Order Limits
 - The Executor of the Estate of the Late Jean Elizabeth Sanderson: during the initial title interrogation it was identified that the owners of the land were Roy and Jean Elizabeth Sanderson. A Landowner Questionnaire was issued on the 18 July 2022 and a letter was received from Will Barker & Co on the 15 August 2022 to notify the Applicant that Jean Elizabeth Sanderson had passed away. Following this all correspondence was issued solely to Roy Sanderson. During due diligence checks it was decided that an Executorship for the Estate of Jean Elizabeth Sanderson should be included.
 - Stanley David Codd Will Trust: as part of the Land Referencing Methodology the Project carried out desktop and contact referencing to identify parties with an interest in unregistered land. This included the use of site notices and discussion with other landowners in the area. The Applicant's surveyors contacted the occupier of the land, Staples (Vegetables) Limited, who couldn't provide the name of the landlord. An LIQ was provided on the 28 February 2024 to provide the name of the landowner.
 - Alexander James Hay, Andrew George Hay and Mary Ellenor Hay: during the initial title interrogation it was identified that the owners of the land were Alexander James, Andrew George and Mary Ellenor Hay. Landowner questionnaires were issued on 24 June 2022. A response was received from Alexander James Hay on 4 August 2022 stating that LL354068 was under the ownership of George Hay & Son Limited. All further correspondence for this title was directed to George Hay & Son. During due diligence checks it was decided that as no further evidence has been supplied that Alexander James, Andrew George and Mary Ellenor Hay should be included for this title.
 - Sarah Elizabeth Scupholm: through further due diligence checking this party was identified as having a Category 2 interest within the Project's Order Limits
 - Colin Frank Daubney: Colin Daubney was identified as a tenant of the Alenson and Erskine Education Foundation on title LL318800 when the Applicant made attempts to secure survey access across the proposed route. Mr Daubney was issued a LIQ on 27 April 2023 and the Applicant received a phone call from Mr Daubney on 2 May 2023 to deny interest in the land. During due diligence checks it was noted that Mr Daubney should be re-added to the land as a tenant.




- Steven John Mayfield Esq: Steven John Mayfield Esq was identified as a tenant of the Surfleet United Charities on the title LL297342 when the Project made attempts to secure survey access across the proposed route. LIQs were issued on the 23 May 2023 to the tenants of Surfleet United Charities. A response was received from Jason and Keith Palmer stating that they held the occupation over the land previously attributed to Mr Mayfield. All further correspondence for this land was directed to Jason and Keith Palmer. During due diligence checks it was noted that Mr Mayfield should be re-added to the land interests as a tenant.
- Nigel Clarence Marshall and Julia Kay Johnson as trustees of the Frank Arnold Marshall Will Trust: during the title interrogation it was noted that the Trustees of the Frank Arnold Marshall Will Trust were the freeholders of the land, and these were David James Hamshaw, Graham Clive Holdich Smith and Mavis Stebbings. All correspondence was issued to these parties. The Applicant was notified by Roythornes Limited on 7 March 2024 that new trustees had been appointed.
- 194. In order to address this matter, the Applicant delivered letters to these parties which provided an overview of the Project and consultation details on 8th March 2024 and provided for a 28 day consultation period.
- 195. Due to the imminence of the submission of the application, the Applicant is not able to consider any responses received to that consultation prior to submission. The Applicant will consider any responses made during the consultation period and take those into account as necessary during the examination of the application. The Applicant will notify these parties under the section 56 procedure on acceptance of the application.
- 196. Should any further new interests arise the applicant will notify new interests of the opportunity to comment on the application during examination.
- 197. Due to the extensive consultation that the Applicant has carried out as outlined above, the Applicant considers that those section 44 land interests have been afforded an opportunity to comment on the proposed Project and were not prejudiced by the stage that the Applicant became aware of their interest in the land or right of access.



9.9 Evidence Plan Process (EPP)

198. The EPP is a non-statutory voluntary process that allows engagement and aims to encourage upfront agreement on the information an applicant is required to submit to the Planning Inspectorate as part of the DCO application. The EPP was initiated to facilitate engagement with key stakeholders to ensure regular, formalised consultation on the Project's development forming an extension to the scoping and wider pre-application consultation process and has aimed to agree the evidence required to be submitted within the DCO application.

- 199. Work relating to the EPP for the Project commenced in early 2021. In August 2021 the Applicant met with Planning Inspectorate for an inception meeting and subsequently confirmed in November 2021 that the EPP had commenced.
- 200. The EPP has provided a record of agreements and disagreements between the Applicant and the key stakeholders included in the EPP and Expert Topic Groups (ETGs)
- 201. An EPP Steering Group was established to oversee the progress of the EPP and resolve any issues emerging from the ETGs, which were held on an approximately quarterly basis. The structure of the Project EPP is summarised in Plate 9.14 and the timeline of the Project EPP is outlined in Plate 9.15






Plate 9.15 Timeline of EPP

- 202. Membership of the ETGs is set out in Table 9.13 and the Project's engagement with the EPP and key discussion points from the ETGs are documented in Appendix 5.1.15.
- 203. The EPP is a voluntary, informal process that has provided a record of agreements and disagreements between the Applicant and those key stakeholders included in the EPP. The EPPs has also helped to inform the Statements of Common Ground (SoCGs) process with those same parties.
- 204. Full details, including an overview of the roles involved and the scope of the EPP are included within the Evidence Plan Process (Appendix 5.1.15). The report reflects the discussions and agreements made with EPP members through the pre-application process.

9.10 Technical Consultation outwith the EPP

205. Following the award of Preferred Bidder status as part of The Crown Estate leasing round 4 in February 2021 the Applicant commenced engagement with a range of stakeholders, in addition to consultation carried out through the EPP as outlined in Section 9.8 above.

9.10.1 Commercial Fisheries

206. A Fisheries Liaison Officer (FLO) has been appointed to ensure effective, ongoing consultation with the fishing industry. The FLO is primarily responsible for maintaining effective communication and relationships between the Applicant, its consultants, and the fishing industry. The FLO has continued to work with the fishing industry to gain an understanding of the interactions and potential impacts of the Project for the industry and help gather data to accurately create a fisheries stakeholder database containing information on vessel operations. The FLO also provides information, notices, and project updates to fishing stakeholders and distributes information relating to safe operation of the fishing industry, including those fishermen operating in the Project area, including for example, when the Applicant has organised surveys that have necessitated the relocation of fishing gear. Details of consultation with the fishing industry is set out below in Table 9.14.

9.10.2 Shipping and Navigation

208. Relevant shipping and navigation stakeholders (including statutory bodies such as the MCA and THLS as well as shipping operators) have been invited to meetings as a forum to discuss the potential effects on shipping and navigation receptors. As part of the work undertaken to inform the PEIR a Hazard workshop was conducted on 10th November 2022. A further Hazard Workshop was then held on 23rd November 2023 to consult on the Project changes from PEIR to ES and inform the updated EIA assessments. Full details of the relevant consultation undertaken to date is discussed in more detail in ES Volume 1, Chapter 15: Shipping and Navigation (Document Reference 6.1.15).

9.10.3 Aviation and Civil and Military Radar

209. For civil and military radar, relevant stakeholders have been invited to meetings as a forum to discuss the potential effects on aviation and radar in the area. Consultation with relevant stakeholders was ongoing throughout the pre-application process, allowing for consultation on the potential impacts arising from the Project. This is discussed in more detail within ES Volume 1, Chapter 16: Aviation, Radar, and Military and Communication (Document Reference 6.1.16) and to the extent that other offshore owners and operators of infrastructure in the vicinity were affected, is included within Table 9.16 below.

9.10.4 Other Offshore Owners and Operators of Infrastructure in the Vicinity of the Project

210. Within the vicinity of the Project array area and the offshore export cable corridor (ECC) a range of other offshore users and commercial interests have been identified including oil and gas operators, pipeline and cable operators, marine aggregate dredging operators, and adjacent existing and proposed offshore wind farms. Consultation with relevant operators was ongoing throughout the pre-application process and is summarised in ES Volume 1, Chapter 18: Marine Infrastructure and Other Marine Users (Document Reference 6.1.18) and set out in Table 9.16 below.

9.10.5 Consultation Relevant to the National Grid Connection Point

- 211. The Offshore Transmission Network Review (OTNR) was initiated by the Department for Business, Energy & Industrial Strategy (BEIS) (now DESNZ) to investigate the way that the offshore transmission network is designed and delivered, consistent with the UK's ambition to deliver net zero emissions by 2050.
- 212. The Applicant has engaged with National Grid ESO (NGESO) in relation to the OTNR process, and the pathway to 2030 Holistic Network Design (HND). Following the preliminary conclusions as published in the HND Report (July 2022, NGESO) which identified two grid connection options for the Project as assessed in the PEIR (Lincolnshire Node and Weston Marsh), the Applicant has continued to engage with NGESO and a final grid connection point for the Project was confirmed as Surfleet Marsh (previously Weston Marsh North) on 10th August 2023.
- 213. In parallel, the Applicant engaged with key stakeholders in developing and identifying Offshore ECC routes and landfall sites (this was also in response to the requirements of The Crown Estate process for agreeing the Agreement for Lease (AfL) for the offshore cable route). Meetings were held with Natural England, the Marine Management Organisation and Cefas in March 2022 to discuss the offshore areas of search and potential landfall locations, with further relevant discussions regarding project refinements undertaken through the established ETGs.
- 214. (See ES Volume 1, Chapter 4 Site Selection and Consideration of Alternatives (Document Reference 6.1.4)).

9.10.6 Transboundary Consultation

- 215. Transboundary effects arise when impacts from a development within one European Economic area (EEA) state effects the environment in other EEA state(s). The need to consider transboundary effects has been embodied by the United Nations Economic Commission for Europe Convention on EIA in a Transboundary Context (commonly referred to as the 'Espoo Convention'). The Convention requires that assessments are extended across borders between Parties of the Convention when a planned activity may cause significant adverse transboundary effects. The approximate distances of the Project from the Exclusive Economic Zone (EEZ) boundaries of other EEA states are shown in Table 1.2 of Volume 1, Chapter 5: EIA Methodology (Document Reference 6.1.5).
- 216. The consultation requirements for transboundary effects set out in the Espoo Convention have been implemented in the UK for the purposes of NSIPs by the Infrastructure Planning (EIA) Regulations 2017. Regulation 32 of the EIA Regulations sets out a prescribed process for the Secretary of State to notify and consult EEA States if the Secretary of State is of the view that a Project is likely to have significant transboundary effects on the environment in that EEA State.
- 217. The Applicant has followed the Planning Inspectorate's Advice Note Twelve: Transboundary Impacts and Processes (The Planning Inspectorate, 2020b) which sets out the procedures for consultation in association with an application for a DCO where such a development may have significant transboundary effects, noting the Applicant's responsibility to provide relevant information on potential transboundary effects as part of the DCO application.
- 218. Transboundary effects have been largely scoped out for many receptors given the location of the Project. However, each of the technical chapters includes details of the potential transboundary effects (see ES Chapters 7 through to 30).
- 219. Where consultation has been undertaken to inform the transboundary assessment, these have been recorded and summarised in the Consultation Report (Doc Ref 5.1).

9.10.7 Habitat Regulations and Compensation

- 220. The Project has been required to undertake a Habitats Regulation Assessment (HRA) in accordance with section 63(1) of the Conservation of Habitats and Species Regulations 2017. Further details on the HRA process are set out in the Report to Inform Appropriate Assessment (document reference 7.1) HRA Screening Report (document reference 7.2) and the Need, Policy and Legislative Context chapter of the ES (document referent 6.1.2).
- 221. The Project has concluded that it will not have an Adverse Effect on Integrity (AEoI) on any of the designated features of the relevant Special Protected Areas (SPA) or Special Areas of Conservation (SAC). However, in the event that the Secretary of State (SoS) identifies that an AEoI cannot be ruled out on any of the relevant sites, the Project has put forward a range of 'without prejudice' compensation measures for the relevant benthic and ornithological features (document references 7.6 7.9).



222. In addition to consultation undertaken through the Expert Topic Groups (ETGs) and EPP process including identification and prioritisation of HRA matters, the Project has undertaken extensive consultation with a range of other stakholders in relation to HRA and associated without prejudice compensation matters. These meetings are recorded below within Table 9.18.

9.10.8 Internal Drainage Boards (IDBs)

223. The ECC is located within the areas managed by five IDBs who own certain drainage assets, including pumping stations and some of the largest drains:

- Lindsey March IDB
- Witham Fourth District IDB (W4DIDB)
- Black Sluice IDB
- Welland and Deepings IDB (WDIBD)
- South Holland IDB
- 224. Other drains are managed by the IDBs and activities relating to riparian drains (which are owned by the relevant landowner) also are regulated by the IDBs. The IDB owned or maintained drains, and the riparian drains are identified in ES Volume 3 Crossing Schedule (document reference 6.3.3.2) and ES Volume 1 Hydrology and Flood Risk (document reference 6.1.24).



- 225. The IDBs own certain drainage assets, including pumping stations and some of the largest drains. Other drains are managed by the IDBs and activities relating to riparian drains, which are owned by the relevant landowner, are regulated by the IDBs. The IDB owned or maintained drains and the riparian drains are identified in the Chapter 24 of the ES Hydrology and Flood Risk (document reference 6.1.24) and the Crossing Schedule (document reference 6.3.3.2).
- 226. All of the IDBs listed above have been involved in the Onshore Ecology, Hydrology, Geology & Ground Conditions and Land Use ETG meetings conducted as part of the EPP with Witham Fourth District IDB acting as a representative of the group for negotiating technical details and arrangements for approvals.
- 227. Additionally, the Applicant has held additional meetings to discuss Project activities that fall within the IDB's regulatory remit and clarify the Project's understanding of their requirements in relation to works. Table 9.19 below outlines separate discussions that have taken place with the Welland and Deepings IDB regarding the permanent drainage discharge arrangements for the OnSS, which are described in Outline Operational Drainage Management Plan (Document 8.12).

9.10.9 Anglian Water Services (AWS)

- 228. AWS is the statutory undertaker providing potable water and sewerage services within the Project area and has a large number of assets, such as water mains and sewerage pipes located within the Project's Order Limits.
- 229. The Applicant consulted AWS through its formal consultation processes and received responses regarding the requirement for protective provisions in relation plant which could be affected by the project, and a request for a meeting. An inception meeting was held to brief AWS regarding the project and for AWS to set out its requirements and procedures, both for the DCO process and for the management of service crossings during construction.

9.10.10 The Environment Agency

- 232. The Environment Agency (EA) is a public body sponsored by the Department for the Environment, Food and Rural Affairs (DEFRA) which has responsibilities and a regulatory role for the management of flood defences, main rivers, abstraction and discharges and other activities requiring environmental permits. The primary areas of interaction between ODOW and the EA relate to the landfall, the five main rivers and associated flood defences (under which cables will be installed by trenchless techniques) and the OnSS, in relation to Flood Risk Assessment (FRA). The EA is also a landowner and owns assets, including flood defences, land and a bridge within the project order limits.
- 233. The EA has been involved in the ETG and Evidence Plan process through the Onshore Ecology, Hydrology and Land-use group and specific meetings have been held to discuss project activities that fall within the EA's regulatory remit. The assessments relating to the topics discussed are contained in ES Volume 1, Chapter 24: Hydrology, Hydrogeology and Flood Risk (document 6.1.24).
- 234. Specific consultation meetings have been carried out, both to discuss concerns raised by the EA and to clarify ODOW's understanding of EA requirements in relation to works, such as the clearances required for trenchless crossings under main rivers and to discuss ODOWs indicative construction methodologies.



- 235. The EA currently has an annual program of beach nourishment close to the cable landfall location and discussions have taken place in order to understand each party's works and potential interactions. The potential for the EA to carry out future flood defence works has also been considered in relation to the depth of installation of the cables, at locations where the EA has identified that works may occur in the future.
- 236. The EA has been the main consultee in relation to the flood resilience requirements for the OnSS and the modelling that was required in order to determine the maximum depth to be considered in the OnSS design. The assessment is contained in the OnSS Flood Risk Assessment (document 6.3.24.3) and Annex 1 the River Welland Breach Model report (document 6.3.24.3.1).

9.10.16 Land Interest Groups

- 242. A Land Interest Group (LIG) has been formed consisting of land agents who are representing landowners affected by the Project's proposals. The LIG was set up by the agents and supported by the Project as it brings efficiencies and a more streamlined approach to voluntary negotiations. The Project has also engaged with the LIG on both the outline Code of Construction Practice (document reference 8.1) and Soil Management Plan (document reference 8.1.3) to ensure that concerns highlighted throughout both the formal and informal consultation have been addressed.
- 243. The LIG has met with the Applicant and the Applicant's land agents regularly since January 2023. These meetings have been centred around agreeing Heads of Terms for the Deeds of Easement which the Applicant is seeking to enter into on a voluntary basis to obtain the land rights for the Project.
- 244. Due to the number of landowners impacted by the cable corridor, the LIG enabled feedback to be streamlined prior to the Heads of Terms being issued to the landowners.
- 245. Following the Heads of Terms being issued there were further negotiations facilitated through the LIG which let to these being amended.
- 246. The LIG has also held meetings to discuss and negotiate terms for the Temporary Works Areas.

10 Community Liaison Groups (CLGs)

- 247. The Applicant established four CLGs at appropriate locations along the onshore ECC in an effort to ensure effective consultation with the local communities, taking account of the proposed infrastructure in the given areas. The purpose of splitting the groups geographically was to facilitate consultation that focused on the key infrastructure proposed within the affected wards. Table 10.1 outlines which CLG's the representatives of each ward were invited to. The four CLGs remained consistent throughout the pre-application process although the names were updated as the Project was refined. These four groups were:
 - Landfall and Northern Substation Search Area (later 'Landfall')
 - Northern Cable Route
 - Southern Cable Route
 - Southern Substation Search Area (later 'Substation')
- 248. The Parish, District and Country Wards that intersect the Phase 1 Consultation Zone (shown in white hash on Plate 9.4) and Phase 1A Consultation Zones (shown in yellow hash on Plate 9.6) are shown on Plate 10.1. The Phase 2 and Autumn Consultation Zones comprise both the Phase 1 and Phase 1A Consultation Zones.
- 249. Locally elected members at county, district and parish councils were invited to ensure local residents were appropriately represented. District and County councillors were invited where the consultation zone intercepted their ward and each of the affected parish councils were invited to elect a member to sit on the group on behalf of that parish.
- 250. Following parish and district local elections held in May 2023 to ensure that the communities were fairly represented on the CLGs, the Applicant invited all appointed District Councillors and requested that the parish clerks re-nominate a parish representative.
- 251. The CLGs operate as a discussion group where the Applicant gives presentations to cover project updates and developments, feedback from any relevant consultation phases and minutes are taken.
- 252. Once the minutes are approved these are uploaded along with the Presentation to the Outer Dowsing website.

 - To involve key local stakeholders in the design and development of the Outer Dowsing Offshore Wind project (landfall, onshore cable route and substation) through presentations, discussions and planned workshop activities.
 - To act as a two-way communication channel between local communities and the project team.
 - To help foster local involvement with the Project



11 Other Community Consultation

- 255. The Project has utilised social media, in order to engage with communities and raise awareness about the consultation phases and corresponding events. Full details of the Project's engagement with social media are outlined in the Social Media Report. (Annex 5.1.14A)
- 256. In respect of the Project's social media presence, the Project proactively utilised Facebook, twitter, LinkedIn and Instagram to achieve the following goals:
 - Promotion of in-person community consultation days to increase community attendance
 - Utilisation of local Facebook groups and community Facebook pages to proactively share details of events with local councillors, MPs, parish councils and the local communities.
 - Promotion of webinars particularly on LinkedIn to increase attendance from interested parties.
 - Promotion of the webinars and in-person events on Instagram in order to attract a younger audience.
 - Promotion of the consultation options on twitter to engage with non-governmental organisations (NGOs), media and other interested parties who are more active on this channel.
 - Facebook was identified as a core channel for those who live and work in the consultation zone and the Project aimed to utilise this extensively throughout the Phase 2 consultation onwards. Several statutory stakeholders and community leaders have 'followed' the Project on Facebook.



12 Outer Dowsing in the Community

- 257. The Project has begun to engage with the community outside of the consultation process and will continue to engage throughout the examination, pre-construction and construction phases.
- 258. To date this has included supporting the John Splenduffe Careers Fair in March 2023 and the provision of stationery and bee friendly native wildflower seeds for the Lincolnshire Pride Pack.
- 259. Members of the Project team participated in Green Libraries Week in Boston in October 2023. Green Libraries Week is an annual showcase which aims to focus on sustainability and climate change.
- 260. The Project has also volunteered with the Boston Woods Trust to engage in replanting of indigenous plants.
- 261. The Project has also engaged with the regional Science, Technology, Engineering and Mathematics Network (STEMNET) lead to discuss opportunities for STEMNET ambassadors to support local schools in the area in 2024.
