- Danish Shipping:

It can be difficult to keep an overview of the various parks and their extents. Therefore with reference to our previous consultation response regarding same project dated November 23, 2023. repeating our remark from that time:

For our member shipping company DFDS which i.a. sailing from Esbjerg, Hornsea 3 will have a big impact. To address some of these impacts we would like this to be the ODW project by reducing the northern extent of the ODW so that it is ensured that DFDS can sail in a more direct line south of Hornsea 3 towards the entrance to the Humber.
