Dear Outer Dowsing team,

Further to the Rule 6 Letter issued on 4th September 2024, we would like to seek confirmation from the ExA on two points:

1. As noted in Annex F, numbered point 5, the ExA has made a Procedural Decision to request that the Applicant completes and maintains a Land Rights Tracker. In line with your email dated 27th August 2024, we can confirm we will undertake this request using the template used on Five Estuaries. We do not intend to update the Applicant's Schedule of the Current Status of Negotiations, which forms Appendices 4 and 5 to the Statement of Reasons [APP-031] as these Appendices would be superseded by the new Land Rights Tracker, it would avoid duplication of information and it would provide a single efficient source of reporting such matters to the Secretary of State.

2. As noted on page 5, the ExA has noted the Examination Timetable includes various Deadlines for the submission of an updated Book of Reference and schedule of changes to the Book of Reference. In Annex D, the ExA notes Deadline 1 includes a request for the Applicant's updated Book of Reference (BoR) and Schedule of Changes to the BoR (If required) in clean and tracked versions. We do not intend to submit a track changes version of the BoR as the Schedule of Changes provides sufficient clarity to identify the changes.

We would be grateful if you could confirm at your earliest convenience if the ExA are accepting of our approach on the above two points.
