

1 Introduction and Document Purpose

- 1. This erratum to the Environmental Impact Assessment (EIA) for Outer Dowsing Offshore Wind (the Project) has been prepared to address and correct an error identified in the original document submitted to the Planning Inspectorate in March 2024.
- 2. After its publication, it was brought to the attention of the Applicant that some of the Onshore ECC Quantitative Analysis data presented in 6.1.4 Chapter 4, Site Selection and Consideration of Alternatives, of the Environmental Statement (Ref: <u>APP-059</u>) Annex A, Table 4B.1 was incorrect and published in error. Although this discrepancy does not impact the conclusions of the ranking exercise or the overall assessment it is important to ensure the accuracy and reliability of the environmental impact analysis.
- 3. The purpose of this addendum is to correct this identified error. The Applicant acknowledges the importance of maintaining transparency and accuracy in reporting and is committed to ensuring that all stakeholders have access to the most reliable and up-to-date information.



2 Correction of Onshore ECC Quantitative Analysis

- 4. Table 1 presents a corrected version of the data presented in Annex A, Table 4B.1 of 6.1.4 Chapter 4. Corrections are presented in red text for clarity.
- 5. Although there are several changes in the data, it is important to note that these changes do not result in a change to the rankings presented in the final row of the Table 1.
