Thank you. Together, we constitute the examining authority for this application. I'll now come on to deal with a few housekeeping matters for those attending in person with us here today. The panel may wish to ask you questions, but you should be reassured that if we do not ask you questions, that is not an indication that the points you've raised have not been taken seriously, the examining authority will give appropriate consideration to all important and relevant matters put before it during this examination, rather than inviting a full response in person today, the examining authority will give the applicant an opportunity to respond fully in writing to any matters Raised once all speakers have been heard the examining authority requests that the applicant submit this written response at deadline one however, it is possible that there may be matters which have been misinterpreted or misunderstood by persons making their representations today, and which the applicant may be able to bring to a quick resolution with a clarifying statement this afternoon, we will therefore come to the applicant to confirm whether it can assist in this way before bringing this hearing to a close. Thank you. So first, then we have Jenny Pennington, would you like to take a seat? Mr. Spington,

Thank you. My name's Jenny Pennington. We are farmers from Spaulding Marsh, which everybody's now decided to call Western Marsh. I'm sorry. I'm dealing with seven projects at the moment that are hitting us. Yesterday, I had my pylons hat on. Today, it's a wind farm project. We're concerned about the loss of the grade one agricultural land. Airline land is actually double cropping, so obviously we're worried about that. Think it's absolute sacrilege to be using grade one land for these sort of purposes. We're also we've got cabling, possibly, and erection of a national grid substation, which air to dowsing will connect into. We appreciate the need for renewable energy, but. We're concerned about the effects of the cabling running through the land, also access roads and any infrastructure which may be needed. We're worried about the disturbance of land, the long impact, long term impact on use of the land, some being taken out of production altogether, ie 35 acres of land at surf fleet for the substation. We're worried about the size of that, the screening, possible dust effects, and basically it's just absolute sacrilege. We don't think that you should be using grade one agricultural land for these sort of projects, there are other areas which could be utilized. Thank you. Thank you.

Good afternoon, Neil. Neil Wilson, farm manager for woodlands farm at Curtin. We farm 3000 acres, organically producing potatoes, beetroot, brassicas and combinable crops. We our soils are all grade one silt, the grade one silt in South South Lincolnshire, South East Lincolnshire is unique in being probably the well, without doubt, the most productive land in the country. All of the crops that was produced on that land are premium quality destined for premium supermarkets. Majority of our potatoes go to Waitrose Marks and Spencers, among others. Similarly, the beetroot the same. The beetroot is exported into Europe. We're also exporting potatoes into Ireland. We are our customers. Expect nothing but the best, and to get the best, our land needs to be in absolutely top quality. It needs to be structurally sound. And because we're organic, we rely on natural fertility. The massive catastrophic disturbance that these cables effectively have on the land mean that the structure is ruined, the fertility is ruined, and it's probably likely that the land will never, ever produce the quality that our customers expect, ever again that combined, not only because of the that the reduction in fertility, drainage is an issue. We're all around about sea level, so under drainage is of great importance to us. These cables obviously affect that drainage. We don't know what impact the heat generation of the cables will have on our crops. I can only assume it will be negative. Because we're organic, we will have to have strict protocols in place to ensure that contamination does not occur on our land from conventionally farm soil. Those protocols will be very difficult to adhere to. That has been demonstrated already by the fact that we've had six environmental assessments done on the farm. For those assessments to be made, we had strict, fairly simple protocols that those doing the inspections needed to follow. Of the six, one was carried out correctly. Protocols were followed. Four of them, we kicked the inspectors off the farm because they didn't follow the protocol. And the final one managed to sneak on the farm and do the survey without our knowledge, with that, in taking that knowledge into account, what hope have we got of the contractors following protocols whilst they're carrying out the work? It just won't happen because the grade one silt. This is confined to a relatively small area. I can see no reason why these cables should not be diverted around this area on grade two and grade three land, most of those farming grade two and grade three land do not produce the quality of crops that we produce, potatoes, for example, are not for pre pack for supermarkets. They're destined for making crisps, and where the skin finish that we produce is not required, so it doesn't have an impact on them. I would say most of those grade two and grade three farmers would welcome you out of dowsing and Ossian and Eagle three and four with open arms, because the payments they would receive will be probably greater than what they would receive from farming that does not apply to us. I've I've suggested the compensation levels that we're offered we will require, and they cannot believe the sums that we're suggesting. So we know that we'll have a massive battle in the forthcoming 1015, years with compensation, and I don't think we'll we're successful in getting what we lose. So yeah, my To summarize, I think I speak on most of the farmers farming this grade one land. We do not want them. Thank you.
