We are writing to you regarding the proposed Gate Burton Energy Park which is a solar photovoltaic (PV) array generating facility and energy storage facility with a total capacity exceeding 50 megawatts (MW) and grid connection route corridor to National Grid's 400kV Cottam substation. The Application is for the proposed Gate Burton Energy Park on farmland south east of Gainsborough and to the east of the A156 at Gate Burton and to the west of the B1241 at Willingham by Stow (the "Site"). The Application comprises of the 'Solar and Energy Storage Park' and a grid cable connection corridor to National Grid's 400kv Cottam substation which is located to the SW of the Site in Nottinghamshire.

The Scheme falls within the definition of a 'Nationally Significant Infrastructure Project' (NSIP) under the Planning Act 2008 (as amended) (the 2008 Act). In accordance with the 2008 Act, we are required to make an application for a Development Consent Order (DCO) to get the consent we need to construct, maintain, operate and decommission the Scheme

This application will be made by Gate Burton Energy Park Limited (company number 12660764) ("the Applicant") to the Secretary of State for Business, Energy & Industrial Strategy (Secretary of State) via the Planning Inspectorate (the Inspectorate) who will appoint an Examining Authority to examine the application on behalf of the Secretary of State.
