What appears to be missing is any consideration of the people of the area. In terms of both benefit to the community, there appears to be the possibility of a limited fund, but this does not address having deprived people in the area of livelihoods and landscape. It is therefore not surprising that as far as I understand, there is scant support for the gate Burton scheme on any or any of the other large scale solar projects, and overwhelming opposition from every parish that has expressed a view representing 18 or 19 villages. Government Strategy papers and national policy statements all refer to the need to consider community impacts. And the Skidmore review recommends that projects are not imposed on local communities. But the end CIP process feels like a machine that the community has no real say in the applicant has been through its consultation process covered in the detailed consultation report, which runs to 338 pages. The executive summary alone is eight pages and describes the approach taken to comply with statutory duties. The executive summary concludes that the applicant has considered and applied all relevant advice and guidance. Nowhere are the results of that consultation mentioned in easily digestible terms such as how many respondents are supportive or in opposition to the proposed development. The consultation report describes in forensic detail how people were made aware what events were held, who told and when it sets out, the application has established us through a process and then have done what they said they will do. There are details on the numbers of people attending the number of website clicks and engagements, there is line by line detail of the issues and concerns raised and in general where the applicant believes such issues are addressed in their extensive material, there is an age breakdown of who provided the feedback from 142 received which is a tiny fraction of people in this area. Despite all this work and all these pages, nowhere are their answers to simple questions such as What has been the effective reach of consultation, how well is the proposed development understood in the area and what public support is there for such a scheme?

We would therefore welcome the opportunity of an issue specific hearing to consider this topic in detail.

The second point is about the quality of material produced by the applicant and the extent to which the applicant appears to be able to provide their own partial evidence with which to convince the examining authority of their case, I'll provide a few examples. The first day of concern we have is a statement of need, which chooses to avoid a description of what output solar produces and overall terms 9% 11% In the UK, this is not properly explained anywhere in the document to be the upper limit of the scheme's annual output, thereby reducing 500 megawatts of capacity to 55 megawatts on average. The applicant also avoids any description of how the output of solar is mismatched, with demand producing most when the country needs least, and nothing when the country needs it most. It is therefore spectacularly selective of for the applicant to conclude that solely contributes to the UK security of supply emitting to answer the the obvious question, what happens when the sun doesn't shine. The statement of need doesn't describe the fundamental problems of solar causes by having a mismatch between its output and the demand curve curve on the need for curtailment le been switched off by the grid operator, because there is more power being generated than can be used. The statement of need includes a graph of solar gain in the UK to describe the area as having high levels of solar irradiation. When patiently the UK is one of the lowest areas of solar gain worldwide. The statement of need includes a sorry, I've read that sorry the statement of need it provides a selective presentation of government policy. Despite mentioning the very recent ambition of 70 gigawatts of solar, there is no reference to the consistent position over many years to require efficient land use, community engagement and delivery of rooftop solar.

such tricks are designed to create an impression of benefit or support. The statement of need presents itself as the evidence base to justify the scheme but it is fundamentally flawed document. within various chapters of the environmental statement, the applicant has made careful selection of its study areas and ranges of impact, to enable it to conclude that the effects of development on minor in nature. For instance, the applicant has chosen for its landscape of self assessment an eight kilometer radius for the main study area, which then specifically excludes a Lincoln cliff area of great landscape value just beyond this boundary. By contrast, the applicant has chosen the whole of West Lindsay and Basset law almost 1800 kilometers squared to consider the socio economic effects, avoiding any reference to severe deprivation in Gainsborough, the main population center immediately adjacent to the scheme only three kilometers away. In the same chapter, the environmental statement the applicant has chosen extremely narrow reference area down to 500 meters to consider the other impacts, such as the impact on amenities or residential properties. These examples demonstrate that the applicant has drawn up his own terms of reference, and details of methodology to be able to arrive at conclusions from the impact assessments that suit its objectives with the words like limited or minor impact, such tactics appear to continue in responses to the first written questions raised by the examining authority. The applicant was asked about the Skidmore review directly. The applicant's reply includes the quote that

the review calls for a rooftop revolution to achieve so full scale deployment of solar the applicant then describes how the government's 70 gigawatt target would require 110 such similar

My second point, decommissioning at the end of the life of the solar industrialization, the cost of the decommissioning would have to be met. Will the cost be met by the developers as part of the application or pass down the ownership chain? So the ownership chain cease trading? How will this be covered? Or will it be passed back to the landowner or local council? Can the applicant detail the projected decommissioning cost and where the responsibility will lay for this application? Or will they expect to consider a decommissioning bond prior to starting the project to reduce impact on the future Community Living adjacent to the development of a third point, local land, the method of measuring the potential productivity of agricultural land has been based upon a grading system that dates back to 1988. It is acknowledged that this measurement is no longer accurate due to farming methods, climate change, etc. There is a phrase being BMV best and most versatile, however, this phrase as a little science behind it. Food security is now known as a weapon of war and around the world we're all experiencing these effects. With these facts in mind in focus, the real money measurement should be based upon yield from the land and the type of crops produced, does the

As a direct result. People are not engaging in the formal examination progress process, because they feel there is no point is a done deal. The 1000s of pages of documents to read to comply with overlap overlapping deadlines for the poor projects make it unfairly prejudicial to those trying to earn a living and whose daily lives will be affected for the next 65 years by the decisions whether to allow the projects. It's compounded by their difficulties in finding information, I still cannot find the vegetation removal plan for this project, consisting of 13 sheets referred to in shedule 17 of the draft DCO as amended can't find it. The effects on mental health in addition to a feeling of hopelessness about the outcome are becoming apparent in our communities. The worry about the drop in house prices, and already the reality of house sales falling through. Where is there a detailed evaluation of the effects on house prices of the proximity of the construction routes in batteries, cable corridors with the potential for EMF issues and being surrounded by fields of panels.

Has Lincolnshire highways been consulted about any plan to major works in the area to ensure that any alternative routes to the ones affected by the projects will not be further affected by planned closures or works.

Gate Burton construction period first quarter 2025 The first quarter 2028 is in fact 36 months and not the 24 months repeatedly referred to as the worst case scenario. So all of the negative effects of the construction period on the local population from this project, plus the community of effects of the other three projects will last half as long again, how can the applicant conclude that a longer construction period would have less impact on the community? You raise that very point in your written questions, sir. And the applicants response to page 141 merely acknowledged that the post proposed timescale would result in a continuation of defects identified, but for their purposes, they viewed 24 months as a worst case scenario. So that's what's applied in their predictions of impacts on us. In Table 14.7, under does the proposal prioritize it encourage walking the applicants ticked? Yes, I fail to see how anyone could reach that conclusion. Just because there are very few public rights of way included in the works area around Martin Gilbert and William how does that translate to the effects on the promotion of walking automatically big deemed negligible. The road from Willingham to gate Burton is a popular walking, running, cycling and horse riding route which connects public rights away. Parts of it has been the route on the annual stoke Community Bike Ride for many years, chosen for its family friendly safety safety levels. It's a single carriageway road with passive places boarded along the majority of its length by mature hedges. The proposal to use it as a construction route would result in a significant effect on the health, wellbeing and exercise opportunities of local residents. The panel's mounting polls, inverters and transformers will be recycled or disposed of in accordance with good practice and market conditions at the time. Does this mean that if the cheapest option available at the time of decommissioning is landfill, that's where they will go? Where is any enforceable provision for the applicant or its successors in title to recycle as much of the apparatus as is technically possible at the time of decommissioning regardless of cost? Otherwise, it makes a mockery of any arguments about the beneficial carbon footprint of the scheme. How will it be decided? Whether the medium voltage cambric cables will be left in situ at decommissioning? How can leaving these in the earth to rot decompose affect the surrounding land and its future views be justified? Finally, another concern is the cumulative effect of the influx of project workers on local, temporary or short term accommodation. There is a dire shortage of rental property in the area and any project staff taking rentals will exacerbate that problem, leaving locals with no affordable rental options. I've already questioned in a written submission, the way in which the applicant concludes that there is no effect on the local hotel b&b accommodation sector by the workers from this and the combined projects due to their selective use of data. But where is the analysis of short term rentals in the applicants documents
