1. Introduction

<u>1.1</u> Purpose of this Document

- 1.1.1 This Statement of Commonality (this "Statement") relates to an application made by Gate Burton Energy Park Ltd (the Applicant) to the Planning Inspectorate (PINS) on behalf of the Secretary of State for the Department for Energy Security and Net Zero under Section 37 of the Planning Act 2008 (PA 2008) for a Development Consent Order (DCO). If made, the DCO would grant consent for the Applicant to develop the Gate Burton Energy Park (the Scheme). A detailed description of the Scheme can be found in Chapter 2: The Scheme of the Environmental Statement [APP-011/3.1].
- 1.1.2 This Statement has been prepared to provide the Examining Authority (ExA) with the current position on Statements of Common Ground (SoCG) between Gate Burton Energy Park Ltd and prescribed consultees, statutory undertakers and interested parties ("other parties").
- 1.1.3 It is the Applicant's intention to update this Statement during the course of the Examination as a record of progress that is being made with the various SoCGs. When sufficient progress has been made on agreements between parties, this document will also discuss areas of commonality between parties to enable efficient resolution of remaining issues.

5. Principal Matters

- 5.1.1 The following section provides a narrative on the specific topic areas which are the subject of on-going discussion with key stakeholders (i.e there is not yet agreement). This section provides the ExA with a summary of the position on the outstanding matters with this section arranged by topic. Where relevant, cross referencing will be made to specific SoCGs.
- 5.1.2 The focus of Section 5 is to summarise the current or final positions of respective Parties on the identified key issues in order to aid the ExA.

5.2 Lincolnshire County Council

- 5.1.35.2.1 LCC has worked proactively with the Applicant throughout the development of the Scheme. LCC objects to the Scheme and discussions are ongoing to narrow the areas of disagreement.
- 5.1.4<u>5.2.2</u> Discussions with LCC are ongoing and areas of agreement were identified following a meeting held with LCC on 5 July 2023. <u>The Applicant and LCC discussed the SoCG at a meeting held on 13 November 2023 which further narrowed items under discussion. The draft SoCG submitted at Deadline 5 reflects these discussions and identifies where agreements have been reach and where parties have agreed to disagree. The Applicant and LCC will discuss the last items under discussion in advance of Deadline 6. The parties agreed that Deadline 4 would be an appropriate deadline to submit a revised draft because it could then incorporate matters from the Local Impact Report, be after the hearings and the Applicant can fully address LCCs comments. There have also been ongoing discussions on the Draft DCO and access designs that the Applicant hopes to be able to agree and document at Deadline 4.</u>

<u>5.3</u> West Lindsey District Council

5.1.55.3.1 Discussions with WLDC are ongoing, with currently no further updates to the document submitted at the application stage **[APP-200/4.3A]**. Therefore, an updated version has not been <u>submitted</u>. The Applicant and WLDC met on 15 November 2023 with a further meeting arranged on 30 November to discuss the draft SoCG. The Applicant and WLDC will work proactively to submit a final signed SoCG at Deadline 6. The Applicant will incorporate WLDC's LIR **[REP-053]** comments into the draft SoCG at Deadline 4.

5.4.1 This document has been updated to reflect the ongoing discussions with NCC and BDC. Following a meeting held with NCC and BDC on 9 March 2023, matters were agreed including on the following topics: design principles, climate change, cultural heritage, water environment and flooding and noise and vibration. The Applicant Applicant, NCC and BDC have worked proactively to close most matters under discussion with agreements reached on the majority of items. Only one area of disagreement has been identified in respect of what is considered to be a reasonable worst case scenario in relation to cumulative impacts on landfill sites in Nottinghamshire. These discussions are reflected in the version submitted at Deadline 5. The Applicant, NCC and BDC will finalise this SoCG for Deadline 6. will incorporate comments from NCC's and BDC's Local Impact Report and aim to submit a revised document at Deadline 4.

5.5 - Environment Agency

- 5.2.15.5.1 The Applicant and the Environment Agency have made great progress in negotiations since submission of the Application and a signed Statement of Common Ground has been submitted at Deadline 1. Matters which have been agreed between parties include Environmental Permitting, Water Framework Directive, Flood Risk, Aquatic Ecology and Water Quality. In particular, the Applicant has provided more detailed assessment on the proposed approach to culverts and there is now no disagreement between the parties on this matter.
- 5.5.2 The only remaining matter for discussion between the two parties is on Protective Provisions, which is expected to be agreed shortly. Given that the Protective Provisions will be included in the draft DCO and are expected to be agreed it is currently considered unlikely that future iterations of the Statement of Common Ground would be required to cover this matter.
- 5.2.25.5.3 The Applicant is discussing Electric and Magnetic Fields (EMF) with Environment Agency and aiming to reach agreement on this issue. When matters are agreed (or not agreed) the Applicant would aim to submit a revised Statement of Common Ground to record this progression.

<u>5.6</u> Historic England

5.2.35.6.1 All matters have now been agreed between Parties including no objection to the Scheme as presented in the Application. The parties are in agreement on the cultural heritage assessment, deposit modelling and impacts on identified heritage assets.

5.2.4<u>5.6.2</u> A final signed SoCG has been submitted at Deadline 1.

5.35.7 Natural England

5.3.15.7.1 Matters have been agreed through positive discussions between the Applicant and Natural England. This has included agreement on matters including Internationally and Nationally Designated Sites, ancient woodland

and ancient/veteran trees, Biodiversity Net Gain and agricultural land. Natural England has also agreed that there is no requirement for Protected Species licences associated with the Scheme. The document submitted at Deadline 1 reflects the ongoing discussions and continues to await comments and the Applicant expects to be able to submit a final signed version at Deadline 3. The Applicant has also requested a view from Natural England on EMF.

<u>5.8</u> Upper Witham IDB and Trent Valley IDB

5.3.2<u>5.8.1</u> The Applicant has agreed all matters in the SoCG with the Upper Witham IDB. A final signed SoCG has been submitted at Deadline 2. The Applicant is progressing discussions with Trent Valley IDB and will update on these discussions throughout the Examination. <u>parties..parties.</u>

5.4<u>5.9 Canal and Rivers Trust</u>

5.4.1<u>5.9.1</u> Discussions between the Applicant and the Canal and Rivers Trust are ongoing. As requested by the ExA, an initial draft SoCG was submitted at Deadline 1. A final signed SoCG was submitted at Deadline 3 with all matters agreed.

5.10 Anglian Water Services

- 5.4.25.10.1 Anglian Water Services requested that the Applicant prepares a SoCG in their Relevant Representation submission [RR-015]. An initial draft SoCG was submitted at Deadline 1 [REP-016/4.3J]. A final signed SoCG was submitted at Deadline 4 with all matters agreed.
- 5.4.35.10.2 In addition to discussions on existing utilities, the Applicant has been discussing the potential for a mains water connection to the site to provide water in the unlikely event of a fire at the battery storage area of the site. The Applicant will update on these discussions throughout Examination. This connection is optional because the Application proposes water tanks on the site that will provide an alternative source of water in an emergency. This position does not therefore need to be finalised pre-consent.

5.11 Cottam, West Burton and Tillbridge Solar-Projects

5.11.1 The Applicant has prepared a joint SoCG with the promoters of Cottam, West Burton and Tillbridge Solar Projects following the ExA's request in its Rule 6 Letter [PD-005]. A draft SoCG between the parties was submitted at Deadline 1 to capture the initial discussions. Further information on joint working and discussions between the parties was provided in the Joint Report on Interrelationships between Nationally Significant Infrastructure Projects [document 8.26] and its previous iterations.
