Good morning

This representation is provided on behalf of Tillbridge Solar Ltd in respect of the latest version of the draft Gate Burton Development Consent Order (“Draft Gate Burton DCO”) being provided to the Examining Authority in accordance with today’s Deadline 6.

Tillbridge Solar Ltd confirms that it has reviewed and supports the amendments to the protective provisions included in its favour at Part 14 of Schedule 15 of the Draft Gate Burton DCO. We note that these provisions include placeholders throughout in respect of the final Work Number for the Area within which there will be overlap between the Tillbridge Order limits for the cable corridor and the Gate Burton Order limits for the cable corridor, once Tillbridge Solar Ltd’s respective DCO application is submitted and accepted. Tillbridge Solar Ltd is expected to submit its DCO application in March 2024, with acceptance anticipated in April 2024, which we note is subsequent to the end of the Gate Burton Examination period. As such Tillbridge (along with Gate Burton) proposes that it will update the Secretary of State in April 2024 (following Tillbridge DCO acceptance) as to the final details for the Area of overlap to be included within the Tillbridge protective provisions in the Gate Burton Order.
