Good Afternoon,

I write to respond to point 7 of the letter dated 29 April 2024 from the Department for Energy Security & Net Zero.

Unfortunately at this time the Protective Provisions have not yet been agreed. The Board was issued with a draft Statement of Common Ground and subsequently (all be it relatively recently) issued a pro forma for protective provisions to the applicant for consideration. This document was returned with substantial proposed redactions. As the proforma document is drawn from a previous agreement signed up to by the Water Management Consortium there is some concern with regard to the proposed removal of wording. Therefore, the Board have sought legal advice and I can advise that the Boards Solicitor has been in contact with the applicants representatives with regard to this matter.

I apologise for the delay but as the Statement of Common Ground is suggesting the disapplication of powers there needs to be comfort that there is no risk to the Board as a result of the development.
