West Burton Solar Project

Notice of proposed application for a Development Consent Order pursuant to Section 46 of the Planning Act 2008

West Burton Solar Project Limited (“The Applicant”) intends to build a solar and energy storage project located within the administrative boundary of West Lindsey District Council and Lincolnshire County Council and the administrative boundary of Bassetlaw District Council and Nottinghamshire County Council (“the West Burton Solar Project”).

The West Burton Solar Project will consist of:

- a. West Burton 1, 2 and 3: three solar array sites located east of the River Trent, south of the A1500 and north of Saxilby, in the district of West Lindsey, Lincolnshire including solar panels, conversion units, inverters and 132kV substations.
- b. West Burton 4: a solar array site located between the villages of Clayworth and Gringley on the Hill, in the district of Bassetlaw, Nottinghamshire including solar panels, conversion units, inverters and 132kV substation.
- c. West Burton 400kV Substation and energy storage facility located to the northwest of West Burton Power Station;
- d. Underground electricity cables connecting West Burton 1 to 4 to the West Burton Substation and from there to the National Grid substation at West Burton Power Station; and
- e. Associated infrastructure, mitigation and enhancement measures, and other ancillary works, for example, fencing, security, local grid connections, temporary access roads, permanent means of access, highway works, temporary works compounds and work sites.

The Applicant is part of Island Green Power.

The Applicant intends to make an application to the Secretary of State for a Development Consent Order (“DCO”) for the West Burton Solar Project. The DCO application will contain full details of the West Burton Solar Project and will be accompanied by an Environmental Statement in accordance with the 2008 Act and the 2017 Regulations.
