West Burton Solar Project

Statutory Consultation

Section 42 of the Planning Act 2008 ("the 2008 Act") and Regulations 11 and 13 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 ("the 2017 Regulations")

West Burton Solar Project Limited ("The Applicant") intends to build a solar and energy storage project located within the administrative boundary of West Lindsey District Council and Lincolnshire County Council and the administrative boundary of Bassetlaw District Council and Nottinghamshire County Council ("the West Burton Solar Project")

The West Burton Solar Project will consist of:

- a. West Burton 1, 2 and 3: three solar array sites located east of the River Trent, south of the A1500 and north of Saxilby, in the district of West Lindsey, Lincolnshire including solar panels, conversion units, inverters and 132kV substations.
- b. West Burton 4: a solar array site located between the villages of Clayworth and Gringley on the Hill, in the district of Bassetlaw, Nottinghamshire including solar panels, conversion units, inverters and 132kV substation.
- c. West Burton 400kV Substation and energy storage facility located to the northwest of West Burton Power Station;
- d. Underground electricity cables connecting West Burton 1 to 4 to the West Burton Substation and from there to the National Grid substation at West Burton Power Station; and
- e. Associated infrastructure, mitigation and enhancement measures, and other ancillary works, for example, fencing, security, local grid connections, temporary access roads, permanent means of access, highway works, temporary works compounds and work sites.

The Applicant is part of Island Green Power.

The Applicant intends to make an application to the Secretary of State for a Development Consent Order ("DCO") under the 2008 Act for the West Burton Solar Project. The DCO application will contain full details of the West Burton Solar Project and will be accompanied by an Environmental Statement in accordance with the 2008 Act and the 2017 Regulations.

Consultation on the West Burton Solar Project

The West Burton Solar Project is currently in the pre-application stage. As part of that process the Applicant is required to carry out consultation on the proposed DCO application





before it is submitted. Your feedback as part of this consultation will be considered before the Applicant finalises its DCO application and will also be reported to the Planning Inspectorate when the application is submitted. Any representations you have already made will also be reported.

We are writing to you as you have been identified as a consultee for the purpose of section 42 of the Planning Act 2008/or Regulation 11 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017, or it has been decided it would be appropriate to consult in any event.

This consultation includes:

- Consultation with prescribed bodies, host and neighbouring authorities (under section 42 of the 2008 Act);
- Consultation with any persons with an interest in the land affected by West Burton Solar Project (under section 42 and section 44 of the 2008 Act);
- Consultation with the local community in the vicinity of West Burton Solar Project (under section 47 of the 2008 Act); and
- General public consultation on West Burton Solar Project (under section 48 of the 2008 Act).

This consultation will run from 15 June 2022.

In addition, section 48 of the 2008 Act and Regulation 13 of the 2017 Regulations require the Applicant to publicise its proposed DCO application. A formal notice publicising the proposed application is therefore enclosed with this letter and sets out further details regarding the consultation.

Consultation materials

The Applicant has prepared a Preliminary Environmental Information Report ("PEIR"), which has been informed by the Scoping Opinion issued by the Planning Inspectorate and which reports the results of the Environmental Impact Assessment ("EIA") that has been carried out to date. The PEIR forms the basis of this consultation and also includes a non-technical summary. The purpose of the PEIR is to enable consultees to understand the likely environmental effects of the West Burton Solar Project and to help inform consultation responses. It should be noted that the EIA is an ongoing process and the design of the West Burton Solar Project will continue to evolve during the pre-application stage.



Section 42 of the Planning Act 2008 ("the 2008 Act"), Regulation 3 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 and Regulations 11 and 13 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 ("the 2017 Regulations")

The Proposed Scheme

West Burton Solar Project Limited ("the Applicant") is developing proposals for a new solar and energy storage project that would cross the county border between Lincolnshire and Nottinghamshire.

These proposals involve the generation of renewable power through solar photovoltaic (PV) panels. This clean energy would then be connected to the National Grid at West Burton Power Station to power UK homes, with the facility to store some of this energy on site for when it is needed most.

The West Burton Solar Project ("the Project") is named after its grid connection point at the existing National Grid substation at the West Burton Power Station. The West Burton Solar Project will consist of:

- West Burton 1, 2 and 3: three solar array sites located east of the River Trent, south of the A1500 and north of Saxilby, in the district of West Lindsey, Lincolnshire including solar panels, conversion units, inverters and 132kV substations.
- West Burton 4: a solar array site located between the villages of Clayworth and Gringley on the Hill, in the district of Bassetlaw, Nottinghamshire including solar panels, conversion units, inverters and 132kV substation.
- West Burton 400kV Substation and energy storage facility located to the northwest of West Burton Power Station;
- Underground electricity cables connecting West Burton 1 to 4 to the West Burton Substation and from there to the National Grid substation at West Burton Power Station; and
- Associated infrastructure, mitigation and enhancement measures, and other ancillary works, for example, fencing, security, local grid connections, temporary access roads, permanent means of access, highway works, temporary works compounds and work sites.

The Applicant intends to make an application to the Secretary of State for a Development Consent Order ("DCO") for the West Burton Solar Project. Consultation on West Burton Solar Project

West Burton Solar Project is currently in the pre-application stage of the DCO application process. As part of that process, the Applicant is required to carry out consultation on the proposed DCO application before it is submitted. We have previously undertaken one round of non-statutory consultation between 03 November 2021 and 15 December 2021 (referred to as phase one). The non-statutory phase one consultation introduced the project to consultees and primarily asked for feedback to help identify and better understand any local impacts of the West Burton Solar Project.

This current, statutory consultation is our phase two consultation and is being undertaken under sections 42, 47 and 48 of the 2008 Act and your feedback as part of this consultation will be considered before the Applicant finalises the DCO application. Your feedback will also be reported to the Planning Inspectorate in a Consultation Report when the application is submitted. Any representations you have already made in response to our phase one consultation will also be reported.
