#### Schedule of changes to submitted documents

A new Schedule of Changes **[EN010132/EX1/WB8.1.8]** sets out revisions made to previously submitted documents and the reasons for those changes.

### Detailed schedules of changes to the draft Development Consent Order and the Land Plan

The Schedule of Changes **[EN010132/EX1/WB8.1.8]** contains detailed schedules setting out all changes to the draft Development Consent Order and to the Land Plan.

#### **Planning Statement**

On 22 November 2023, the Department for Energy Security and Net Zero published a suite of revised Energy National Policy statements. The Applicant is reviewing these versions and will update the Planning Statement at Deadline 2 to reflect this. This updated version will also include the adopted Central Lincolnshire Local Plan 2023. It is noted that the documents being submitted at this deadline still refer to the draft NPSs that were published in March 2023.

#### **Schedules of progress**

As requested in the Rule 8 letter, the Applicant is submitting a Schedule of progress regarding objections and agreements in relation to Compulsory Acquisition, Temporary Possession, other land rights, and blight **[EN010132/EX1/WB8.1.12]** and a Schedule of progress regarding Protective Provisions and Statutory Undertakers **[EN010132/EX1WB8.1.14]**.

Section 1.5 ('Other consents and licences') of the Consents and Agreements Position Statement **[EN010132/APP/WB7.4]** has not been updated at this Deadline 1 as there have been no changes of note to report. The Applicant notes that, at present, as a result of baseline surveys and sensitive development design, the potential for impacts on the listed protected species is low and no clear need for protected species licensing has been identified at this stage. The Applicant's ecological consultants are keeping under review the potential need to



seek a protected species licence, and will apply for a licence in the usual way should it become necessary to do so. This approach is agreed with Natural England, as set out in response ECO-09 within the Statement of Common Ground with Natural England **[EX1/WB8.3.7]**.

#### Report on the interrelationship with other National Infrastructure projects

As requested in the Rule 8 letter, the Applicant is submitting an interrelationships report **[EN010132/EX1/WB8.1.9\_A]** between the Scheme and three other Nationally Significant Infrastructure Projects, Gate Burton Energy Park, West Burton Solar Project and Tillbridge Solar. The report has been prepared jointly with the applicants for the other schemes. It provides text and plans showing how the schemes relate to one another. The report sets out the approaches taken by the four developers to coordinate applications and reduce cumulative effects. It also explains the approach taken to the shared grid connection corridor, shared mitigation measures and an update on the assessment of cumulative impacts. As mentioned at ISH1, this is a live document and will be updated throughout the Examination to ensure that it takes into account the most up to date information.

#### Statements of Common Ground

The status of the Statements of Common Ground being agreed by the Applicant and other bodies is summarised in the Statement of Commonality **[EN010132/EX1/WB8.1.11]**.

#### Environmental impacts of a 60-year operational lifetime

The draft Development Consent Order has been updated to set the maximum operational lifetime of the Scheme at 60 years. At ISH1 on 9 November, the Examining Authority requested the Applicant to review the assessments made in the Environmental Statement. For each topic, a review of the potential significant effects has been carried out. The results are set out within a revised version of ES Chapter 23: Summary of Significant Effects (Revision A) **[EN010133/EX2/WB6.2.23\_A]** and explained in the Review of Likely Significant Effects at 60 Years **[EN010133/EX2/WB8.2.3]**.

#### **Environmental Statement Addenda**

Where information that is additional or supplementary to the Environmental Statement has been requested or provided, addenda to the Environmental Statement are being submitted as new documents.

The Applicant has submitted updated versions of some Environmental Statement chapters, where errors in the chapters originally submitted have been identified that needed to be updated.

#### Withdrawal of document

The Outline Soil Management Plan was submitted as two identical documents, one as Appendix 2 to Chapter 19 of the Environmental Statement **[APP-138]** and one as a standalone document, 7.16 **[APP-325]**. The Applicant wishes to withdraw the stand-alone version of the document **[APP-325]**.
