Notice of variation to the Examination Timetable and Hearing

We are writing to provide notification that the Examining Authority (ExA) has made a Procedural Decision to vary the Examination Timetable. For Issue Specific Hearings Interested Parties (IPs) may be invited to make oral representations at the Hearing on the specific issues being examined at the Hearing as set out in the Agenda.

All Hearings are recorded. The recordings and transcripts will be made available on the project webpage as soon as practicable following the Hearing. The recordings allow any member of the public who is interested in the application and the Examination to find out what has been discussed at a Hearing.
