The hearings are being held primarily for the purpose of hearing from those who wish to speak in relation to the the applicant's proposed changes to the application. And I will shortly be asking the applicant, Pryde, a summary of those changes and how they impact on the applicant's case. Um, but before I do that, could I ask, um, who is here and who will be speaking on behalf of the applicant, please?

Good morning. Um, my name is Claire Broderick. I'm a legal director at Pinsent Masons LLP, solicitors for the applicant, West Burton Solar Project Limited. So I'll let them introduce themselves if they are required to speak at any point during during today's hearing.

A clever trick for the applicant. Um, details of the applicant's, um, change application are set out in the Change Application and Consultation report, which is document reference as Dash 056. Um, this um, describes in detail in section three the five um proposed changes. Um, which I'll just summarise now. Um, change one is an extension of the order limits along the highway from the West Burton one

site to the A1 500 Bridge Lane, to the north of Brock's home, in order to facilitate access to the site during the construction phase.

Change two is an extension to the order limits, uh, to the east of the Lincoln Gainsborough Railway line within Stowe Park to allow for flexibility in relation to the um separate proposal being submitted for another solar farm under the town and country Planning Act regime. Um at Stowe Park Farm uh change five is an extension to the order limits along the Lincoln Gainsborough Railway line within the West Burton three site, to allow for flexibility in relation to the construction of the cable cable underneath the railway.

Change four is a small extension to the order limits along the A1 five six High Street Martin, in proximity to the cable route corridor construction. Access point reference AC 110. In relation to the provision of a visibility splay and change five is an extension to the order limits to include the existing main vehicular access to the West Burton Power Station from Gainsborough Road, and that's to provide access during both the construction and operational phases, uh, to the National Grid, a substation site.

As part of the change application, uh, the applicant prepared a supporting environmental information report that's document reference as 057, um, that considers the conclusions of the environmental statement submitted with the DCO application in relation to the proposed changes, and in particular, whether there are any changes to the potential significant effects compared to those reported in the original environmental statement for the scheme. Uh, the Supporting Environmental Information report concludes that there are no new or different likely significant effects of the change.

Application and consultation report also sets out, um, the engagement that the applicant applicant has undertaken with both um stakeholders, including uh, local authorities, and also engagement with landowners who are affected by the proposed um changes. So, um, we understand that the UK Atomic Energy Authority has an interest in the land at West Burton site for the development of the the Step project, um, which we understand to be a project that will demonstrate the ability to generate energy from fusion.

And your representation is set out that so far the early investigations are focused on site characterization, which was found at the site and is constrained by various environmental sensitivities and also the need to coexist with other users. And we also understand that this this baseline investigation type work will continue for a further two years to inform site master planning. And and so therefore, at this point, there's no certainty about the location of plant within the site and that in fact won't be fixed until around 2027.

So until this time, the, um, the UK Atomic Energy Authority seeks to retain flexibility in order to to optimize plant's location. And again, as we understand it, um, the UK Atomic Energy Authority doesn't object in principle to the scheme, but in the absence of a voluntary agreement with the applicant, is seeking protective provisions in the developed consent order. Um, and in that respect, I understand that um, engagement between the parties has, um has, has been taking place. Um, so, so just does that reasonably set out your case or are there any points of correction or clarification that you'd like to make for us?

Um, as things stand, however, our position is that the compulsory acquisition powers over our land, um, is over. Land in which we hold an interest isn't justified in circumstances in which we are willing to grant rights on a voluntary basis.

Um, and the second point is just to highlight that, as you will have seen, madam, we provided some protective provisions that were appended to our further representations there in draft. And we are working with the applicant to hopefully reach a point of agreement. But there is one point that, um, we're not in agreement on, and that is paragraph five in those protective provisions. Um, and that is about, um, effectively exercising the powers, um, in agreement with ourselves. Um, and at the moment the applicant hasn't agreed to that, um, on the basis that they need to reach an agreement with the freeholder of the land, EDF.

And just as things stand, that's not acceptable to us. Um, we say that that needs to be included in the draft DCO in advance of and notwithstanding any progress made in respect of an agreement with um EDF as a as a minimum reasonable safeguard to protect our interests because of the significance and importance of the site and the project.

All right. Thank you. That's. That's helpful.

So in terms of, um. The site specific information. At this stage of looking at the, um, the area impacted, um, uh, it appears that it's plot ten um, ten um, one eight, four seems to be the main area.

So thank you. Um, Mr. Corbett, if you just turn on your microphone and your camera, that'd be really helpful. Thank you.

At the moment, there are huge technical, technological engineering challenges which we need to resolve. And there's going to be new ones coming down the line, which are unforeseen at the moment. But what we have at the moment is we have a site that is, uh, was carefully chosen as being the best available site, but it does come with a lot of, uh, challenges.

Um, and one of the challenges, as you mentioned in your summary at the beginning, the environmental challenges and also the fact that we need to coexist with other users. Um, so they include National Grid, they include, uh, West Burton Energy, they'll include other solar farms, who we are talking to who have similar needs, and we are working actively with them to make sure that we can all coexist on the site and work in a, um, a, uh, a good collaborative manner. Um, but at the moment, um, we don't have any specific laydown areas, but a key demand of the project is that we maintain flexibility.

So when we do go into the more detailed design phase, we don't become constrained unnecessarily by, uh, things that we cannot move. So all the agreements we are looking for are the ability to, uh, lift and shift and to work together to look for solutions in a collaborative manner and not to be restricted by land which we might not have access to in the future, that could, uh, create, uh, serious impediments to the success of our project.

All right. Thank you, Mr. Colby. That's helpful. Um, are you able to say any more about the sort of timeline that you're working to? I know, I know, in summary, I've seen reference to things not being fixed until 2027. Is there anything more specific you can say in terms of the progress towards that, the milestones you're hoping to go through?

Um, yeah. So we're currently doing the environmental baseline studies. We're doing the Geological Survey's, um, this is going to be a major, uh, you know, the size of the project is going to be something similar to, uh, maybe Sizewell C, uh, you know, a major nuclear plant. Um, so there's a lot

of geotechnical, um, risk assessments we need to do, uh, understanding the, uh, the ground structure. Um, and that's going to determine very much where the plant goes along with the environmental considerations. So we're intending to have all these studies being done over the next 2 to 3 years so that we can have a, a firm layout fixed by around about 2027 to start construction in early the early 2030s.

And then the plant will be operational. The aspiration is to get it in the early 2040s. Uh, the plant actually running. So it's a very long time. Scales, uh, very hard to sort of say where are we going to be in 20 years time? And that's really what we're just looking for, is not to constrain ourselves in these early, uh, that could own these early, uh, periods that could harm us ten, 15 years, even down the line.

It says one through eight. So just just something to note there. And I'll note this is an action point. Okay.

Thank you. So, um. Unmistakable. You've set out that, um, that there is discussion with the applicant and there seems to be there's a there's a sticking point over paragraph five on the protective provisions. So at this point, I think it will be helpful to ask, um, the applicant to, to, to comment on, on where things are up to and, and where things might, might proceed from here. So, Mr. Broderick, are you able to assist with that?

A clever project for the applicant. Yes. As Miss Noble said, um, the applicant has been engaging in discussions with uh, UK, aa both in terms of the, um, sort of practical technical alignment of the cabling in this area and also in relation to um, protected provisions. Um, as you will have seen, um, from the plans, um, the area to the immediate south of the National Grid substation is is very constrained.

There are a number of overhead lines and pylons coming into that substation. Um, and the cable route needs to navigate its way through. We believe we have, um, a route that has been, um, considered acceptable both to, um, EDF, who are the current landowners, um, and also, um, UK, EEA. We obviously do need to retain, however, some flexibility because there is the potential for National grid, um, to change the location of the bay, um, that the cable comes into.

And that's why, um, the order limits are fairly wide around the National Grid substation to provide that flexibility in case National Grid, um, decides we need to connect into a different a different bay. Um, my understanding is that there isn't at the moment any intention, as part of Ucaas plans to relocate National Grid to Substation um as part of their proposals. And therefore, what we're looking at is ensuring that the location of the cable within that area to the sort of small area to the south of the

site, um, is acceptable to UK and the protected provisions that we've been discussing, and that will be included in the deadline six version of the draft DCO, um, require the applicant before it carries out any works to, uh, submit details of um, the exact location of the cable um to UK for approval before it does any of the works.

Um and that UK can impose um, any reasonable conditions that they might need in terms of obviously depth or, um, protective, uh, measures that they might need to facilitate their ongoing, uh, development proposals. Um, obviously it's noted that at the moment, whilst UK has the benefit of an option agreement over this land, it's not the current landowner. Uh, the landowner is EDF. Um, a voluntary property agreement is being negotiated with EDF, but at the moment we're unable to reach agreement on the commercial terms.

So the consideration that's due, uh, for that. So at the moment we it's not possible, um, to, for the applicant to, um, restrict or give up its compulsory acquisition powers because there, there isn't a voluntary agreement in place and UK are not able to grant that voluntary agreement because they're not currently the freehold owners of the land. Um, we are working, um, on putting in place hopefully a signed agreement, um, that will provide some further assurances to UK should it become the freehold owner of the land prior to the construction of the cable? Um, however, um, as the Secretary of State has already considered in a number of other decoders, um, there is a case for granting compulsory acquisition powers to ensure there are the correct property rights to enable a nationally significant infrastructure project to go ahead, and that can be done without causing serious detriment to, uh, the undertaking of statutory undertakers or um, in this case, future development proposals, because protective provisions provide a mechanism whereby consent needs to be given for the actual works themselves.

Um, and we'll provide details in the written summary. But the Secretary of State has considered this issue both in the National Grid Hinkley Point C connection project order and then subsequently in the Immingham Open Cycle Gas Turbine Order um, which basically states that it is acceptable and reasonable for compulsory acquisition powers to be granted. Um, assuming that there are those protections in terms of the actual technical nature of the works provided in protective provisions.

So at the moment, in the absence of a voluntary agreement with EDF as landowner, the applicant's position is that it does need to retain compulsory acquisition powers to ensure deliverability of the scheme, but that it feels the protected provisions provide adequate protection for UK future development plans. Thank you.

All right. Thank you, Miss Broderick. Okay, so I can obviously see that work has been undertaken, but there are various um, elements to this which do complicate matters. So yes, miss, Miss Noble, what would you like to say in in response?

Thank you madam, if I just made briefly respond, respond to that. Um, as things stand, um, obviously, as Miss Broderick said, there isn't an agreement with EDF as the freeholder, which means that as things stand, the compulsory acquisition powers would bite against us. And without the paragraph five, effectively, we're in a position where they have compulsory acquisition powers that don't allow for a kind of lift and shift. So we are still, um, effectively we're going to be prejudiced by, um, potentially the inability to reach an agreement with EDF, and therefore it is our position that we still need the paragraph five in our draft protective provisions to protect our position at this stage.

Um, and negotiations are ongoing still with EDF in respect of a voluntary agreement for that site, both for, um, the Cottam solar project, but also for the other projects that are connecting in to um Cottam Power Station being Gate Burton um, and the recently submitted Taylor Bridge project.

And can I ask, Miss Broderick how you respond to that, that particular point, what your wiews are on that?

So the protected provisions cover a range of different matters, including approval of plans, as I've just mentioned.
