1 Introduction

1.1 Purpose of this Document

- 1.1.1 This document has been prepared to provide the Examining Authority (ExA) with the latest position on Statements of Common Ground (SoCG) between West Burton Solar Project Ltd. (the 'Applicant') and statutory consultees, statutory undertakers and other Interested Parties (the 'parties') in relation to the proposed West Burton Solar Project (the 'Scheme').
- 1.1.2 This document provides a position on the commonality on specific points between SoCGs at Deadline 56 (being 1130 April 2024).
- 1.1.3 The Applicant will, for each deadline during the course of the Examination, update this Statement as a record of the progress being made with the various parties. When sufficient progress has been made on agreements between parties, this document will also discuss those areas of commonality between parties to enable the efficient resolution and focusing in on the remaining issues.

1.2 Structure of this Document

- 1.2.1 This Statement of Commonality is structured as follows:
 - Section 2 details the structure of each SoCG document. Table 2.1 provides a
 full list of SoCGs being produced and offers an overview of the status of each
 SoCG being submitted to each Deadline;

2 Statements of Common Ground

2.1 Structure of SoCGs

- 2.1.1 Each SoCG adopts a standard format to ensure consistency in the approach taken to documenting those matters agreed, matters subject to ongoing discussion or matters not agreed.
- 2.1.2 Each SoCG is structured as follows:

3 Commonality

Therefore, where the Applicant considers there to be a high degree of certainty over matters being agreed and is waiting for confirmation, they are marked as green in **Table 3.1.**
- 3.1.5 Following the Summary of Commonality in **Table 3.1**, **Section 3.2** outlines the principal outstanding matters which are subject to further discussion before a final position can be reached.

4 Positions at Deadline 56

4.1.1 This section provides a summary of the position reached across all SoCGs being progressed and submitted to Deadline 56. The Applicant will continue to engage with those parties through the examination on matters which are ongoing.

4.2 Lincolnshire County Council

- 4.2.1 The matters recorded in the SoCG have been subject to discussion, through monthly catch ups, between the ApplicantThe Applicant has progressed discussions since Deadline 5 and the Host Authorities as well as SoCG which is submitted at Deadline 6 [EX6/WB8.3.1 A] is in the form that the agreed SoCG will take. The signed version will be submitted at Deadline 7. The SoCG includes agreement on all matters except some topic specific meetings e.g. matters relating to the principle of development, landscape and visual impact. Detailed discussions on cultural heritage matters, highways, soils and agriculture and waste management. These matters have also taken place.
- 4.2.2 The Applicant has been party to the discussions that have taken place between agreed in part with the Host Authority and Council as detailed within the Cottam Solar Project applicant. The discussions on the Cottam Solar Project SoCG have established the position of the Host Authority SoCG and the Applicant on matters, of which many are applicable to the Scheme. This includes separate position statements on the accompanying Cultural Heritage and Landscape topics which will be appended to the SoCG, as has been agreed on Cottam Solar Project. The Cultural Heritage and Visual Position Statement is still being updated and will be submitted into the Examination as soon as possible but follows the same principles as was agreed in the Cottam Solar Project position statement [EN010133/REP6-006].
- 4.2.3<u>4.2.1</u> The Applicant has prepared a draft SoCG which is based on the principles agreed through the Cottam Solar Project appendices to the SoCG, including any relevant updates specific to the Scheme. The only item that is still under discussion relates to ecology and biodiversity residual effects and waste assessment scope and policy.
- 4.2.4 The Applicant is waiting for comments back on this draft but is confident that given the principle that were agreed on the Cottam Solar Project this draft will closely reflect the finalised version that will be submitted at Deadline 6.

4.3 West Lindsey District Council

- 4.3.1 The matters recorded in the SoCG have been subject to discussion, through monthly catch ups, between the Applicant and the Host Authorities. The Applicant has submitted a draft to the party and is awaiting formal comments back. The matters listed as agreed in Table 3.1 are based on the Applicant's judgement on the high likelihood of them being agreed.
- 4.3.2 The Applicant has been party to the discussions that have taken place between the Host Authority and the Cottam Solar Project applicant. The discussions on the



- Cottam Solar Project SoCG have established the position of the Host Authority and the Applicant on matters of which many are applicable to the Scheme.
- 4.3.3 The main matters subject to further discussion relate to alternatives and design evolution, cultural heritage, ecology and biodiversity, landscape and visual impact noise, socio-economics, soils and agriculture, transport and access and the draft DCO.
- 4.3.4 The Applicant is waiting for comments back on this draft and will submit the finalised version at Deadline 6.
- 4.3.1 The Applicant has progressed discussions since Deadline 5 and the SoCG which is submitted at Deadline 6 [EX6/WB8.3.2_B] is in the form that the agreed SoCG will take. The signed version will be submitted at Deadline 7. Agreement has been reached with the Council on climate change, ecology and biodiversity, glint and glare and other environmental matters. Agreement in part has been reached on all other matters. The position of the Council and the Applicant on these outstanding matters is set out within the SoCG.

4.4 Historic England

- 4.4.1 Extensive discussions have been undertaken between the parties with agreement already reached on assessment and mitigation of all heritage assets, excluding the Medieval Bishop's Palace and Deer Park, Stow Park Scheduled Monument.
 - A final and signed SoCG is submitted at Deadline 6. All matters have been agreed except for matters relating to the Medieval Bishop's Palace and Stow Deer Park.
- 4.4.2 Historic England and the Applicant met on the 3rd April 2024 to discuss the Medieval Bishop's Palace and Deer Park, Stow Park Scheduled Monument (NHLE 1019229). Both parties agree that Figure 1 in **Stow Park Cultural Heritage Position Statement [EN010132/EX5/WB8.2.10]** shows the location of the three parts of the Scheduled Monument, the most likely boundary of Stow Park Deer Park with consideration to currently available information. Figure 1 also shows crops marks interpreted as having a potential medieval / post medieval origin, the possible early medieval settlement as identified during the evaluation for the Scheme and Stow deserted medieval village.
- 4.4.3 An updated draft of the SoCG has been shared with Historic England, with the parties agreeing that the finalised version will be signed for Deadline 6.

4.5 National Highways

4.5.1 All matters have been agreed between the parties by Deadline 1. A signed SoCG was submitted at Deadline 1 [REP1-064].

4.6 The Environment Agency

4.6.1 All matters are now agreed between the parties. The and a final and signed SoCG is awaiting signatures, the draft version is submitted at Deadline 5 [EN010132/EX56]



[EX6/WB8.3.5_A] and when the final version is available this will be submitted into the Examination.B].

- 4.6.2 One matter which was raised on Cottam through the ExA 3rd Written Questions (question 3.7.2 [EN010133/PC-017]) was in relation to the flood risk effects of an operating lifetime of 60 years as opposed to the 40 year period that has been assessed in the Flood Risk Assessment. On 21 February 2024, the Environment Agency confirmed that further data for the Tidal Trent is available from the Environment Agency which includes appropriate climate change allowances up to the 2080's epoch. Whilst this hasn't formally been raised for the Scheme, the Applicant is proposing to update the Flood Risk Assessment [APP-089] and its Appendices [APP-090 to APP-093]. The Applicant received the data on the 3rd April 2024 and is undertaking the process of updating the relevant reports.
- 4.6.3 In the event that it is It has not been possible to complete the modelling of the data in time to update the Flood Risk Assessment prior to the end of the Examination, it was agreed with the Environment Agency on a call on 21 February 2024 that the updated flood risk assessment should be submitted for approval prior to construction as this will ensure that appropriate mitigation is in place taking into account climate change allowances up to the 2080s epoch. —This is secured by Requirement 22 of the WB3.1 G Draft Development Consent Order Revision G [EX6/WB3.1 G].

4.7 Network Rail

- 4.7.1 The matters recorded in the SoCG have been subject to discussion between parties. The Applicant has submitted a draft to the party and is awaiting comments back. The matters listed as agreed in Table 3.1 are based on the Applicant's judgement on the high likelihood of them being agreed.
- 4.7.2 The Applicant has been party to the discussions that have taken place between Network Rail and the Cottam Solar Project applicant. The discussions on the Cottam Solar Project SoCG have established the position of Network Rail and the Applicant on matters of which many are applicable to the Scheme.
- 4.7.3 The Applicant is aiming to submit the finalised SoCG at Deadline 67 which will be based on the principles agreed through the Cottam Solar Project SoCG with any other relevant updates specific to the Scheme. The updated draft SoCG is currently with Network Rail for approval.

4.8 Natural England

4.8.1 All matters have been agreed between the parties at Deadline 5. A signed SoCG iswas submitted at Deadline 5 [EN010132/EX5/WB8.3.7_AREP5-023].



4.9 Nottinghamshire County Council & Bassetlaw District Council

- 4.9.1 The matters recorded in the SoCG have been subject to discussion, through monthly catch ups, between the Applicant and the Host Authorities. The Applicant had a meeting with both Host Authorities on the 14th November 2023 to agree on matters which can be moved from the "matters under discussion" table in the draft SoCG to the "matters agreed" table.
- 4.9.2 The Applicant has been party to the discussions that have taken place between the Host Authority and the Cottam Solar Project. The discussions on the Cottam Solar Project SoCG have established the position of the Host Authority and the Applicant on matters of which many are applicable to the Scheme.
- 4.9.3 The Applicant is waiting for comments back on this draft but is confident that given the principle that were agreed on the Cottam project this draft will closely reflect the finalised version that will be submitted at Deadline 6.
- 4.9.1 All matters have been agreed between the parties by Deadline 6 except cultural heritage which remain as 'Not Agreed'. Please refer to the Cultural Heritage Position Statement in the **Lincolnshire County Council SoCG [EX6/WB8.3.1 A].**

4.10 Lincolnshire Wildlife Trust

4.10.1 Extensive discussions have been undertaken All matters are now agreed between the parties with agreement already reached on and a number of issues as indicated in the draft document. There have been no further updates to the final and signed SoCG is submitted at Deadline 1 [REP1-069]. The Applicant is seeking to finalise the SoCG as soon as possible.6 [EX6/WB8.3.9 A].

4.11 Nottinghamshire Wildlife Trust

4.11.1 All matters have been agreed between the parties by Deadline 1. A signed SoCG has been submitted at Deadline 1 [REP1-070].

4.12 Gate Burton Energy Park, Tillbridge Solar Project and Cottam Solar Project

- 4.12.1 The parties have undertaken ongoing discussions as they progress through their respective Examinations and, in the case of the Tillbridge Solar Project, impending application submission. A signed version of the SoCG was submitted at Deadline 1 [REP1-071].
- 4.12.2 The parties have now reached agreement on the Joint Report on Interrelationships between the four projects [REP4-059]. The teams have reviewed the applications submitted by the other developers to compare sections on cumulative impacts and have continued to look for further ways to collaborate and reduce cumulative impacts (e.g. on access locations in the Shared Cable Route Corridor). The report is



the joint cooperation agreement and each Schemes' respective protective provisions for the benefit of other parties, are contained within the respective Schemes' draft Development Consent Orders.

4.13 Anglian Water

4.13.1 All matters have been agreed between the parties by Deadline 2. A signed SoCG has been submitted at Deadline 2 [REP2-018].
