It is the Applicant's position that if the Secretary of State was minded to grant development consent subject to the removal of these panels, the Applicant would be invited to submit the identified documents and Interested Parties invited to comment on them prior to the Secretary of State determining the DCO Application.

The Applicant noted that this was not amended at Deadline 1 when the change to the lifespan of the Scheme was made.
