Planning Act 2008 and The Infrastructure Planning (Examination Procedure) Rules 2010

Application by West Burton Solar Project Limited ("the Applicant") for an Order granting Development Consent for the proposed West Burton Solar Project.

REQUEST FOR INFORMATION

- 1. Following the completion of the Examination on 8 May 2024, the Examining Authority submitted a Report and Recommendation in respect of its findings and conclusions on the above application to the Secretary of State on 8 August 2024. In accordance with section 107 of the Planning Act 2008, the Secretary of State has three months to determine the application.
- 2. There are matters on which the Secretary of State would be grateful if the Applicant could provide information as appropriate.
- 3. Without prejudice to the Secretary of State's final decision, the Applicant is requested to provide further clarification regarding the option to remove solar panels from Stow Park Deer Park ("the Stow Park Alteration").

Best and Most Versatile ("BMV") Land

4. The Applicant is requested to provide clarification relating to the figures given in Environmental Statement ("ES") Chapter 4, ES Chapter 5, ES Chapter 19 and ES Appendix 19.1 for the Agricultural Land Classification ("ALC") proportions. The Secretary of State has been unable to reconcile these figures to determine the proportions of land in West Burton 1, West Burton 2 and West Burton 3 by grade. The Applicant is requested to provide further clarification in a table as to the proportions by ALC grades 1, 2, 3a and 3b for West Burton 1, West Burton 2 and West Burton 3 and for the Stow Park Alteration.

Biodiversity Net Gain ("BNG")

5. The Applicant is requested to provide clarification relating to the figures given in the ES Appendix 9.12 Biodiversity Net Gain Report Rev A ("BNG Report Rev A"). The Secretary of State notes discrepancies in the percentage of BNG for river units, between the figures in the Executive Summary, those in Figure 3, and those noted in paragraph 6.1.5 of BNG Report Rev A.
