Back months ago, I remember emailing about the verges which were left in a mess. Vus tidied the area in front of the substation, the even graded it and laid topsoil and National grid dug it up 2 days later.

Well, this Saturday I believe the quarry road was surfaced. The company doing the work is part of Aggregate industries who are the quarry tenants. The soak away is not working it has just pushed the water into my garden at a different place.. Also, in front of the bungalow there is standing water. My lawn in 3 inches under water and I believe this has stop the water reaching the bungalow.

You're going to say it's been raining like the man from Bassetlaw Planning committee. I understand that but when something has been done to stop something that has been happening for years doesn't work then what was the point in doing it.

Well, I've ranted long enough but I will be back.

My new year has not been a good one so far with the projects and it only day 6. I'm sure it will get better and someone I email will answer me and have some answers to the problems and the destruction of the land around our villages.
