Notice is hereby given that Cottam Solar Project Limited (Company registration number 12711231) of Unit 20.2 Coda Studios, 189 Munster Road, London, England SW6 6AW ("the Applicant"), proposes to apply to the Secretary of State for Business, Energy and Industrial Strategy under section 37 of the Planning Act 2008 for a Development Consent Order for the Cottam Solar Project (the
- 2. The Cottam Solar Project will consist of:
- (a) Cottam 1, 2 and 3: three solar array sites with one site located in the area around Coates (Cottam 1), one site located east of the village of Corringham (Cottam 2) and one site located to the north-east and south-east of the village of Blyton and east of Pilham (Cottam 3), in the district of West Lindsey, Lincolnshire including solar panels, conversion units, inverters, and 132kV substations in Cottam 2 and 3 and a 400kV substation in Cottam 1.
- (b) An energy storage system located within Cottam 1.
- (c) Underground electricity cables connecting Cottam 1 solar array sites, substations and the energy storage system to the National Grid substation at Cottam Power Station: and
- (d) Associated infrastructure, mitigation and enhancement measures, and other ancillary works, for example, fencing, security, local grid connections, temporary access roads, permanent means of access, highway works, temporary works compounds and
- 3. The majority of Cottam Solar Project is located within the administrative boundary of West Lindsey District Council and Lincolnshire County Council with the grid connection infrastructure also located within the administrative boundary of Bassetlaw District Council and Nottinghamshire County Council
- 4. The proposed DCO will, among other things, authorise:
- Construction, operation, maintenance and decommissioning of solar PV electricity generating stations and associated development including grid connection and energy storage facility;
- Compulsory acquisition of land, including interests in land, rights over land and imposition of restrictions, powers to override, suspend or extinguish rights over land and powers for the temporary use of land;
- The application, modification and/or disapplication of legislation including legislation relating to compulsory purchase and landlord and tenant; and
- Such ancillary, incidental and consequential provisions, licenses, property rights, permits and consents as are necessary and/or convenient
- 5. Cottam Solar Project is an Environmental Impact Assessment (EIA) development for the purposes of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017.

This means that the proposed works involved constitute development for which an EIA is required and the proposed application for a DCO will therefore be accompanied by an Environmental Statement. The Environmental Statement will provide a detailed description of the Cottam Solar Project and its likely significant environmental impacts. Information compiled so far about the Cottam Solar Project's likely significant environmental effects is set out for consultation in a Preliminary Environmental Information Report (the PEIR') and summarised in a non-technical summary.



Hickman races to win double on Isle of Man

LOUTH-BASED Peter Hickman and his FHO Racing team claimed their second win of the 2022 Isle of Man TT Races with another start to finish victory, this time in the RL360 Superstock race.

Riding the BMW M1000RR, Hickman put in another imperious performance around the 37.73-mile Mountain Course to take his seventh TT victory, coming home 12.7s clear of local rider Conor Cummins.

Pushed back to a 6.35pm start and cut from four laps to three, with a mandatory pit stop to be taken after the first lap, the 35-yea- old grabbed the lead from the outset with an opening lap of 132.217mph, giving him a more than healthy 12.7s lead over Cummins' team-mate Davey Todd.

An excellent pit stop, where just fuel was taken, enabled Hickman to extend his lead to 15.9s at the end of the second lap. Although a 133mph+ lap from Cummins reduced the gap slightly on the third and final lap, Hickman, with his quickest lap of the race, 132.274mph, took the chequered flag to make it win number two.

Hickman said: "The bike worked faultlessly again and I felt really comfortable. The bike's working so well and it's making my life so much easier. All the boys are fast and they're all keeping me honest and I'm working my heart out to get the bike round as fast as possible.

Hickman had got race week underway with a stunning victory in the RST Superbike race.

He was never headed during the six laps and, aided by the fastest lap of the race at 133.461mph, won by almost 40 seconds to take his sixth TT victory.

Halfway round the first lap at Ballaugh, Hickman was already three seconds clear of second placed Dean Harrison.

With a first lap speed of 133.18mph, he extended his advantage to 9.3s. Second time around, he upped his pace to 133,461mph which almost doubled his lead.

The Louth-based rider's lead was 36s when he came into the pits at the end of the fourth lap and, with his second pit stop as good as the first. he controlled the race in its final third to bring the bike home first




